Dea	erdose & Poisoning ath Data Coroner Data ODMAP	 Jennifer reported on the Stanislaus County Overdose and Poisoning Deaths Coroner Preliminary Death Data on closed cases as of 3/7/25 for the year 2024. Jennifer stated we will have the final data once all cases are closed. There has been a total of 172 drug-related deaths in 2024, 101 were fentanyl related, 12 other Opioids, 45 Meth, 8 were alcohol related deaths, 3 were cocaine related deaths and 3 were other. Jennifer also shared 2025 data for closed cases as of 3/7/25. There has been a total of 11 drug-related deaths in 2025, 5 were fentanyl related, no deaths for other Opioids, 2 Meth, 1 alcohol related death, none were cocaine related and 3 were other. Jennifer shared 2025 data from ODMAP by month and day of the week for January, February, and March 2025. 	
	sentation: Aegis atment Centers	 Rebecca Mitchell and Moises Alcantara from Aegis Treatment Center provided a presentation on Medication Assisted Treatment. They are a part of a nationwide parent company - Pinnacle Treatment. Pinnacle offers: MAT, Residential, PHP/IOP, Withdrawal Management and Transitional Housing. They have 48 locations in California. They went over Aegis dosing protocols, census and demographics, outcomes and success and the SOR IV Grant which aims to address the opioid and stimulant use disorder crises by improving access to treatment, reducing unmet treatment needs, and reducing opioid and stimulant-related overdose deaths through the provision of prevention, treatment, harm reduction, and recovery service activities. They shared long acting injectables will be available soon. Tabitha requested the Stanislaus County Substance Use Disorder Education and Prevention Services Survey from March 2020 be shared at the next Coalition meeting. The survey involves demographics, substance use history, Opiate Addiction and Fentanyl Specific questions. Coalition Members will also review the questions on the survey and make changes as needed.

Jennifer shared she is waiting to hear back from MJC regarding reserving the location. Registration will open on National Fentanyl Awareness Day on April 29th.
