CIVIL CODE SECTION 3333.2—What is new?

Increased cap for
non-economic
damages

- Non-death cases
- Death cases

Separate caps for
three categories
of defendants

- “Health care provider”
- “Health care institution”
- “Unaffiliated” health care provider or institution

Increased Cap Amounts

Personal Injury
Claims

\$430,000

Wrongful Death
Claims

\$600,000

“Affiliated” v. “Unaffiliated”

- When one corporation is directly/indirectly through one or more intermediaries, controls, is controlled by or under common control with another corporation
- Employed by another
- Performing under a contract with another
- Owner of another
- Joint Venture with another
- In the same “health system”

Separate Cap Amounts

Health Care Providers

- Single cap for all providers
- Excludes unaffiliated Health Care Providers

Health Care Institutions

- Single cap for all institutions
- Excludes unaffiliated Health Care Institutions

Separate Cap Amounts

Unaffiliated Health Care Provider or Health Care Institution

- Unaffiliated with another HCP or HCI
- Liability is based on separate and independent acts of negligence, and
- Negligence occurred at an unaffiliated HCI, or
- Negligence occurred in relation to a medical transport

General Limits On The Number Of Caps



Three potential caps

No HCP or HC institution defendant shall be liable for non-economic damages in more than one of the three categories

The caps apply regardless of the number of defendant HCP and HC institutions or number of causes of action

When do the new damages caps apply?

The new caps apply to actions filed in 2023

The amount of the cap is based on the date of settlement/verdict

- “...at the time of judgment, arbitration award, or settlement shall apply to an action . . .” CCP 3333.2(g)

Increasing non-economic damages caps

First 10 years, starting 1/1/24:

- Non-death actions increase \$40,000/yr.
- Death action increase \$50,000/yr.

Starting 1/1/34:

- Caps are adjusted for inflation annually by 2%



Hospital and Nurses

Hospital and nurses are sued and alleged to be negligent

Case is set for trial in January 2026

What is the potential exposure to non-economic damages?

Hospital System, Hospital, Treating Doctor, and Nurse

Hospital System, Hospital, treating doctor and nurse are sued and alleged to be negligent

Patient died and wrongful death suit is filed

What is the potential exposure to non-economic damages?

Hospital, Treating Doctor, Doctor's Group, and Nurse

Hospital, treating doctor, doctor's group and nurse are sued and alleged to be negligent

Patient lived, filed suit after 1/1/23, then died during the litigation...

What is the potential exposure to non-economic damages?

Hospital and Treating Doctor

Hospital and treating doctor are sued for negligence and loss of consortium

Patient filed suit after 1/1/23...

What is the potential exposure to non-economic damages?

Hospital, Treating Doctor, Nurse, and Ambulance Company

Hospital, treating doctor, nurse, and ambulance company are sued and alleged to be negligent

Patient's heirs brought a wrongful death lawsuit...

What is the potential exposure to non-economic damages?

Hospital and ER Doctor



ER doctor is sued
for negligence,
Hospital is sued for
ostensible agency



Plaintiffs claim there are
two separate
recoverable limits...



How many limits
apply?

Jury Verdict

Case is tried against hospital, doctor, nurse, and ambulance company

What questions does the jury need to decide?

Does the jury decide an allocation of fault?

Jury Verdict

Jury finds hospital,
nurse, and doctor
liable for \$1.5M in
wrongful death
lawsuit

40% to hospital
10% to nurse
50% to doctor
