Code of Conduct

Core Values, Braver and Safer Spaces

Bi+ Equal is committed to creating a braver, safer, inclusive, and respectful environment. Everyone is welcome – regardless of gender identity or expression, pronouns, age, religion, ethnicity, sexual orientation, visible or invisible disabilities, neurodiversity and neurodivergence, mental and physical health, appearance, relationship structures, or other characteristics and their intersections.

We ask all participants to be mindful of each other, respect personal boundaries, and actively contribute to an atmosphere of openness, curiosity, and care. Our aim is to create safer spaces providing everyone with security and comfort, cultivating an environment where people can freely express themselves without fearing judgment, and simultaneously braver spaces to push boundaries by encouraging uncomfortable yet necessary conversations.

Participation in the Bi+ Equal Conference implies agreement with the following Code of Conduct.

- 1. I agree to contribute to creating a braver and safer, inclusive and open-minded environment by treating all participants with respect.
- 2. I agree that discrimination, xenophobia or harassment of any kind will not be tolerated at the conference, and such behaviours will have appropriate consequences.
- 3. I agree to listen to and respectfully engage with perspectives that may differ from my own.
- 4. I agree to commit to the values of Bi+ Equal, ensuring the conference remains free of any discriminatory practices, including but not limited to sexism, racism, homophobia, biphobia, transphobia, agism, ableism and classism.
- 5. I agree to respect confidentiality when people share personal stories or experiences, and not take and share photos without permission.

This Code of Conduct will apply to all events hosted by or in collaboration with Bi+ Equal during the Conference and Founding General Meeting period in October in Vilnius, Lithuania.
