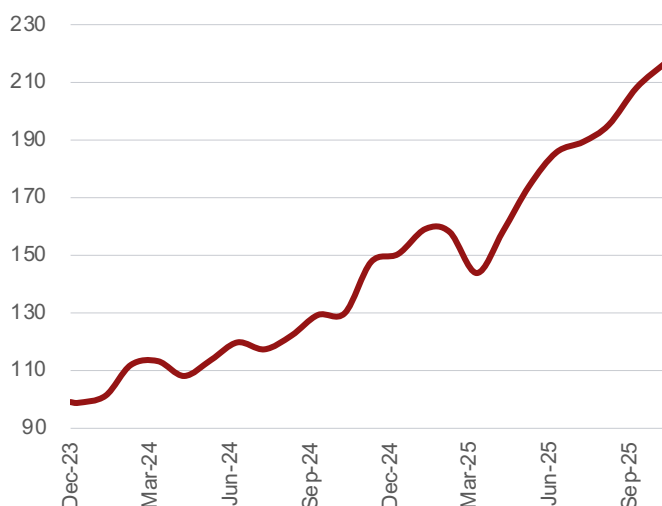
## Portfolio strategy

The Cape Equity Collections Portfolio offers a diversified investment portfolio of 15-30 large cap names, focusing on developed markets.

Employing a bottom-up approach, the AMC seeks to identify companies with market-leading positions and strong moats characterized by high barriers to entry, pricing power, unmatched offerings, and product integration, among others, in their respective fields. The strategy is designed for a long-term investment horizon (+10 years) and follows a “buy and hold” philosophy with very low turnover. This approach is based on the belief that the value of these companies will continue to compound over time due to their consistent innovation and adaptability to change.

The AMC aims to provide a high-risk/high-growth return profile, complementing a client's traditional equity exposure.

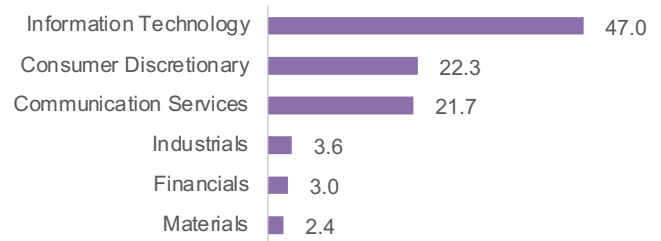

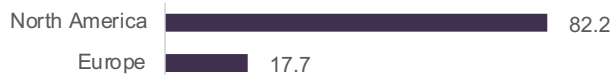
