Portfolio strategy

The Cape European Infrastructure Reset Portfolio offers a diversified investment portfolio of companies exposed to a “European Infrastructure Reset” theme.

The investment strategy is anchored on three core pillars:

- 1) Infrastructure Modernization: Anticipating increased spending as Europe transitions from an analogue to a digital economy.
- 2) Ukraine Reconstruction: As the market forecasts peace between Russia and Ukraine, significant reconstruction efforts are expected, creating imbalances and opportunities in various infrastructure sub-sectors.
- 3) Valuation Opportunity: European equities present a compelling case, with their valuation gap relative to US equities at a 20-year high. This theme is played via a basket of names across different industries such as construction & buildings, transport & logistics, electrification, infrastructure, and banks, with a primary focus on developed markets.

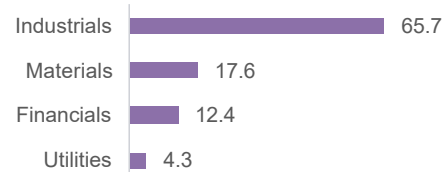
