Reimbursement

Gentle Reminders

1. Attendance and sign in and out sheets need to be submitted on the same date, by end of third business day.
2. Excuse notes for absences need to be attached when they are entering attendance, under attachments, not SharePoint or document library. We do not have the capability to edit and add it, providers need to be adding it themselves.
3. Sign in and out documents need to be uploaded in document library under the (A1-SR SIGN IN/OUT, A1-VPK SIGN IN/OUT, A1VPK Short/ Long Form), not in random folders
4. Providers, please verify that documents you are uploading are legible especially if they are handwritten, if its not legible and we have to struggle to make out what is written, then that document is not acceptable.
5. When providers are submitting daily and weekly sign in and out sheets it would be most helpful if they upload the sheets in order, if not reimbursement spends additional time trying to sift through to make sure they find all the students and signatures.
6. Please terminate children prior to submitting your attendance.

2025-2026 VPK Enrollment Certificates

1. **VPK certificates** - applications are reviewed in the date order that they are received. Parents can login to their family accounts to see the status (submitted, approved or rejected). Calling the coalition or walking into the coalition delays processing time as staff are already trying to assist households without computer access, who have language barriers, or need notarization of paperwork. We promise that we are working our hardest to ensure that the VPK applications are processed as quickly as possible, but it is not an automated system and does require staff processing.

2. **School Readiness certificates** - must be accepted by the provider in a timely manner. SR certificates time out if they are not accepted in the provider portal and that leads to the children "disappearing" from your attendance rosters. In those situations we have to cancel the enrollment request and resend it to you.

3. You should be checking your attendance rosters regularly to request corrections. You should not be submitting attendance corrections for more than the prior 60 day period.

DEL has changed the reporting process to 4-cycles.

You will now receive CLASS notes individually for each cycle. This will give you more details on your composite score. We are currently working on a transition plan. We should start using the new format in October, to be 100% deployed by January 1, 2026. Children's Forum is following this same plan.

PreK CLASS Assessment will be updating to PreK CLASS 2nd Edition 7/1/26.







ASQ Child Screenings

ASQ Screenings are required for School Readiness children. Only the parents can opt out of a screening. There are 2 different screening that are required.

- ASQ-3: This is the screening that has been conducted with SR children for many years. It covers Communication, Large Motor and Small Motor skills, Problem Solving, and Personal-Social skills.
- ASQ:SE-2: This is a newer screening that is also required for SR children. This is not new, we have been doing this screening for a few years now. Some providers are having trouble with this screening. It covers more in-depth, Social-Emotional Child Development. Many of the questions look like something only the parent would know.

Work together with the parents on these screenings if you are unsure of the answers. Build that partnership with the families. There are only 45 days to complete the screenings so if you answer the questions you can first, you have time to ask the parents to help with the few that remain.

Be sure you share the ASQ results with the parents, even if the parent did the screening. They only see the results when you show them.

If the child on your Screening Report is no longer attending or never attended, let Ivonne know right away. Don't wait until the screening is late, you will get a Non-Compliance.




