
I'm hopeful that you've logged in and checked out the new web portal! As we continue through the stages of fully implementing Milk Moovement you'll see increased amounts of data and information available to you online! There are new features of the web experience that we would encourage you to start taking advantage of like the sub-user accounts and notifications. If you don't have access to the internet, there are ways we can leverage notifications to get you more timely information too. Feel free to reach out to the Membership Office for help.





6% Farms with Notifications Set Up

Notifications can be used to get an automated message when you have a lab result that crosses a custom threshold. For example, if your SCC typically averages 140, and you want to make sure that you stay below the 150 threshold to qualify for that tier of quality premium, you could set up a notification that would inform you when a lab result came in at 190 for example. These are completely custom, if your level of concern is 100, that's possible too! These notifications can be sent to you as a text message, email, or a phone call.



To set up notifications:

Choose the menu option called "Settings" and then choose "Notification Settings". If you wa

"Notification Settings". If you want to receive the notification by text, click the blue plus sign, add and verify your cell phone number (be sure to include

a 1 & the area code). Once that's complete, work your way through each of the custom drop-down boxes to make a notification that's important to you. Once finished with that part, be sure to check mark the delivery method and save the alert!



One thing to note – if a new lab report is received overnight that meets that threshold, you'll receive a text in live time.

Dairy Dynamics in 2025: From Prices to Production, What Trends are Shaping the Industry in 2025? by: Jodi Smith Krzysiak, VP Economist & Industry Affairs and Allee Coombe, Dairy Market & Policy Analyst

Cheese prices have remained stronger than expected this winter, with CME spot block prices reaching \$1.92/lb on January 13th. Block prices have averaged \$1.90/ lb and Barrel prices have averaged \$1.85/lb so far in 2025. The increased spot prices have resulted in a higher Class III futures market at press time. These prices are reflective of the tighter supply coming out of the holiday season and constrained production. Total cheese output fell 6.1% and nonfat dry milk output fell 4.2% between October and December 2024. Anecdotal reports suggest that irregular manufacturing and inclement weather played a role in the supply shortage as well. Demand fluctuated, as there was a 2.5% increase in cheese exports year-over-year, but a 1.9 % decline month-over-month, with 87.1 million pounds being exported in November. We can expect cheese prices to move lower following the Superbowl demand period and this trend may continue as new capacity is slated to come on line in April.

While fluctuations in the cheese market keep us alert, butter and

nonfat dry milk have held steady since the start of the new year. At press time, CME spot butter prices have again eclipsed \$2.60/lb., a level last seen in mid-November. On the NDM side of the Class IV complex, prices have averaged around \$1.36/lb since November, compared to the GDT index for SMP at \$1.22/lb in the most recent auction. Class IV product prices at these levels have provided a more supportive financial environment for producers, especially in the Northeast.

Heading into 2025, there is anticipation of a slight decline in Class III and Class IV milk prices due to an increase in milk supply; however, a growing milk cow herd and higher yields per cow are welcome in the new year. This growth is likely in preparation of filling capacity expansions in South Dakota, Wyoming, and New Mexico. Closer to home. Great Lakes Cheese and fairlife have been working on capacity expansions in New York. This is exciting news for the United States, especially the Northeast, where capacity issues have grown over the last twenty years.

The United States milk production declined 1% year-over-year from 2023 to 2024 due to the HPAI breakout in California. While discouraging, California is considered an outlier in comparison with the remainder of the U.S as we saw an increase in milk production (0.8% YOY) and milk cow numbers throughout the rest of the country. Year-over-year, milk cows were up 40,000 head in 2024, and this number is expected to continue growing in 2025.

Domestic dairy consumption is keeping up with the trending increase in production as well.

Consumption of dairy achieved its highest level since 1959, reaching 661 pounds per capita in 2023.

The dairy industry is set to experience growth and change in 2025 with expanding production capacity, increased supply, and evolving market dynamics. As California rebounds from the HPAI breakout, the U.S. is anticipating continued growth in milk production and number of milk cows.
