



Executive Summary

VCIA conducted six programs in Q1, including major events for our advocacy mission: annual Legislative Day (January) and Hill Day (March). Close to 400 registrants participated in the quarter’s events and the inaugural programs “In with VCIA” and “Advocacy in Action” were well received. The VCIA Chicago Chapter hosted its first Happy Hour Meetup and promotions began for the Philadelphia Chapter Launch, on April 15th.

VCIA remains focused on fulfilling its strategic mission and executing new initiatives that were developed from member feedback during the strategic listening tour. In Q2, VCIA shifts focus to the annual conference — America’s largest captive insurance gathering — with registration opening in late April.

Q1 2026 VCIA Activity

- ★ January Board Meeting in Montpelier ahead of Legislative Day, which garnered the highest turnout of members and lawmakers since the pandemic.
- ★ VCIA leadership **testified** in front of Vermont legislative committees in support of the 2026 captive bill.
- ★ Christine Brown was **officially named** Deputy Commissioner. She and Vermont regulatory leadership, coming off a historic year of **licensing 51 captives in 2025**, presented the Q1 webinar which drew nearly 200 participants.
- ★ 175 individuals participate in the soft launch of the new online community forum, which will go live to all membership in Q2.
- ★ **2025 Impact Report published**, showcasing a 17% increase in membership from 2024.
- ★ VCIA President Ian Davis named to **Captive Review’s 2026 40 under 40**.
