

THE CHALLENGE

Tight Deadline, Missing Evidence, and Mounting Legal Pressure

A national, full-service law firm representing a corporate client in a breach of Joint Venture Agreement matter faced mounting pressure as a critical hearing approached. Central to the dispute was a multi-million-dollar note believed to define key financial terms of the partnership.
