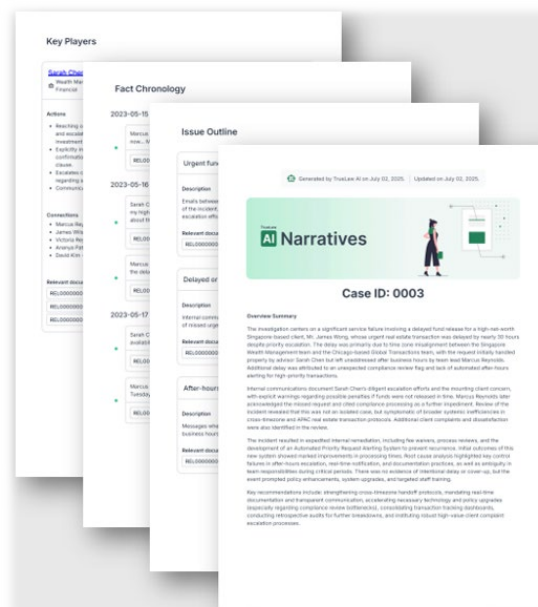

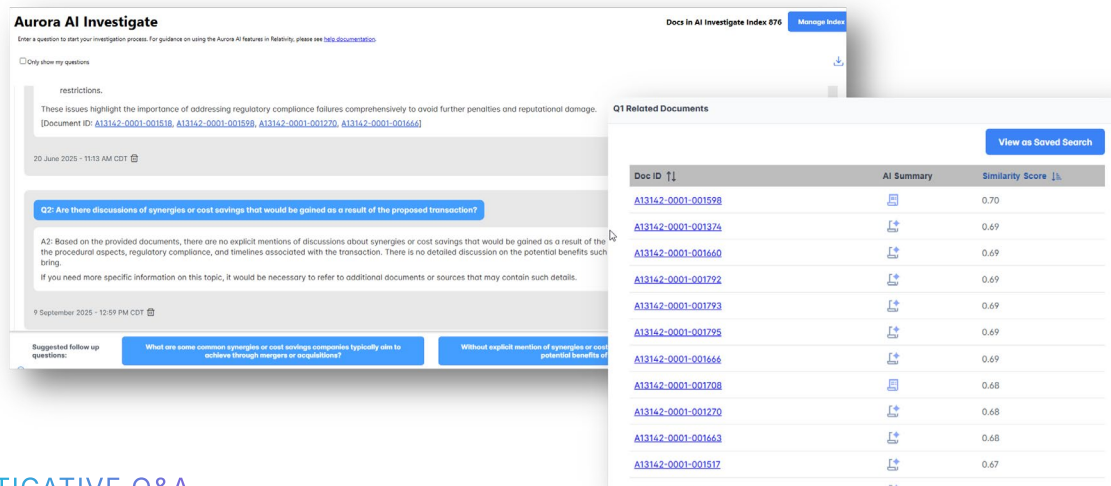
Component Overview

NARRATIVE GENERATION

Our process begins with the use of Consilio's AI-powered narrative generation tool, AI Narratives, to surface the key facts, themes, and timelines within the document set. Guided by starter prompts and refined in collaboration with subject matter experts, each narrative reflects both the technology's analytical precision and the team's contextual understanding of the matter.

The result is a clear, source-linked overview that helps counsel quickly understand the story behind the data and focus preparation where it matters most. Each report is tailored with client-specific details such as case name, report title, and date. As part of the engagement, counsel also gains ongoing access to the narrative within the workspace to support continued strategy development and collaboration.

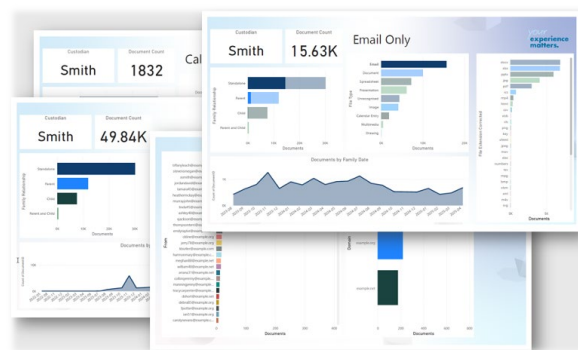

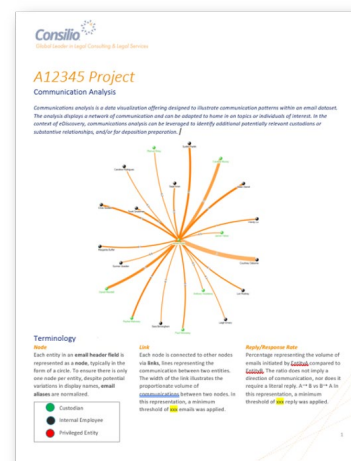
Consilio's AI & Analytics Team uses our proprietary chat-based tool, AI Investigate, to uncover key documents and explore issues identified during narrative development. Using natural language queries, counsel can ask targeted questions and receive clear, context-aware responses grounded in the actual case data. Each response cites the specific documents that informed it, enabling fast validation and follow-up.

AI Investigate also identifies and tags the documents most relevant to each query, making them accessible in the workspace for efficient review and deeper exploration. Powered by Retrieval Augmented Generation (RAG), the tool goes beyond traditional conceptual analytics by connecting questions to the most meaningful content within the data, revealing patterns and insights that strengthen strategy and improve deposition preparation.



POPULATION OVERVIEW

Through a combination of document metadata analysis and expert review, Consilio's AI & Analytics Team delivers a clear overview of the data linked to each deponent. This includes insight into data volume, document types, and communication patterns that help counsel understand the deponent's role, relationships, and potential relevance to key case themes.



COMMUNICATION ANALYSIS

This analysis helps counsel understand the context in which the deponent operated, identify additional relevant custodians, and uncover new lines of inquiry that can inform deposition strategy.
