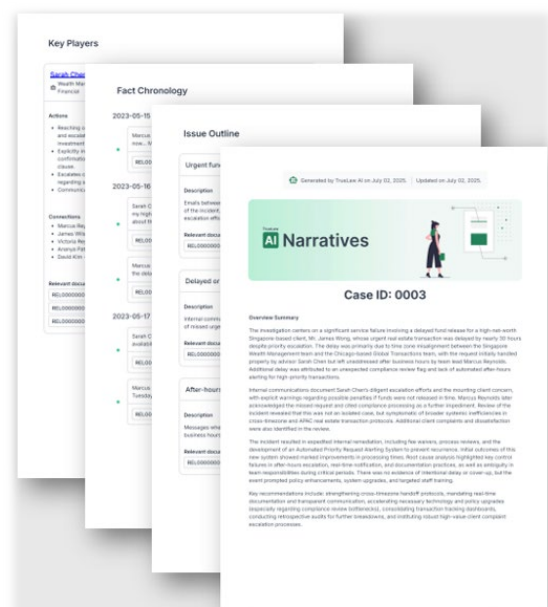

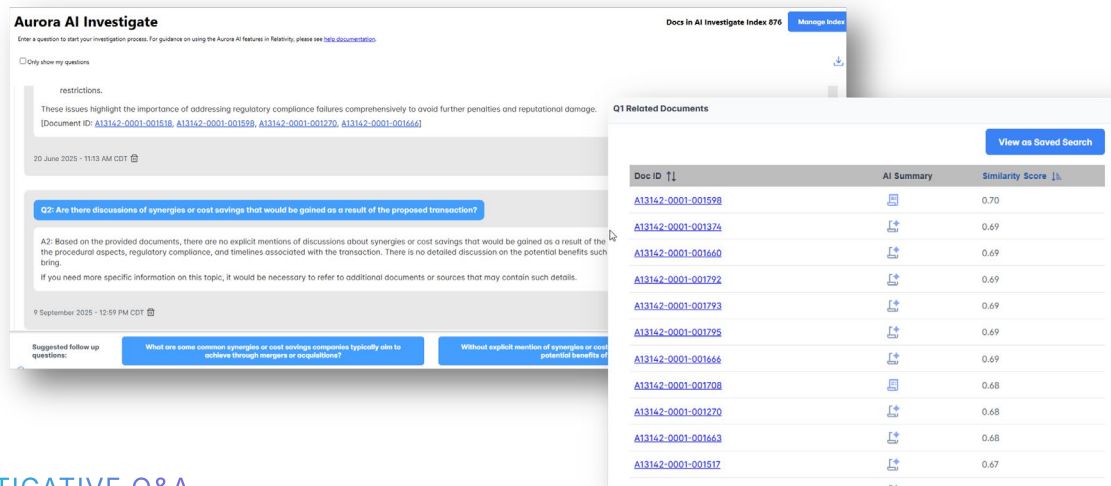
## Component Overview

### NARRATIVE GENERATION

Consilio's AI & Analytics Team uses AI-powered narrative analysis, **TrueLaw AI Narratives**, to synthesize large incoming productions into a clear, structured summary of key facts and issues. This narrative provides an early, high-level understanding of what the production contains, highlighting themes, timelines, and individuals that may be relevant to the matter.

The narrative is developed through an iterative process that combines AI-generated insight with subject matter expert input. As findings emerge, the team refines the analysis to ensure accuracy, relevance, and alignment with litigation priorities. Each insight is supported by linked source documents, allowing counsel to quickly validate conclusions and dig deeper where needed. The result is a concise, data-backed narrative that helps teams orient themselves faster and focus on what matters most.

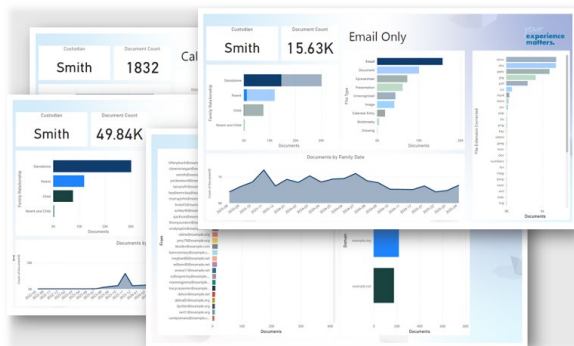




## INVESTIGATIVE Q&A

Building on the narrative analysis, Consilio's AI & Analytics Team uses **Aurora AI Investigate** to explore specific issues and questions within the incoming production. Through targeted, natural language queries, the team can quickly surface documents and context related to key facts, individuals, or events identified in the narrative.

Each response is grounded directly in the production data and includes citations to the underlying documents, making validation and follow-up straightforward. In addition to answering specific questions, this approach identifies clusters of related materials that may warrant deeper review. Investigative Q&A enables teams to move beyond high-level understanding and quickly test assumptions, refine strategy, and uncover evidence that might otherwise be missed.



## POPULATION OVERVIEW
