Our ELM-Powered AI Review Process

ELM-Powered AI Review follows a structured, collaborative workflow designed to ensure accuracy and client control at every stage. This iterative model ensures AI outputs are shaped by legal expertise and validated before being applied at scale.

- **Knowledge Sharing** - Consilio Prompt Engineers meet with client subject matter experts to understand the legal issues, objectives, and context that will guide analysis.
- **Sample Review** - A representative sample of documents is reviewed by the client SME to establish a ground truth. When issue prevalence is low, exemplars or synthetic documents may be incorporated to ensure prompts capture relevant content.
- **Initial Prompts** - Consilio's team drafts initial prompts tailored to the client's objectives, helping SMEs understand the prompting framework and how AI will interpret the issue.
- **Collaborative Analysis** - Prompt results are reviewed jointly with the client SME and refined through multiple iterations until performance meets agreed-upon standards.
- **Full Dataset Execution** - Once approved by the client, prompts are run across the full data set to generate final, validated results.
