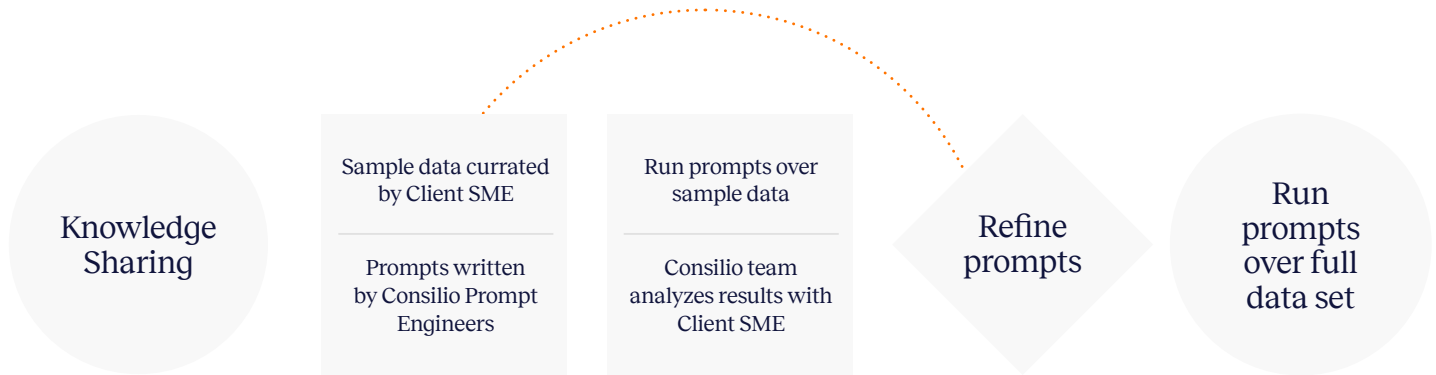

Our Guided AI Review Process

Guided AI Review is a collaborative process built around client input and expertise. Consilio's team works closely with client stakeholders to design, refine, and validate each stage of review, ensuring the AI aligns with case strategy and quality standards. Clients lead the direction, and Consilio provides the technology, expertise, and workflow execution that bring it to life.

- **Knowledge Sharing** - Consilio Prompt Engineers meet with client subject matter experts (SMEs) to understand the subject matter and the objectives. This initial step ensures that we are aligned with the stated goals and expectations.
- **Initial Prompts** - Consilio Prompt Engineers draft initial prompts to help client SMEs understand the prompting format. This collaborative effort ensures that the prompts are tailored to the client's specific needs.
- **Sample Review** - A sample, typically a 400-document random sample, is reviewed by the client SME to create a '*ground truth*'. If the issue has low prevalence, exemplars or synthetic documents may be included in the ground truth to ensure that prompts are capturing the relevant content.
- **Collaborative Analysis** - The results and prompts are shared with the client SME for collaborative analysis and refinement. This iterative process continues until the client is satisfied with the results and Consilio demonstrates effectiveness.
- **Full Dataset Execution** - Once the prompts are refined and approved by the client, they are run over the full dataset to achieve the final results.
