SHOCKING photos from the crime scene where Gypsy Rose Blanchard's mother Dee Dee was murdered have resurfaced on social media, sparking renewed interest among fans since her release from prison last year. The images show a crowded house with bags, garbage, and personal belongings scattered about, including a chair used by Gypsy in a bathroom and a gun she stored full of shells. Gypsy Rose Blanchard was released from prison on December 28, 2023 after serving eight years for the second-degree murder of her mother, Claudine "Dee Dee" Phipps. In 2015, Dee Dee was stabbed to death in their Springfield, Massachusetts home, having been stabbed in the back 17 times. It was later determined that Gypsy's mother suffered from Munchausen syndrome by proxy, which is also known as Factitious disorder Imposed on Another (FDIA). Experts claim that with her large following on social media platforms like Instagram and TikTok, Gypsy Rose could be earning millions this year. Gypsy Rose's contract was not renewed in 2019, according to a lawsuit, due to her "failure to secure any media projects or produce any marketable content." The lawsuit claims she continued to create and share content about herself on social media without consent. Gypsy Rose married Ryan Scott Anderson while serving her sentence but the relationship ended shortly after her release. She filed for divorce just three months later. After eight years in prison, Gypsy Rose was released on December 28, 2023. Since then, she has remained in the public eye, sharing a first selfie of freedom and appearing in interviews and reality TV shows. Gypsy Rose Blanchard's Crime Scene Photos Spark Outrage and Debate. If you haven't seen the disturbing photos circulating online, it's advised to skip this viral moment, as one user suggested: "Um. Next time imma mind my business," wrote @theashrb. Fans of true-crime stories have a higher tolerance for this type of content, saying they "weren't that bad." Gypsy Rose Blanchard a célébré 33 ans le 27 juin. Elle est actuellement en conflit juridique avec April Johns après que les Blanchards ont déposé une plainte contre elle pour diffamation, violation de contrat, enrichissement injuste, fausse lumière et fraude. Il est entendu qu'en 2017, Gypsy et ses parents ont signé un accord d'option de droits sur la vie avec Johns, qui est couramment utilisé pour accorder aux producteurs la possibilité de posséder les droits à l'histoire de quelqu'un pour être utilisés dans un documentaire. Gypsy a annoncé qu'elle allait devenir mère en janvier de l'année prochaine et, même si son divorce de son futur ex-mari Ryan Anderson n'a pas été finalisé, elle insiste sur le fait qu'elle et son petit ami actuel Ken Urker sont excités à l'idée de devenir parents. Elle a également déclaré qu'elle donnerait à son bébé "toutes les choses qu'elle voulait dans une mère". Des photos du lieu du crime de sa mère décédée, Claudine "Dee Dee" Blanchard, ont commencé à circuler sur les réseaux sociaux neuf ans après sa mort, coïncidant avec le 33e anniversaire de Gypsy Rose. Les images ont provoqué un tollé sur les réseaux sociaux, de nombreuses personnes se demandant pourquoi ces photos sont redevenues virales le jour de l'anniversaire de Gypsy. Il est intéressant de noter que les images provenaient d'un lien qui a été signalé comme provenant du Patreon détenu par une blogueuse qui était impliquée dans un conflit juridique avec Gypsy Rose Blanchard. April Johns, également connue sous le nom de Fancy Macelli, a pris la parole à propos du lien, clarifiant dans une vidéo TikTok que les photos n'étaient pas une "fuite" et qu'elles ont été disponibles au public depuis neuf ans. Elle a déclaré : "Le lien qui est sorti d'un lecteur est mes fichiers. Oui, il provient de mon Patreon. C'est gentil à tous tous de l'avoir pris et de l'avoir répandu partout." Ces documents, ces photos du lieu du crime, ont été publics pendant les neuf dernières années", a ajouté Johns. "Quiconque aurait pu déposer une demande de FOIA à tout moment et obtenir ces photos." Dans une autre vidéo TikTok, elle a clarifié qu'elles n'étaient pas responsables de la diffusion du lien le jour de l'anniversaire de Gypsy, disant : "Nous l'avons eu depuis très longtemps. Il a été partout sur Facebook, il a été partout sur Reddit pendant des années et des années." Gypsy Rose Blanchard et Johns ont une histoire, car le duo a été impliqué dans un conflit juridique après que leur partenariat médiatique ait échoué. L'ancienne détenu, ainsi que son père Rod, sa belle-mère Kristy et sa demi-sœur Mia, ont déposé une plainte contre Johns, alléguant la diffamation, la fraude, la violation de contrat, l'enrichissement injuste et la fausse lumière. Selon les documents judiciaires, Gypsy a également intenté une action en justice contre Johns pour avoir violé son accord de droits sur la vie. Blanchard family and Johns had initially collaborated on media projects but eventually parted ways due to lack of progress from Johns, who portrayed herself as an experienced producer. The Life Rights Option Agreement granted access to evidence from the murder case but produced no marketable content. The relationship further deteriorated after Johns allegedly became confrontational over Gypsy's relationship with her fiancé Ken. After a 2019 split, things took a turn for the worse between both parties, with Johns making derogatory comments about Gypsy in a YouTube video and creating profane content across various platforms. However, the lawsuit was dismissed due to improper venue.
