Special Assistance in New Emigrant Law

Since emigrants coming here are entitled to special low emigrant fares from Italy to New York throughout the year, on a time payment plan, as well as a 66-pound free baggage allowance, Alitalia anticipates substantial westbound traffic following the passage of the bill. The line is currently preparing an attractive Emigrant Fare Folder for all its district offices listing these special fares and offering other useful information for emigrants. In addition, Alitalia's district offices will issue sales letters and bulletins explaining the new liberal immigration policy.

Relatives and friends are being urged to fly to Italy to meet and return with the immigrating person, and, at the same time enjoy a visit to Italy. In the case of an infant or child emigrant, Alitalia will make arrangements for an extra hostess to accompany the youngster.

The bill also approves new immigrant quotas from Portugal, Greece, Poland and Yugoslavia.

Bureau for Legal and Administrative Aid to Italian Labour Abroad (A.G.A.L.I.E.)

Via Oslavin 14 - Roma (Italia)

The « Ufficio per l'Assistenza Giuridica e Amministrativa del Lavoro Italiano all'Estero (A.G.A.L.I.E.) », which has been founded in Rome, aims at solving the various juridical and administrative problems which, as the consequence of emigration and immigration, confront Italians residing abroad in their relations with their mother land and Italians at home in their relations with foreign countries, thus filling a gap the existence of which is felt by many in the field of the protection of workers and producers.

The Bureau will accept no responsibility until it has summarily examined the details of the case submitted. Therefore, the attached questionnaire must be duly filled out and sent in by the person requesting the services of the Bureau.

The reply from the Bureau will enable the applicant to know whether the matter can be dealt with and brought to a favourable conclusion, and under what conditions.

The following is a list, though of necessity not a complete one, of matters within the competence of the Bureau:

Adoptions - Affiliations - Family Councils - Protection and welfare of minors - Alimonies for dependents - Recognition and non-recognition of paternity - Separations.

Successions by law or will, in Italy and abroad.

Acquisition, loss and re-acquisition of citizenship - Enrolment on and cancellation from civil, military and electoral registers - Transcription and modification of certificates - Establishment and relinquishment of domicile and residence - Residence permits - Declaration of missing persons - Reconstruction of Family Trees.

Tracing of properties - Sale, purchase and re-selling of real estate and administration of same - Registration and writing-off of mortgages - Appraisal and measuring of land - Boundary rights - Recognition of intellectual rights (trade marks, patents, copyrights, etc.).

Matters connected with State Offices - Fiscal, currency and customs questions - Import and Export Licences - War Damage - Pensions - Social Insurances.

Special and General Mandates - Legal Advisors in Court Cases - Rogatory letters - Recognition and execution of sentences - Legalization of documents.

Penal proceedings before ordinary and military courts - Extraditions, expulsions and deportation orders - Execution of penal sentences - Rehabilitation - Amnesty and pardon petitions - Damages - Recovery of credits - Commercial Disputes - Auditing - Paying up of Insurance Policies - Car Accident Liabilities.

LANZA REQUIEM RITES AT ROME

Temporary Burial in Verano Cemetery

ROME (UPI) — Tempestuous tenor Mario Lanza received his final tributes Saturday in a horse-drawn funeral procession that brought 5000 persons to watch on the street and 3000 mourners to his requiem services.

The procession tied up Rome traffic for half a mile.

Actor Van Johnson and band-leader Xavier Cugat were among the show business representatives who attended the funeral of the 38-year-old Philadelphia-born singer and actor.

The body was interred temporarily in Verano cemetery in Rome pending final decision on a permanent resting place. Lanza had once remarked that he would like to be buried next to the body of his hero, Enrico Caruso, in a cemetery at Naples.

CHILDREN GRAVE

Lanza's wife, dressed in a black-lined white coat and black hat and veil, had to be supported by friends. The four Lanza children were grave-faced during the Requiem Mass in the Church of the Immaculate Heart of Mary.

The Mass was sung by Father Paul Maloney of Rome's Santa Susanna church. Father Maloney is an old friend of the family. He had baptized the four Lanza children, Mark, Damon, Calleen and Elisa, in Los Angeles.

As the Italian-style funeral cortege wound through the streets from the Parioli suburb to the nearby church, thousands of Romans doffed their hats or reverently crossed themselves.

Police estimated 5000 people turned out in the streets.

The hearse was drawn by four jet-black horses, and was followed by cars carrying Lanza's wife, the former Betty Hicks, the children, and his parents who had flown from California last night. Other mourners joined the cortege.

TRAFFIC BLOCKED

The 20-car procession blocked traffic in all directions.

Lanza died Wednesday after pneumonia and a heart attack. Some reports said death was hastened by the fact that Lanza, who had a tendency to overweight, had gone on a series of "crash" diets.

Born Alfredo Cacoza—Lanza is his mother's maiden name—he had a glorious voice and modeled himself in the heroic mold of Caruso. His fight with Hollywood movie producers and directors were legendary.

But there was no mention of his career at the funeral. Father Maloney's eulogy was brief and confined to words of comfort for the family.

It was not known whether Mrs. Lanza and the children would return to the United States.

Because of her love for the printed word, brown-eyed Linda worked diligently as copy editor of her school newspaper and advertising manager of the yearbook.

Elected to Quill and Scroll and the National Honor Society, she was further honored by her schoolmates and civic officials by being chosen president of the student council, ideal girl and princess schoolspirit, fourth place winner in the Optimists' club Youth of the Year contest and recipient of the coveted American Legion award.

Linda's father had to build a case to hold her 52 trophies, pins and letters. The black-haired honor student, who is now taking pre-law at Loyola university, attributes her accomplishments to a deep faith in God and the support of her parents.

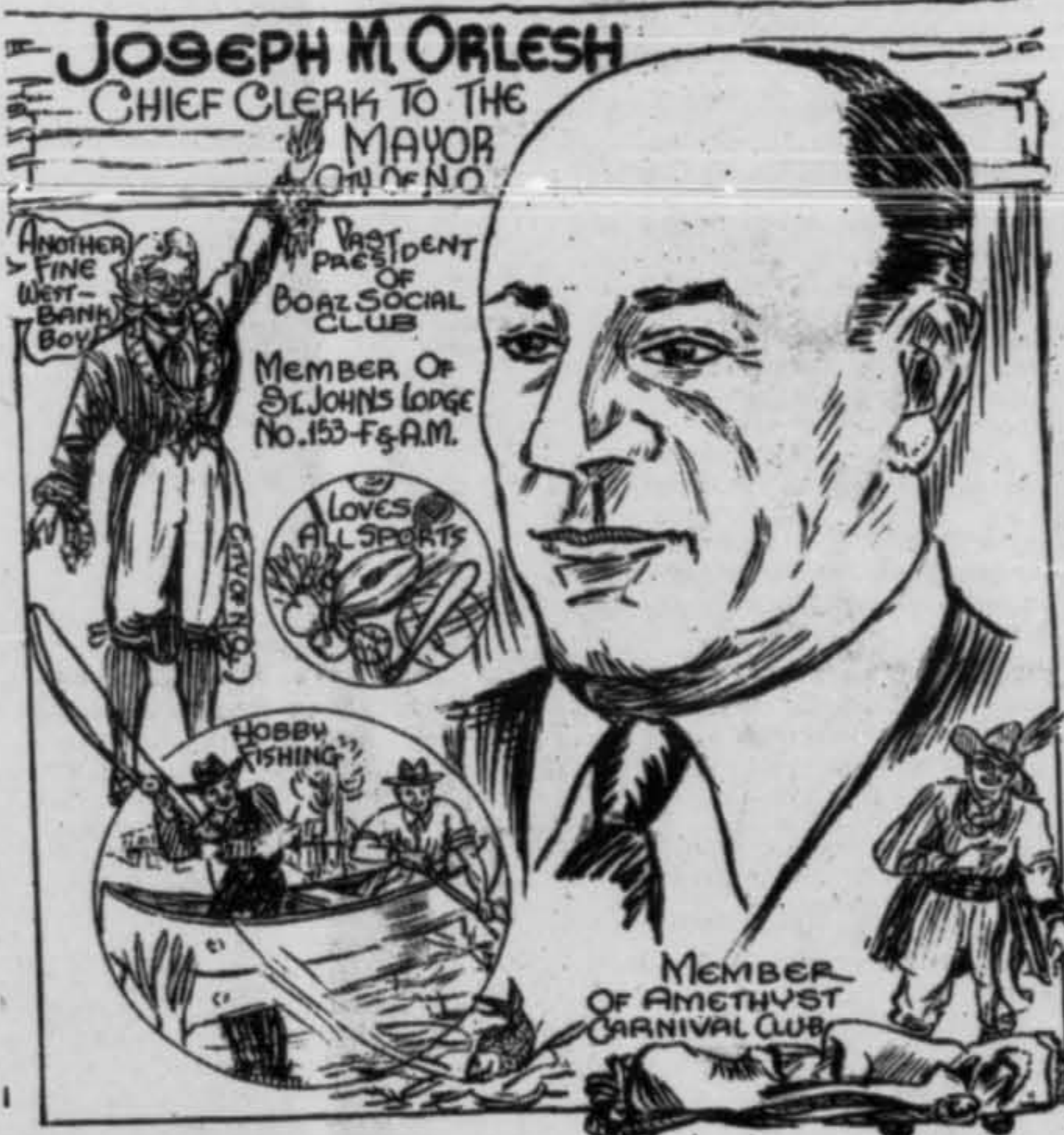

Uno Spettacolo "Suono E Luci" A Pompei Nel 1960

NAPOLI, (Agit) — Il grande successo ottenuto dagli spettacoli "Sono et Lumiere" nei castelli della Lupa, prima, e a Frascati poi, hanno indotto il Presidente dell'Ente Provinciale per il Turismo di Napoli, Renato Barondson, a gettare le basi per organizzare per il 1960 la stessa formula di spettacoli a Pompei. La formula originale di detti spettacoli consiste nella rianimazione di vecchie e storiche dimore, a mezzo di effetti di luci variabili sintonizzati alla suggestione evocativa creata dalla simultanea diffusione radiofonica di commenti e recitativi appositamente registrati e riguardanti episodi di costume e avvenimenti storici che hanno avuto luogo negli stessi ambienti. Ora se si pensa alla suggestiva vastità della dissepolta città di Pompei ci si può render conto che uno spettacolo suono e luci non poteva trovare una più adatta sede di applicazione. La suggestione che si prova attraversando le strade e i ruderi dell'antica Pompei, nota l'Agit, è così profonda che i visitatori si meravigliano di non trovare animazione nelle case o ungari di non incontrare gli abitanti della città vittima della furia del vicino Vesuvio. Questo significa che lo spettacolo "Sono et Lumiere" di Pompei deve essere particolarmente curato e realizzato con la massima perfezione tecnica.

Edeappunto lo studio già iniziato per realizzare la manifestazione s'è rivelato tutt'altro che facile per via proprio della vastità delle spettacolari risorse di Pompei. BIOGRAPHY OF GEORGE J. GULOTTA

Among the many prominent professional men of Italian parentage in the city of New Orleans is George J. Gulotta, who has been engaged in the practice of law for more than forty years.

He served as an Assistant District Attorney for the Parish of Orleans for twenty two years, and under the administration of Hon. James P. O'Connor and Hon. Severn T. Darden, Mr. Gulotta occupied the important position of First Assistant District Attorney.

He was first appointed Assistant District Attorney by Hon. Eugene Stanley in 1927, and because of his qualifications as a prosecutor and devotion to the duties of his office, he was retained by almost all District Attorneys that followed Mr. Stanley.

As a trial assistant and as First Assistant District Attorney he tried, or actively assisted, in the successful prosecution of many of the most important cases tried in our Criminal Courts.

Mr. Gulotta also served as an Assistant United States Attorney during the administration of Hon. Herbert W. Christenberry as United States Attorney, and now serving as United States District Court Judge.

From 1924 to 1927 Mr. Gulotta served as a member of the State House of Representatives from the Fifth Ward of this city, from which position he resigned to become an Assistant District Attorney.

In 1948 Mr. Gulotta was again elected to the Legislature from the Fifth Ward, and upon the termination of the Legislative term in 1952 he was again appointed to the post of First Assistant District Attorney by Mr. Darden.

As a defense attorney, Mr. Gulotta is best known and remembered as Chief Counsel in the celebrated case of the Six Italians, tried in the Parish of Tangipahoa. The case was tried twice. After conviction the first time, Mr. Gulotta successfully appealed the case to the Supreme Court of the State and secured a reversal. Upon a second conviction he again appealed and went to the Supreme Court of the United States on the grounds that his clients had been denied due process of law and had not received a fair and impartial trial as required by law. It became a case of national interest and perhaps of international interest when Mr. Gulotta invoked the intervention of the Italian Government on behalf of his clients.

It might be interesting to note that Mr. Gulotta was the first of Italian parentage in the State to be elected to the Legislature, appointed an Assistant District Attorney in the city of New Orleans and appointed an Assistant United States Attorney in this State.

Mr. Gulotta is a graduate of the Tulane Academic school and the Louisiana State University law school.

PUBLIC LEAGUE

As the Public League shapes up it appears that there will be as close a race in it as we expect in the Catholic League. Here's the rundown:

EASTON - Under new head coach Babe Gendusa, the Eagles look like the team to beat once again. Although they got off to a rocky start in the first two exhibition games, they came back very strong against Redemptorist and they appear to have settled down. In the line the Eags have three bruising All-Prep candidates in Jerry Negroto at center, Sid Anderson at one end and Jerry Randy at a guard spot. The offense is built around Billy Hatchett, hard running 190 lb. fullback. Long on experience, Easton looks like a repeater.

EAST JEFFERSON - Looming as a serious threat to Easton's domination of league play lie the Warriors under another new head mentor, Jimmy Dutreix. In their first few games the Jeffs have shown themselves able to score well and if they can plug a few gaps in their defense they'll be tough to handle. Led by such backs as Paul Trippi, a shifty runner, Iggy Modica another punishing runner and the pitching arm of Joe Barras, they will certainly show their opponents an explosive offense.

FORTIER - The Tarps look like they're in for their roughest year. Coach Mook Clavier can't find too much to be happy about at all. They do have a couple of good boys in Elbert Goff, a tough 195 lb. lineman and in passer deluxe, Bill Eckert. But there aren't enough Goffs or Eckerts!
