ALASKA'S EARTHQUAKE

Energy Greater Than
All A-Blasts To Date

ANCHORAGE, Alaska — In this biggest and hardest hit of Alaskan communities, and in half a dozen devastated smaller towns, leaders labored for a rebirth of the state's shattered economy even as they mourned the lost.

In California and Oregon quake-generated sea waves smashing against the coast killed at least 16.

Officials said much of the state's main industry, fishing, was wiped out by huge seismic sea waves that wrecked hundreds of boats, canneries and piers around the Gulf of Alaska. Railway facilities at Seward, the key supply center, were ruined. Waterfront shipping installations were extensively damaged.

President Johnson said after studying the disaster reports that "everything necessary" must be done, both for immediate and long-term relief. This would require new legislation.

At Seward, railhead for the line leading to Anchorage and Fairbanks, 90 to 95 per cent of industries and jobs were wiped out by surging seas followed by fire. The town of 1,700, about 60 miles south of Anchorage, lost a 5,000-foot chunk of waterfront which slipped into the bay, taking a cannery, docks, warehouses, offices, storage tanks. Rail facilities were obliterated. Twenty-nine homes were lost.

OSLO, Norway — The Alaska earthquake may represent a greater energy release than all the nuclear bombs ex-

ploded to date combined, a spokesman for the seismological station at the Norwegian west coast city of Bergen said in a radio interview.

He said his station believes the force of the Alaska quake to be between 8.3 and 8.6 on the Richter scale and added that an 8.6 quake represents an energy release equivalent to 10,000 megatons of nuclear explosions. A megaton is a million tons.

United States Is Rarely Hit

Earthquakes have taken a toll of hundreds of thousands of lives over the years.

Relatively, the United States has largely been spared.

The shock in Alaska on the 27 of March may have been the most severe in this country since 1906 when the San Francisco earthquake and resulting fire cost 452 lives.

The greatest quake toll of all time was a reported 830,000 deaths in China in 1556.

The last major quake prior to Alaska's took about 80 lives in Kashmir last Sept. 2. Six weeks previously 2,000 died in a quake at Skopje, Yugoslavia.

TWO NATIONS DONATE STATUES TO THE CITY

The French government has informed Mayor Victor H. Schiro that it will present to the city of New Orleans an equestrian statue of Joan of Arc, the Maid of Orleans who is France's national heroine.

The gift was announced to the mayor in a letter from Robert Picquet, French consul general in New Orleans, confirming that the 13-foot golden bronze statue, one of 10 in the world cast from the original mold will be presented to the city officially on April 18.

Tentative plans call for the placing of the statue, which has been in storage here for many months, at the foot of the new International Trade Mart tower in an area to be designated "Place de France," Schiro said.

In the meantime, another statue given to New Orleans—that of Francisco Morazan, the Central American liberator—soon is expected to be placed in the Garden of Americas, which is the neutral ground of Basin st., near the Municipal Auditorium.

The Morazan statue is a gift of the Morazan Society of Honduras and the five Central American republics of Honduras, Costa Rica, Guatemala, Nicaragua and El Salvador.

Fremiet was commissioned by the Emperor Napoleon III to do a series of sculptures among which was the one of Joan of Arc. In 1880 the first of the gilded statues of the Maid of Orleans to be cast from his plaster mold was erected in

heroine of France

Paris in the Place des Pyramides.

There are nine others, among which is the cast to be presented to the city, now in storage here with the stevedoring firm of T. Smith and Son Inc.

The Morazan statue is stored

in a warehouse of the Texas Transport and Terminal Co. Inc. and only a donation by Honduras to complete the collection for the cost of the pedestal remains to be made to complete the bequest by the five Central American republics,

Michelangelo's Masterpiece

AT THE WORLD'S FAIR

The Pieta' to be viewed by 70 million people

MICHELANGELO'S PIETA', the priceless white carrara representation of Mary grieving over the body of Christ, the most perfect masterpieces of all time, within days it will arrive in New York to grace the Vatican pavilion at the World's Fair.

For its 3,950-mile journey, the Pieta will be wrapped in linen and paper and rigidly braced inside its first wooden container. This box fits in wood shavings snugly inside the second wooden crate, which likewise rests in a bed of shavings inside the outer steel case.

What fairgoers will see is a double-figured statue 6 feet 7 inches high and almost as wide. An almost life-size Mary sits supporting her Son's body across her lap. His head hung back in death and His arms and legs dangling.

The name of the work, which some experts regard as the su-

preme example of Christian art in any medium and of any century, suggests both pity and piety. The mother's out-turned left hand, crowning detail of the sculpture according to many art lovers, reflects both utter helplessness and resignation.

Michelangelo faced the problem of how to show the body of a full-grown man reclining horizontally across the smaller body of a woman. His genius is said to show forth in the technical way he resolved the difficulty—by enlarging Mary's figure slightly and reducing Christ's figure by a fraction. Though the figures are carved on different scales they are so perfectly proportioned that the subtle mathematical differences escape the eye.

The draping of Mary's garments is so natural, with almost tissue-thin folds in her veil, that the Pieta appears to weigh nowhere near its massive 6,700 pounds.

Michelangelo once was questioned about the youthfulness in the face of Mary, who was supposed to have been near 50 at the time of Christ's death. The explanation of the 24-year old Florentine sculptor: "I wanted to stress the virginity and imperishable purity of the mother of God."

Michelangelo Buonarroti was born in 1475 in Caprese, son of the local mayor, a poor nobleman. The family soon moved to Florence. His mother died during his infancy and a stonecutter's wife nursed him.

Though he was a painter, engineer, architect and man of letters as well, Michelangelo always regarded himself as basically a sculptor. He signed letters even to his father as "Michelangelo, sculptor."

He began studying painting at 13 under the great Ghirlandaio, then moved into the Medici

Statistical data about the manufacture of sewing machines in Italy go back to 1925, and refer to machines for the home, with vibrating shuttles and non-flexible thread-stretchers. However, in a few years, Italian sewing machines attained a high degree of technical perfection in matters of kinematics and automatism. Ten years later, the first zigzag sewing machine for the home appeared using a feature previously found only in industrial machines.

Besides, the technically revolutionary line of the Italian sewing machine's industrial design attracted attention around the world. It won numerous awards such as the U.S.A. Consumers' Union "Best Buy", the London "Good Housekeeping" award, the "Guarantee Seal" of the U.S. Testing Company, the "Grand Prix" at the Brussels World Exhibition and a "Place of Honor" in the New York and Detroit Art Museums. The Italian sewing machine is today in demand in all world markets, for quality and for style. No big international trade fair or exhibition opens without the presence of Italian models among the sewing machines displayed —

whether it be in Paris, Budapest, Brussels, Poznan, Marseilles, Vienna, Berlin, Geneva Helsinki, Zagabria or Athens in Europe; Smirne or Saigon in Asia; Sydney in Australia; New York, Vancouver and other cities in North America; Mexico City, Lima, or Buenos Aires in South America; Casablanca, Lagos and Johannesburg in Africa. Total production of sewing machines in Italy reached the figure of 88,663 units by 1947. Two years later, the figure had been trebled.

By 1954 it had reached 430,000. At the present time it has passed 500,000 units. Exports have kept pace with the upward production curve. Compared to 30,000 machines exported in 1946 (in pre-war 1938 only 14,000 machines were shipped to foreign markets) the 1948 figure was more than doubled: 68,900 machines. By 1950, exports totalled 89,044 units; ten years later, 1960, the number of sewing machines exported rose to 182,000 machines. In addition, there was the wide-scale supply of sets of separate parts within the framework of industrial cooperation agreements,

enabling Italian-produced sewing machines to be assembled and manufactured abroad. Areas where exports of Italian sewing machines have made greatest progress: in 1954, mainly towards the dollar area (64% of total exports), in 1960 they were boosted to the European Common Market area, 34% and to the other countries of O.E.E.C., 36%. Exports have reached outstanding record targets in the most important markets. In the United States, alone — a market well known for being difficult to penetrate — there are more than 800,000 sewing machines of Italian manufacture. In the Common Market countries, France and Germany accounted for equal quantities of Italian sewing machines in 1960: 20,349 to the former and 20,300 to the latter.

An all-over survey of exports during the last five years shows a record level of 83,000 machines exported to France, followed by 65,000 to Yugoslavia, 60,000 to Western Germany and 36,000 to Holland. Exports outside Europe included, for example, 45,000 machines to Mexico and 41,000 to Australia.

In a number of countries where home production of sewing machines is being developed, thus blocking traditional importation, the foremost Italian industry of this sector has drawn up important agreements to ensure industrial collaboration. As a result, sewing machines are built under Italian license in countries such as the Argentine, Spain, Yugoslavia, Mexico, South Vietnam and Indonesia. New agreements are currently being stipulated with other countries whose national economy is tending toward local industrialization.

Naturally, a well-developed, organic trade network, with fully qualified technical and maintenance services has accompanied and facilitated the establishment of Italian sewing machines on markets throughout the world. Most manufacturers of sewing machines in Italy are members of an association, belonging to the Federation of Italian Industries (Confindustria). This Association is C.O. S.M.A. - Associazione Costruttori Macchine per Cucire (Sewing Machine Manufacturers Association) — with headquarters at 3, Via Brisa, Milan.

MASSANET'S "WERTHER" Nov. 5 and 7 with Rosalind Elias as Charlotte, Ara Berberian as Le Boilli and Rosemary Falgoust as Sophie.

Verdi's "Il Trovatore" Nov. 12 and 14 with Leyla Gencer as Leonora and Richard Torigi as Count Di Luna.

Puccini's "Madame Butterfly" Dec. 3 and 5 with Mielita Sghel as Cio-cio-san, Daniele Barioni as Lt. Pinkerton and Richard Torigi as Sharpless.

Charpentier's "Louise" March 11 and 13 with Dorothy Kirsten as Louise and Norman Treigle as the father.

DONIZETTI'S "Don Pasquale" March 25 and 27 with Gianna D'Angelo as Norina and Renato Capecchi as Dr. Malatesta.

The eighth opera, to be given in April, has not been announced.

ITALY OBSERVES MASSACRE DATE

ROME — Italy has solemnly observed the 20th anniversary of the Ardeatine Caves massacre, the Nazi reprisal killing of 335 Italians.

Hundreds of persons, including families of the victims, gathered for the observance at the caves in the Roman countryside near the ancient Appian Way, and watched President Antonio Segni lay a memorial wreath.

There, 20 years ago, the hostages were machine gunned for a partisan bombing that killed 32 German soldiers.

Prelates have coats of arms

Like royal families, the royalty of the Church has coats of arms.

The Pope, Cardinals, Archbishops, and Bishops have special insignia.

These are heraldic emblems usually consisting of a shield surmounted by the tiara or ecclesiastical hat from which cords with tassels descend. Often a motto is attached.

Cardinals' coats of arms have scarlet ecclesiastical hats with two cords, each having 15 tassels.

Archbishops have a green hat and 10 tassels on each cord.

Bishops also have a green hat but only six tassels on each cord.

The right side of the shield represents the diocese; the left, the family arms of the prelate.

Architects' Sketch of Vast West Bank Shopping Complex



40-Store Shopping Unit Planned

A major new development for this area will be a multi-million dollar, 40-store shopping complex on a 60-acre West Bank plot.

New Aurora Plaza, planned to have a theater and hospital along with dozens of stores and shops, will boast 350,000 square feet of leasable space. First phase of construction will start in June.

The new facility will stand at MacArthur Blvd. and Holiday Dr. in the midst of a growing residential area. Design is by August Perez & Associates.

Aurora Properties Inc. will develop the center which is to be provided with air-conditioned malls and parking for 3,500 cars. It is part of the corporation's \$100,000,000 West Bank development that includes several residential sections.

John T. Bills, corporation vice-president, said the "tremendous market potential existing in the area will grow in the next few years. A recent survey reveals that 34,855 households now exist in the new center's trade area.

Corporation president Charles Grandbouche said population figures in greater New Orleans have increased 55 percent during the two decades since 1940. Estimates for the next two decades show that population in greater New Orleans will increase by as

much again to a total of 1,351,500 persons.

Among major tenants in the center will be an 8,400 square foot theater with a seating capacity of 850. This will be one of the first tenants in the center and will be operated by Montgomery Enterprises. Owners say it will be a quality motion picture house showing first run movies and featuring new innovations in seating, sound and projection techniques.

Plans for the 150-bed hospital will be announced later.

National Food Stores will also be among first tenants. The firm will occupy a 21,000 square foot site.

Among other facilities to be included in the big development will be a department store, high fashion dress shop, cafeteria, steak house, bank, savings and loan firm, camera store, hardware store, shoe store, men's furnishings shop, auto supply shop, book and records shop, cocktail lounge, specialty shop and a sidewalk cafe.

Kaiser to Start Big Plant Soon

Kaiser Aluminum & Chemical Corp. announced Wednesday construction of a \$4 million isocyanates plant at Gramercy will begin in the near future.

The new plant will be operated by Kaiser Chemicals, a division of the parent corporation, and will produce 20 million pounds of isocyanates annually. Completion is set for early 1965.

Apartment Project Set

Construction is expected to begin immediately on conversion of a one-time furniture factory into a 60-unit apartment building on Chartres St. in the French Quarter.

The Vieux Carre Commission yesterday approved the conversion into an apartment complex to be called Le Richelieu.

At the same time, an old residence at 1228 Chartres will be restored as part of the complex.

THE VIEUX CARRE Property Owners and Associates opposed the demolition of a service ell at the rear of the 1228 Chartres residence. It will be torn down to make room for a patio and swimming pool.

Leonard J. Spangenberg Jr., architect for the property owner, Sam Recile Jr., said it would not be feasible to preserve the ell and not recreate the front of the structure.

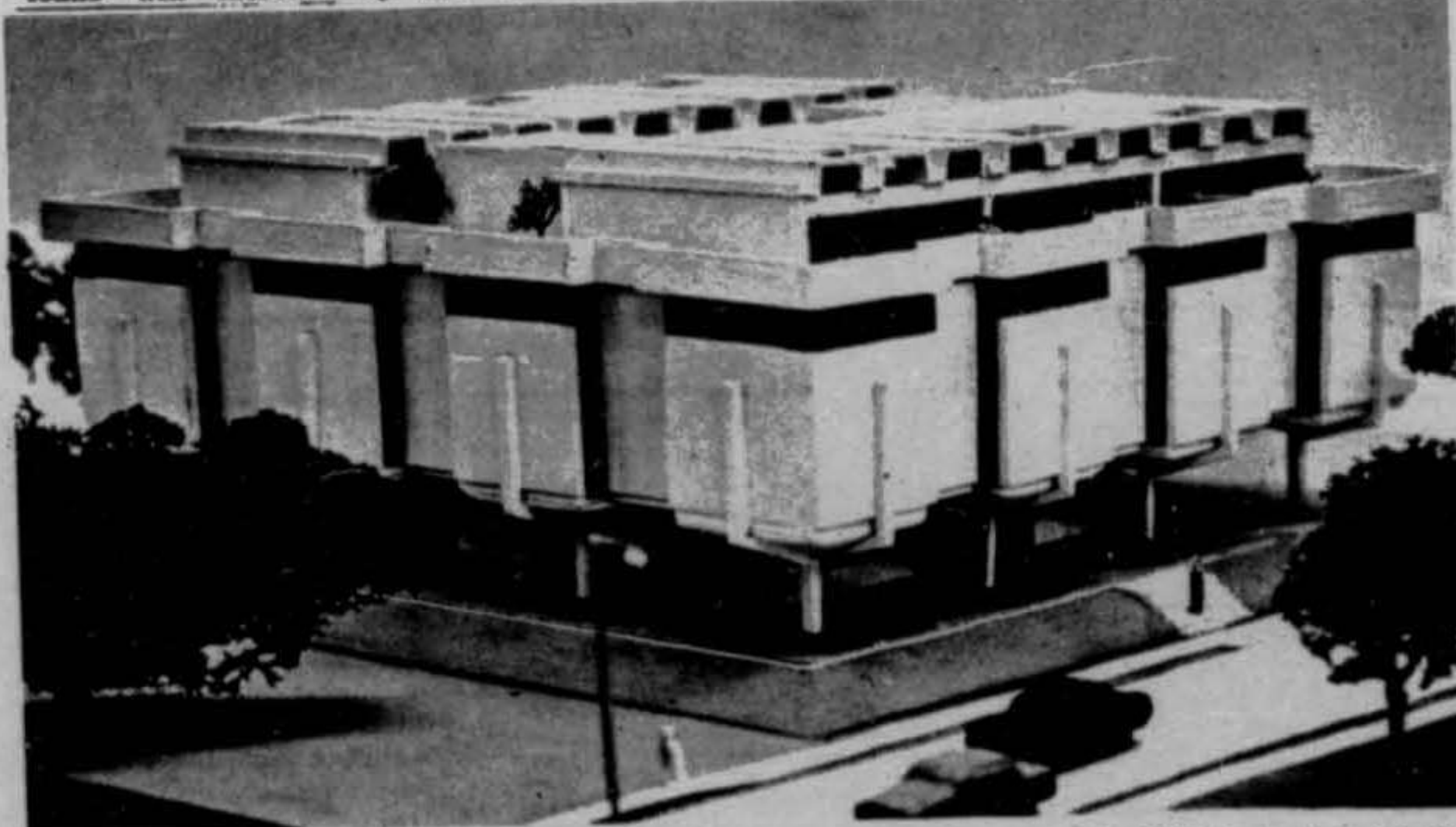
Spangenberg said he felt it was more important to restore the street scene than to preserve the ell which cannot be seen from the street.

Mrs. Mary Monison, representing the property owners, said she was opposed to the demolition of old properties and parts of structures.

THE COMMISSION also approved the demolition of buildings at 608-12 N. Rampart to make room for a small apartment building. The commission ruled the buildings unimportant and not historically or architecturally valuable.

Commission Chairman I. William Ricciuti announced he will no longer appear at City Council sessions called at the request of interested groups to reverse VCC decisions because he felt they were not legal.

The law gives the property owner, or applicant, the right to appear for a reversal opinion before the City Council, but other groups don't have this right, he said.

palace to learn sculpture under the sponsorship of the Florentine nobleman Lorenzo the Magnificent.

He already had begun to attract attention when he went to Rome in 1496. The French Cardinal Jean de Villiers di Lagraulas wished to donate a statue to the old St. Peter's Basilica. Michelangelo's Roman patron, a banker named Jacopo Galli, promised the cardinal in a contract that "the said Michelangelo will complete the said work within one year's time and it will be the most beautiful work of marble ever seen in Rome and no other master will be able to surpass it."

Nine months later in May 1499 the Pieta was finished. The car-

dinal paid Michelangelo 400 gold ducats, equal to \$1,000 — a far cry from the \$10-million insurance that the Vatican demanded for letting it go off to America five centuries later.

The Pieta was installed on Cardinal de Villiers' funeral monument—he died the month it was completed—in the Church of St. Petronilla at the edge of Vatican City. When the church was demolished to make room for the new St. Peter's, the Pieta was transferred to a nearby church, Santa Maria Della Febbre. It remained there until permanently installed in the rebuilt St. Peter's in 1749, never once having left the Vatican.

Inscribes Name

It was in the Church of St.

Petronilla, a few days after the statue was unveiled, that Michelangelo overheard two admirers suggesting the exquisite Pieta must have been done by the Milanese master Cristoforo Salari.

Upset, Michelangelo returned that night with mallet and chisel to inscribe across the ribbon on Mary's tunic: "Michel Angelus Bonarotus Florent faciebat," (made by Michelangelo Buonarroti, Florentine).

Never again did Michelangelo have to sign another work. The Pieta guaranteed him lasting fame even before he went on to sculpt other commanding masterpieces, paint the frescoes in the Sistine Chapel and help design the present St. Peter's Basilica.

Principal speakers were: Rev. J. C. Skinner of St. Bernard Methodist Church; Rev. J. A. Tomaszovich of Our Lady of Prompt Succor Church, and Rabbi Nathan Share of the Congregation Gates of Prayer.

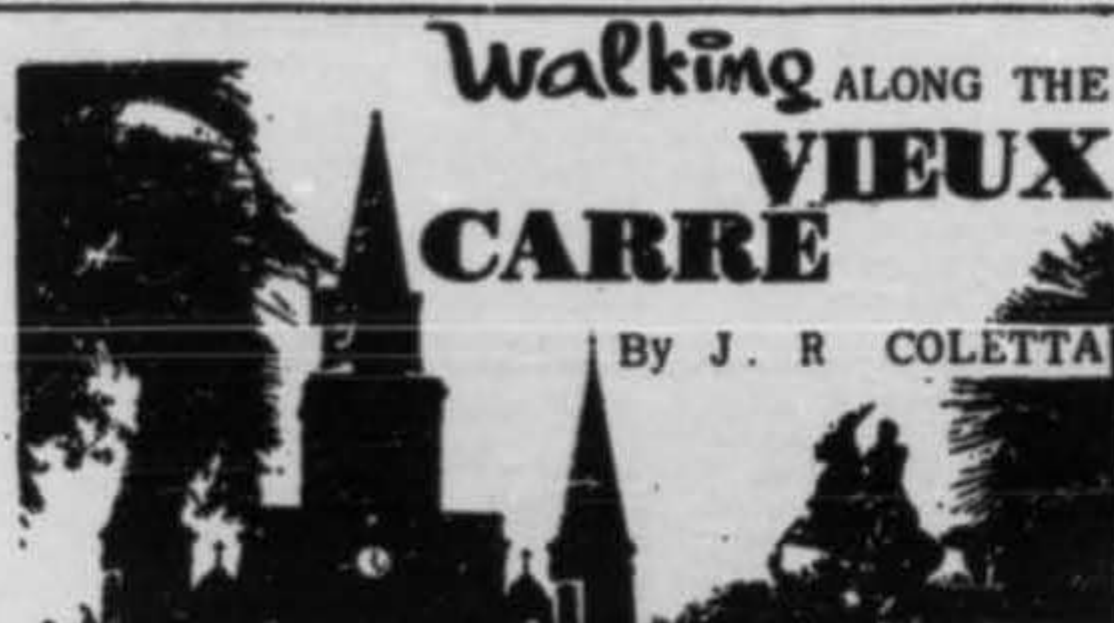

PORTALS OF AGES The Ursuline Convent



OF "OUR LADY OF PROMPT SUCCOR"

Carved in wood by an artist in France, this beautiful statue was installed in the chapel of the Ursuline Convent in 1810.

In 1895 was held a solemn coronation of this miraculous statue and the women of Louisiana gave gold, jewelry and precious stones to have a crown made to be worthy of this honor. This was done and each year on November 10 the anniversary of this glorious event is commemorated at the Ursuline Convent. The chapel, the National Shrine of Our Lady of Prompt Succor, is open daily at 2635 State Street.

The guarantee of the United States Government and the assurances of the first territorial Governor of Louisiana, William C. Claiborne, served the nuns well in their wonderful mission. Tranquillity however, was often upset, but in every small and grave circumstance, the recourse was always to OUR LADY OF PROMPT SUCCOR, who did invariably answer their petitions and the devotion spread and continues, powerful, in our present time. When in January 1815, the British were moving to capture New Orleans, citizens volunteered in its defense by joining quickly gathered troops from Kentucky and Tennessee; actually a hand full facing 10,000 well armed, well trained veterans of England.

At Chalmette as the battle lines were formed, General Andrew Jackson sent word to the Ursulines to pray.

It was on the morning of January 8 that the Mass of petition ended with a TE DEUM, the hymn of VICTORY obtained through the intercession of Our Lady of Prompt Succor.

General Jackson was so surprised by the happenings on the plains of Chalmette that he came in person to thank the nuns who had asked God's help.

The Ursuline nuns, who had worked so extraordinarily for 90 years, and had benefited Louisiana in all

of its moral aspects, finally moved to a new home on the grounds of the Industrial Canal in 1824.

The old Convent was turned over to the Bishop of New Orleans and it became an episcopal residence. Bishop Louis William Dubourg was the first occupant, followed by Bishop Joseph Rosati who was Bishop of St. Louis and Administrator of New Orleans; Bishop Leo de Neckere and Bishop Antoine Blanc, who in 1850 became the first Archbishop as New Orleans was raised to the rank of Archdiocese.

Six archbishops were in residence in the Ursuline Convent, until Archbishop

Chapelle moved to more suitable and appropriate quarters in the 1200 block of Esplanade Avenue in the year 1899.

From Convent to Bishop's residence, to Archbishop's palace, to Archdiocesan Chancery Office, to the rectory of the Oblate Fathers in charge of Saint Mary's, these have been the major administrative changes within the ancient but solid structure which today stands as it was but life is quite on the inside.

The Oblate Fathers of Mary Immaculate first took charge of historic St. Mary towards the end of 1919 and ever since have been also the custodians of numerous treasures which enrich the hallowed walls.

At this point we will transgress from our main subject to recall that in 1939 our son Eugene was baptized in St. Mary's by the late pastor Rev. Carmelo Gagliardoni, and in 1943 our daughter Diana was held at the same font and was baptized by Father Vincent Verdaraime who is now in Texas. Also, before we come to the conclusion of this writing, we wish to give a brief history of Father Vincent Liberto OMI, present pastor and successor to the late Father Gagliardoni. To say the least, Father "V" as he is affectionately called, is one of the most active, one of the busiest priests in the Archdiocese. He was born in Beaumont, Texas, on the 20th of January 1903, and spent his childhood in San Antonio, Texas. His parents were from Cefalu' (Sicily) and were married in New Orleans in 1899 in the Church of Guadalupe on North Rampart Street, known, at the time, as St. Anthony Italian Church.

Father Liberto is the 3rd of 8 boys and 2 girls. Sam, the oldest, and a Knight of the Order of the Holy Sepulcher, is on the Board of Directors of the Great Southern Life Insurance Co., Enrico is the owner of Liberto Specialty Co.,

Thomas P. is an insurance broker; Virgil A. an artist, died in 1938. Edward A. is a civil service aeronautical technician at Kelly Field, and Paul V. is associated with Enrico in the specialty business. Peter C. a twin of Paul, died in infancy.

The home of the Libertos is Houston. One sister, Venera Rose, a 1940 graduate nurse of Santa Rosa Hospital, makes her home in Dickinson, Texas, where her husband Dr. Andrew J. Magliolo, is a practicing physician.

Rose Mary, the youngest, a detective with the rank of Lieutenant, lives in Houston with her husband, John Magliolo, who is also a Lieutenant of the Police Department.

The mother of Father Liberto was Angelina Rinaudo. She passed away in 1924 at the age of 44.

Mr. Frank Liberto married again in 1928 and took as his wife Miss Margaret Biasiolli, who became a widow in 1940.

Father Liberto started his ecclesiastical career in the minor Oblate seminary of St. Anthony in San Antonio. His novitiate was in Mission, Texas, and was ordained June 7, 1929. His first assignment was as assistant at San Benito. In 1936 he became pastor and OMI District superior of Immaculate Conception in Asherton, Texas. From 1943 to 49 he was also District superior and pastor of the Immaculate Conception in Houston, and from 1949 to 1952, pastor of Sacred Heart in Crystal City Texas.

Father Liberto has been at St. Mary's well over a decade. The Italian people love him and ask for him, and that is why he is always on the go...

Father James Miller is the assistant at St. Mary's in charge of youth activity.

IL TRAFORO DEL GRAN S. BERNARDO

La grandiosa opera è costata 22 miliardi di lire

AOSTA (ANSA) Il traforo del Gran San Bernardo fu ufficialmente aperto al traffico la mattina del 19 marzo u.s.

L'opera è costata in totale 22 miliardi di lire, compresi i due tronchi stradali d'accesso. Sono stati impiegati oltre 20 milioni di ore lavorative; scavi di roccia per 900 mila metri cubi, con l'impiego di oltre un milione e mezzo di chilogrammi di esplosivo; impiegati un milione e mezzo di quintali di cemento, quattromila quintali di acciaio, 90 chilometri di conduttori elettrici.

Com'è noto, l'originalità di questo traforo è costituita dalla quota relativamente elevata degli imbocchi: 1.875 metri sul versante italiano e 1.918 su quello svizzero, che ha reso opportuna la costruzione di lunghi raccordi autostradali (km. 10,350 verso Aosta e km. 6 verso Bourg St. Pierre) in gran parte coperti. Ma con tale so-

luzione è stato possibile limitare a 5.853 metri la lunghezza della galleria vera e propria, il che ha consentito una efficace ventilazione, basata su due camini verticali di aerazione, lunghi rispettivamente 254 e 210 metri, situati a 2.900 e 4.400 metri dall'imbocco italiano. E la copertura di gran parte dei raccordi (gli ultimi sei chilometri e mezzo di quello italiano, i sei interi di quello svizzero) ha reso possibile e quanto mai sicuro l'accesso al traforo anche nei mesi di maggiore innervamento.

Bernardo, inserisce infatti sulla direttrice del 7° meridiano i grandi itinerari europei convogliando sulla rete autostradale italiana il traffico che proviene dal centro Europa.

Venezia la perla della laguna si sta spopolando lentamente

VENEZIA (ANSA) - Venezia, la perla della laguna, la città più bella del mondo, lo smeraldo della Serenissima, sta lentamente spopolandosi. Cresce ogni anno il numero dei veneziani che emigrano in terra ferma, a Porto Marghera a Mestre ecc. spinti dal bisogno di una vita esterna più dinamica e da concrete necessità di movimento e di lavoro. Nel 1963, la popolazione del Centro storico di Venezia (il comune di Venezia include anche i grossi centri urbani della terra ferma) è passato infatti a 129.500 abitanti con una secca perdita di 3300 unità rispetto al 1962 e di 5000 unità rispetto al 1961.

A questa diminuzione fa riscontro il crescente aumento degli abitanti della terra ferma; aumento che è stato assorbito nella massima parte da Mestre, che ha fatto segnare nel 1963 10 mila abitanti in più rispetto al 1961. Anche al Lido di Venezia si registra un lieve aumento di 300 unità rispetto allo scorso anno.

Secondo le statistiche in tredici anni (e cioè dal 1950 al 1963) la popolazione di Venezia è calata di 46 mila unità. Sono vari i motivi per cui i veneziani lasciano le isole per la terra ferma. Il primo luogo la necessità di abitare vicino al luogo di lavoro, e cioè riguarda soprattutto gli operai e gli impiegati delle grandi fabbriche nate negli ultimi decenni a Porto Marghera. Mestre ecc. In secondo luogo la terra ferma offre rispetto a Venezia il vantaggio di case nuove e funzionali dotate di tutti i comfort moderni. La cosa non è sempre possibile a Venezia "centro" dove le abitazioni sono ancora in gran parte quelle dei tempi della Repubblica, spesso insufficienti dal punto di vista igienico. Si aggiunge poi un terzo elemento: il minor costo della vita nei quartieri della terra ferma.

Insomma - dicono gli studiosi di questi fenomeni - se l'esodo dei veneziani continuerà con lo stesso ritmo in pochi anni

Venezia diverrà davvero quella "città museo" che molti vogliono e che insieme molti altri temono. Una città cioè destinata esclusivamente al turismo e quindi morta per almeno sei mesi l'anno.

I LAVORI DI RESTAURO NEL DUOMO DI MILANO

MILANO, (ANSA) - Si sono iniziati i lavori di restauro nel duomo di Milano. Si tratta di lavori lunghi e complessi quali mai negli ultimi due secoli erano stati affrontati. Dovranno essere rifatti gli intonaci, e le grandi volte gotiche del tempio i quali danno segno di cedimento e sgretolamento. E solo per questa parte il lavoro sarà lungo e difficile poiché essi interessano una superficie di oltre 7 mila metri quadrati. Intanto per raggiungere i lati più alti e riposti delle grandi volte sono stati innalzati i grandiponteggi tubolari sui quali già si aggirano gli operai per iniziare il lavoro.

La corrosione degli intonaci è dovuta più che al passare del tempo alle variazioni termiche

alle quali sono sottoposti. Già da tempo dalle volte si staccano pezzi di intonaco anche abbastanza voluminosi, tanto è vero che per evitare rischi per i fedeli si era provveduto a collocare su in alto una rete di nylon destinata a trattenere i frammenti caduti. Una rete naturalmente invisibile, dal basso, ma non per questo meno robusta e rassicurante. Per rallentare il processo di sfacimento degli intonaci bisognerebbe riscaldare il Tempio, rendere costante la temperatura sotto le volte.

E' un progetto abbastanza costoso, che per ora è allo studio. I lavori per rifare gli intonaci dureranno almeno due anni.

Cassino e il ventennale della distruzione della città

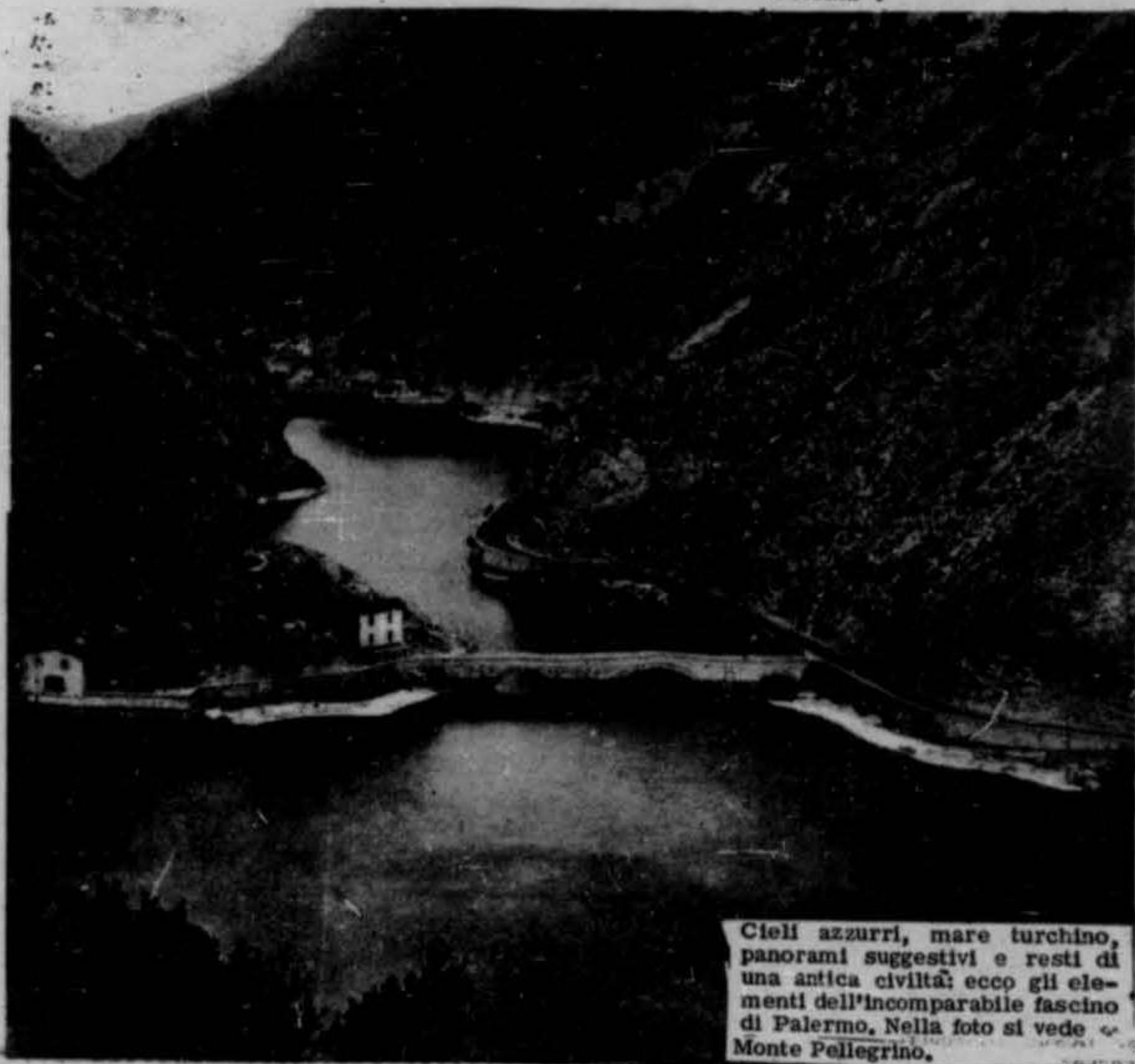

DEMPSEY IN LIBEL ACTION

NEW YORK —Jack Dempsey, former world heavyweight champion, charged in a \$3 million suit Wednesday that he was libeled in an article published in Sports Illustrated last Jan. 13 which said he won the title from Jess Willard in 1919 by using "loaded gloves."

In an action directed against Time, Inc., publishers of Sports Illustrated, Dempsey said: "In truth and in fact, my gloves were not 'loaded' when I defeated Jess Willard and won the heavyweight boxing championship of the world. I won the championship fairly and the published matter was, and is, false, malicious and defamatory."

Dempsey defeated Willard at Toledo, Ohio, on July 4, 1919.

In his complaint, Dempsey said that the cover of the disputed magazine bore the headline "Dempsey's gloves were loaded," and a sub-headline which read "Doc Kearns's own story of the bloody Willard fight."

The story, the ex-heavyweight champion said, was titled "He didn't know the gloves were loaded, by Jack (Doc) Kearns with Oscar Fraley."

Kearns died in July, 1963.

Dempsey said that the story charged falsely that his gloves "were improperly and surreptitiously weighted with plaster of paris when he fought Jess Willard."

As a result, the one-time heavyweight champion said, he had "suffered great injury to his good name, fame and reputation and injury to his present employment."

Cup to Stay in States—Ralston

KNOXVILLE, Tenn. (AP) — The Davis Cup, emblem of world tennis supremacy, may be retained by the United States a few years, says Dennis Ralston.

"I'm terrible at predicting things but I believe we can keep the Davis Cup for a while," Ralston said Sunday after an exhibition match in which he defeated his cup teammate, Chuck McKinley, 8-6, 8-6.

"I'm not even sure the Aussies (Australia) will be around for the challenge round," the Californian added. "They're no cinch." Ralston and McKinley combined their talents to wrest the Davis Cup from Australia.

Both Ralston and McKinley said they would like to see Vic Seixas accept the position as captain of the U.S. Davis Cup team. Seixas has been offered the non-paying job.

Why Was Manny Delayed? 'Had to Fight in Revolution'

BRADENTON, Fla.—Outfielder Manny Jimenez arrived in camp four days late, explaining he had been delayed by a revolution in the Dominican Republic.

"There no taxis," Jimenez explained. "They no like taxis. They shoot at them. I have to take back trails to airport."

Manager Ed Lopat asked Jimenez why he didn't start to the airport sooner and Jimenez told him he had to fight in the revolution.

"I don't see any bullet holes in you," Lopat said. "I don't even see any scratches."

"I too good a shot," Jimenez said. "They no get to me."

Jimenez was fined \$200—\$50 a day—for reporting late.

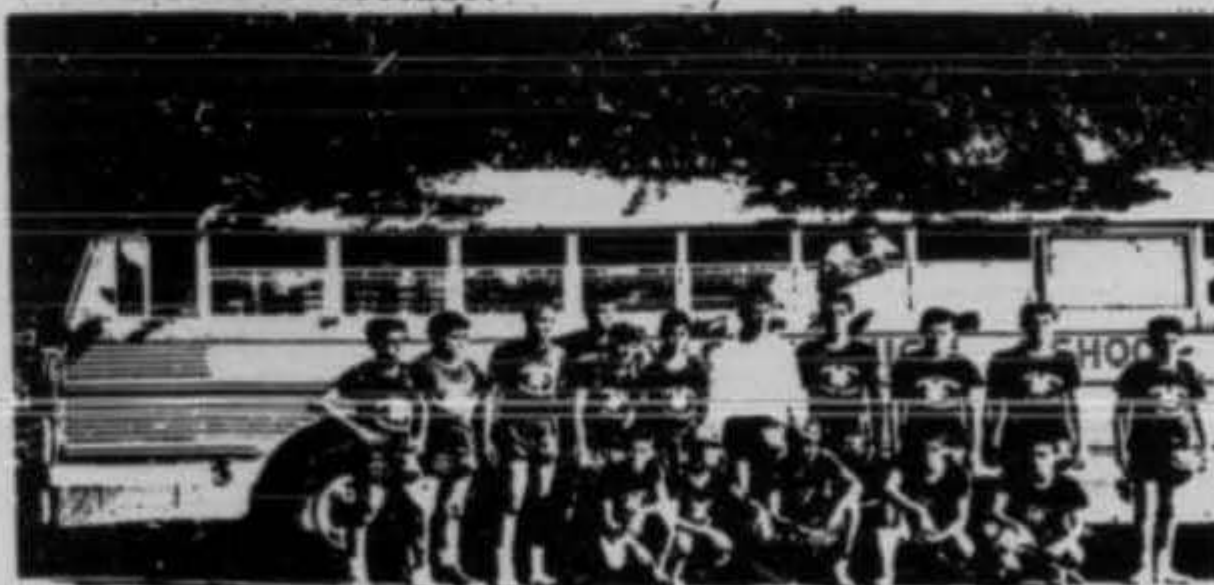

La Organizacion de Estados Centro-Americanos

Esta semana se reunieron en San Salvador, los Ministros de Relaciones de Centro-America y Panama, para cumplir la disposicion de reestructurar la ODECA conforme lo acordado solemnemente en este ultimo pais en diciembre de 1962. Se aprovechara la misma reunion para estudiar el caso del Canal de Panama, mejor dicho, la crisis panamena-norteamericana producida a raiz de los lamentables sucesos en la Zona-tramados, calculados y realizados, conforme planes previamente convenidos por la conspiracion castrista en Panama.

A la vez -tal como se ha dado a saber oficialmente-la reunion de Cancelleres va a conocer del caso de Panama, por acuerdo espontaneo, unanime y fraternal de los seis paises, sin que Panama pueda sentirse intervenida en su vida y sin que el resto de los Estados Centro-Americanos esten asumiendo el papel de interventores. Diriamos que en esta reunion de Cancelleres va a firmarse esa Nueva Alianza que patrocinamos, la Alianza para la Paz. Porque el deber supremo de America, en estos momentos, es unirse, compactarse, soldarse, integrarse en fin, con el cemento maravilloso de la fraternidad. Porque lograda la paz -a base de fraternidad y de justicia- todo lo demas nos podra venir como aña di dura.

Nicaragua Es el Cuarto Pais que Ratifica Convenio Centroamericano de Educacion

Nicaragua deposito en la sede de la Organizacion de Estados Centroamericanos, ODECA, el instrumento de ratificacion del Convenio Centroamericano sobre Unificacion Basica de la Educacion. La ceremonia se llevo a cabo en las oficinas de la Secretaria de la ODECA en San Salvador y a ella asistieron los Embajadores de las Republicas Centroamericanas, entre ellos el Lic. Eliseo Perez Cadalso, Embajador de Honduras.

Nicaragua es el cuarto pais que ratifica este convenio, calificado como uno de los mas importantes suscritos hasta la fecha por los gobiernos centroamericanos. Se ha explicado que tal convenio ya esta en vigencia y que algunos de los principios establecidos han sido aplicados, entre otros, dar validez a los años laborados por los maestros en cualquier pais del istmo. Anteriormente el importante convenio habia sido ratificado ya por Guatemala, El Salvador y Honduras.

Informe Sobre el Volcan Irazu se Entregara al Gobierno Tico

Durante los dias de la presente semana se espera que se entregue al Gobierno de Costa Rica, un informe de un grupo de vulcanologos extranjeros y nacionales, sobre estudios efectuados en el crater del volcan Irazu.

El grupo de tecnicos, que esta estudiando el crater del volcan desde hace ya algunas semanas, entregara este informe a la Oficina de Planificacion, que a su vez llevara a cabo las recomendaciones ante el Presidente Orlich. Entonces se decidira si se le da publicidad, o bien se mantiene en secreto, segun lo amerite la situacion.

Los vulcanologos y sismologos permanecen en el crater del Irazu, durante las 24 horas del dia, alternandose en turnos cada seis horas, con el fin de dejar terminado el trabajo en el tiempo previsto.

Mucho Cuidado con Brasil
