

2026 RIVER'S EDGE BRACKET CHALLENGE OFFICIAL RULES

To enter this 2026 River's Edge Bracket Challenge (the "**Giveaway**"), you must agree and abide by these official rules ("**Official Rules**").

NO PURCHASE NECESSARY. No purchase or payment is necessary to play or win. A purchase or payment will not improve one's chances of winning.

1. **Sponsor.** River's Edge Promotions, LLC ("**River's Edge**") is solely responsible for all aspects of the Giveaway. The Giveaway is not sponsored, endorsed, administered by or associated with LinkedIn or the NCAA in any way. NCAA® and MARCH MADNESS® are registered trademarks of the NCAA.
2. **Eligibility.** The Giveaway is only open to permanent legal residents of the fifty (50) states of the U.S. or D.C. (excluding Puerto Rico, Guam, all other U.S. territories and possessions, and where prohibited by law) who are (a) currently physically located and residing therein, and (b) at least eighteen (18) years of age or older (or the age of majority in their jurisdiction of residence, whichever is older) as of the date of entry ("**Eligible Participants**"). The following individuals are **NOT** eligible to participate in the Giveaway: any person who is a player, coach, team staff member, or officiant for the 2026 NCAA Division I Men's or Women's Basketball Tournaments, and each of the immediate family members of such excluded individuals (i.e., spouses, parents, children, siblings and the "steps" of each), and all persons living in the same household of each.
3. **Entry Period.** The Giveaway entry period shall take place between March 30, 2026, at 9:00 AM EST, and April 2, 2026, at 11:59 PM EST (the "**Entry Period**").
4. **How to Enter.** To enter, during the Entry Period, Eligible Participants must (i) follow River's Edge on LinkedIn, (ii) comment your pick of the winner of the 2026 NCAA Division I Men's Basketball Tournament and winner of the 2026 NCAA Division I Women's Basketball Tournament (collectively, the "**Tournaments**") on the River's Edge's original Giveaway post dated March 30, 2026, on LinkedIn, and (iii) link and repost the River's Edge's original Giveaway post dated March 30, 2026, on LinkedIn. Eligible Participants may only submit one (1) entry.
5. **Grand Prize Winner; Secondary Prize Winner; Alternative Selection.**
 - a. River's Edge will review all eligible entries received during the Entry Period to determine the Eligible Participants who correctly identified both final championship teams of the Tournaments. One (1) winner of the Grand Prize (as defined below) will be selected via a random drawing from among those correct entries.
 - b. If no eligible entry correctly identifies both final championship teams of the Tournaments, no Grand Prize winner will be awarded. Instead, one (1) winner of the Secondary Prize (as defined below) will be selected by River's Edge via a random drawing from among all eligible entries.
 - c. The selected winner of either the Grand Prize or the Secondary Prize will be notified via LinkedIn direct message. If the selected winner does not respond within forty-eight (48) hours following notification, River's Edge may select an alternate winner via randomized draw from the respective pool of such entries. This process will be repeated until a winner responds within forty-eight (48) hours following notification.

6. **Grand Prize; Secondary Prize.**

- a. The grand prize consists of (i) US \$1,000.00, (ii) one (1) case of Titleist golf balls, (iii) one (1) pickleball set, (iv) two (2) golf towels, and (v) two (2) sets of playing cards (the “**Grand Prize**”). The Grand Prize is non-transferable and no other substitutions are allowed. The total approximate retail value of the Grand Prize is US \$1,150.00.
- b. The secondary prize consists of (i) one (1) case of Titleist golf balls, (ii) one (1) pickleball set, (iii) two (2) golf towels, and (iv) two (2) sets of playing cards (the “**Secondary Prize**”). The Secondary Prize is non-transferable and no cash or other substitutions are allowed. The total approximate retail value of the Secondary Prize is US \$150.00.

7. **Odds of Winning.** The odds of winning the Grand Prize depend on the number of eligible entries received by River’s Edge and the number of eligible entries who correctly identify both winning teams of the Tournament. The odds of winning the Secondary Prize depend on the number of eligible entries received by River’s Edge.

8. **General Conditions:** This Giveaway is governed by these Official Rules and all applicable federal, state, and local laws. By entering the Giveaway, participants agree and acknowledge to be bound by these Official Rules, as well as the decisions of the River’s Edge, which are final and binding in all respects; to waive any rights to claim ambiguity with the Official Rules; and to indemnify and hold River’s Edge and its affiliates, and their respective directors, officers, employees and agents (collectively, the “**River’s Edge Parties**”), harmless from any and all liability resulting or arising from the Giveaway or the use of any submitted entry; and to release all rights to bring any claim, action, or proceeding against the River’s Edge Parties in connection with the Giveaway. River’s Edge reserves the right, in its sole and absolute discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of the Official Rules. 9. **Governing Law; Jurisdiction; Waiver of Jury Trial:** Any controversy or claim arising out of or relating to (i) the Giveaway, (ii) the awarding or redemption of the Grand Prize or the Secondary Prize, and/or (iii) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state’s laws. Any controversy or claim arising out of or relating to these Official Rules, its enforcement, arbitrability or interpretation shall be submitted to the state or federal courts located in the State of Delaware and participants hereby irrevocably waive, to the fullest extent permitted by law, any objection which he or she may now or hereafter have to the laying of the venue of any proceeding brought in any such court or any claim that a legal proceeding commenced in such court has been brought in an inconvenient form. PARTICIPANTS HEREBY IRREVOCABLY WAIVE ANY AND ALL RIGHTS TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATED TO THESE OFFICIAL RULES OR THE GIVEAWAY CONTEMPLATED HEREBY.

10. **Limits of Liability:** PARTICIPANTS HEREBY WAIVE ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL, AND CONSEQUENTIAL DAMAGES AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES, AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR INCREASED ARISING OUT OF OR RELATED TO THE GIVEAWAY, INCLUDING, WITHOUT LIMITATION, ANY ACCESS OR USE OF MATERIALS OR ANY WEB SITES TO ENTER THE GIVEAWAY. IN NO EVENT SHALL RIVER'S EDGE'S LIABILITY TO ALL PARTICIPANTS, IN THE AGGREGATE, HEREBY EXCEED \$1,150.00. Should any term of Section 9 or this Section 10 be deemed by a tribunal of competent jurisdiction void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring such Section within the requirements of law, be deemed to be severed from the other terms of these Official Rules, and the remainder of these Official Rules shall be given effect as if it had not included the severed term herein.
11. **Privacy:** By entering the Giveaway, participants agree to the collection and use of their personal information for the purposes of administering the Giveaway.
12. **Publicity:** Except where prohibited by law, by accepting the Grand Prize or the Secondary Prize, the winner thereof hereby grants River's Edge and its representatives an irrevocable, perpetual, worldwide, royalty-free, non-exclusive and sub-licensable right and license to use, distribute, and publicly display the winner's name, the contents of any posts, and information about the Grand Prize or the Secondary Prize, in any way, at any time, in any and all media, including without limitation, for use in advertising and marketing, without any additional approval or consideration.
