By using the limited license described herein, you, as an individual coordinating or attending a Meetup (each a “Participant”) agree to abide by these Hero Led Meetup Terms (“Terms”). Any terms not defined in these Terms shall have those meanings described in the [Platform Terms](#).

1. **Hero Led Meetups.** Meetups are not affiliated with Kajabi. Except for the licenses granted herein, Kajabi is in no way affiliated with Meetups, including, without limitation, not responsible for, or involved in any such event organized, led or sponsored by a third party person.
