This Privacy Policy describes how Breaking Trades LLC collects, uses, and protects your information when you access our services, including Breaking Trades AI, Breaking Trades Plus, and the Breaking Trades Discord Server. By using our services, you agree to the collection and use of your information in accordance with this policy.

1. **Information We Collect** We may collect the following types of information from you:
 - Personal identification information (name, email address, phone number)
 - Financial information (payment details for services)
 - Trading activity and performance data when using Breaking Trades AI
 - Communication data from the Discord Server
 - Technical data such as your IP address, browser type, and access times

2. **How We Use Your Information** We use the information we collect to:
 - Provide and improve our services
 - Process transactions and manage accounts
 - Respond to customer inquiries and provide support
 - Analyze and enhance the functionality of our AI-based trading systems
 - Communicate updates, offers, and promotions (where you have consented to receive them)
 - Comply with legal obligations and enforce our terms

3. **How We Protect Your Information** We implement appropriate security measures to protect your personal information from unauthorized access, disclosure, or alteration. While we strive to use commercially acceptable means to protect your information, no method of transmission over the Internet is 100% secure.

4. **Sharing Your Information** We do not sell, trade, or rent your personal information to third parties. However, we may share your information with:
 - Service providers who assist us in operating our website or conducting our business, provided they agree to keep this information confidential
 - Legal authorities if required by law or in response to valid legal requests

5. **Cookies and Tracking Technologies** We use cookies and similar technologies to track your interaction with our services and improve your user experience. You can choose to disable cookies through your browser settings, but this may limit your ability to use some features of our services.
6. **Your Data Rights** Depending on your location, you may have the right to:

12. **Payments, Fees, and No Refunds**

- **Payment Information:** When you provide payment details to Breaking Trades LLC, including credit or debit card information, this data is securely processed and stored via our payment processor, Stripe. Your card information may be saved to allow us to charge applicable fees and commissions as authorized by you.
- **Fees and Commissions:** Fees may include a **small flat fee** (which may vary) and a **commission of 20% on gains** generated through the use of Breaking Trades AI. Commissions are only charged if profits are realized. All fees and commissions are **final and non-refundable**. By providing your payment information, you authorize us to charge the applicable amounts manually.
- **Verification and Identity:** To access our Services, you may be required to submit a verification form and a government-issued ID to confirm your identity. This ensures that payments and services are provided to the correct user.
- **No Refunds:** All payments, fees, and commissions are non-refundable. By using our Services and providing payment information, you acknowledge and agree that all charges are final, and you waive any right to dispute payments or request refunds, except where prohibited by law.
