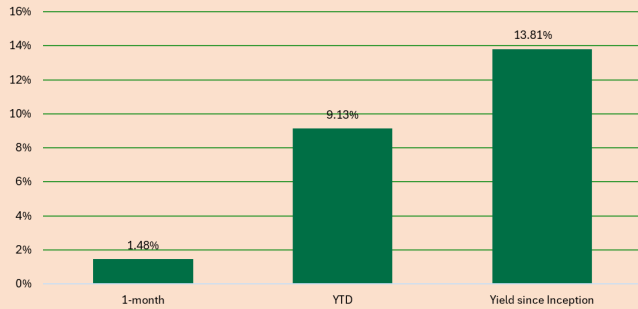

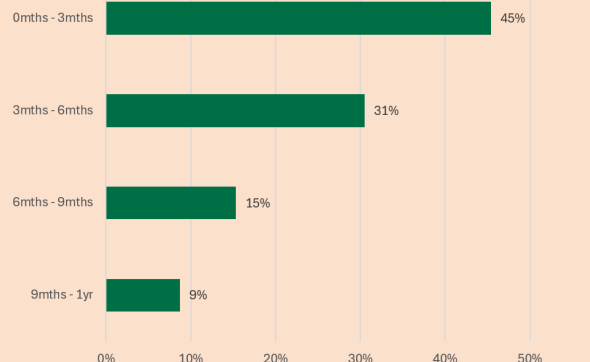
Performance of GHS 10,000 from inception vs Benchmark
