Donating publicly traded securities is one of the most tax-effective ways to support Synaptic and make a lasting difference in the lives of those living with neurological conditions.

When you donate stocks, bonds, mutual funds, or other publicly listed securities directly to Synaptic, rather than selling them first, you benefit from **two significant tax advantages** in Canada:

## 1. Elimination of Capital Gains Tax:

Normally, when you sell securities that have increased in value, 50% of the capital gain is taxable. However, when you donate those securities directly to a registered charity, **you pay no capital gains tax on the appreciated value**. This means your gift costs you less, and Synaptic receives the full value of the securities.

## 2. Charitable Tax Receipt:

You will receive a **charitable tax receipt for the full fair market value** of your donated securities on the day they are received by Synaptic's brokerage account. This receipt can be used to reduce your personal income taxes, depending on your tax situation.

# Example:

If you sell \$10,000 of appreciated stock, you may pay capital gains tax, leaving you with less to donate. If you donate the stock directly, Synaptic receives the full \$10,000, and you avoid the capital gains tax altogether—while still receiving a donation receipt for the full amount.

### **Simple Process:**

- Complete the attached form and provide it to your broker.
- Your broker transfers the securities directly to Synaptic's brokerage account.
- Synaptic will issue a charitable tax receipt once the transfer is complete.
