Parler's 15.3 million historic accounts represent one of the most engaged digital communities ever built. Until now, outreach relied on broad email campaigns, but with the relaunch under Parler Cloud Technologies, we have a powerful chance to re-engage this audience. Through targeted campaigns, invites, and incentives, we can turn dormant users into active participants across the full ecosystem.

Our **story**, to date

Parler Cloud Technologies is rooted in a decade of cloud innovation, from the founding of Edgecast and Triton to key infrastructure like MNX and Sanapptx. After Parler's explosive growth and eventual deplatforming, the company began rebuilding with a focus on scale, continuity, and control. Every milestone reflects a step toward platform resilience and global delivery.



Edgecast Founded

2006 – A high-performance CDN built for scalable, global content delivery.



Triton Cloud Founded by Joyent

2013 – Joyent, backed by Samsung, begins building Triton Cloud as a secure AWS alternative.



Parler Launches

2018 – Opens to the public as a free-expression social media platform.



Parler Deplatformed

2021 – Removed from all major app stores and AWS after reaching #1 in the app store.



MNX Solutions Founded

2006 – Launched as a secure, Michigan-based cloud infrastructure and data center provider.



Sanapptx Launched

2011 – IT service provider focused on cloud, migration, and business continuity.



Verizon Acquires Edgecast

2014 – Verizon acquires Edgecast and evolves it into Edgio for enterprise media delivery.

June, 2020 Hits 1M users.
Nov, 2020 Passes 8M users.

Our **story**, to date

Following Parler's deplatforming, Parler Cloud Technologies began assembling a censorship-resistant tech stack from the ground up. Over two years, the team acquired key infrastructure, rebuilt the backend, and launched ventures like Smart Cloud and Optio. By early 2024, the foundation was in place: decentralized cloud, enterprise-grade capacity, and blockchain-backed engagement.



The Concept Is Born

2021 –Yasser Elgebaly starts acquiring assets to build a censorship-resistant tech stack.



Parler Acquired

2023 – Acquisition completed as groundwork for backend independence begins.



Triton Acquired

Q1/Q2 2024 – Triton joins Parler Cloud Technologies to power decentralized compute and storage.



Triton Relaunches

Q1/Q2 2024 – \$300M+ R&D platform reactivated to support scalable, private cloud compute.



Smart Cloud Launches

2023 – New internal ventures Smart Cloud and Hyeworks debut.



Foundation Built

Q3/Q4 2023 – Core cloud infrastructure is assembled and Parler backend rebuilt.



MNX Acquired

Q1/Q2 2024 – Enterprise-grade cloud capacity expanded via MNX acquisition.



Optio Launches

Q1/Q2 2024 – Our blockchain backbone goes live, enabling trustless rewards and verified engagement.

With its creator stack live and PlayTV launched, Parler Cloud Technologies accelerated momentum across web3 tools and decentralized commerce. Kyvo brought payments and tipping on-chain, Cartix connected merchants to mission-driven buyers, and Edgecast ensured platform independence.
