

# **Deccox<sup>®</sup>-L** **Type B Medicated Feed**

## Product Description

Deccox<sup>®</sup>-L (decoquinate) Type B Medicated Feed prevents coccidiosis in cattle and calves, contains 4,542 g (0.5%) of decoquinate per ton of premix, and can be incorporated into complete feed or mixed into milk replacer. It is intended for the manufacture of Type B and Type C medicated feeds only.

## Indications for Use

- For the prevention of coccidiosis caused by *Eimeria bovis* and *E. zuernii* in ruminating and non-ruminating calves, including veal calves.

## FDA Status

- Category I drug and does not require a feedmill license for manufacture of medicated feeds.

## Withdrawal Periods & Residue Warnings

- No withdrawal period is required when used according to labeling.
- Do not feed to cows producing milk for human consumption.

## Packaging

- 50-pound, multiwall paper bag with protective barrier ply.

## Storage

- Store in a cool, dry place. Keep bag tightly closed.

## Key Points

- Synthetic coccidiostat developed for coccidiosis prevention in calves.
- Inhibits mitochondrial respiration in coccidia protozoa, halting development before clinical signs appear.
- Prevention of coccidiosis minimizes gut damage, bloody diarrhea, weight loss, immune suppression and secondary infections like bovine respiratory disease.
- Low toxicity and minimal risk of overdose.
- It contains lactose providing the ability to be mixed into a milk replacer formulation.
- Can be mixed into daily ration or into milk replacer formulation.

Mixing Directions	Mix 5.7 to 40 lbs. DECCOX-L with non-medicated feed ingredients to manufacture one ton of complete feed or milk replacer containing 12.9 to 90.8 grams decoquinat as in the examples below.
