

# UTGL Finance Privacy Policy

## 1. Disclaimers

This Privacy Policy applies to UTGL Finance Limited (referred to as “we”, “our company”, or “us”). ## 3. Use of Personal Data

We strive to maintain accurate and up-to-date records. Personal data may be used for:

- Conducting credit checks at application, renewal, or review stages
- Monitoring ongoing creditworthiness and account standing
- Updating records to assist group or affiliate companies in conducting credit checks or debt collection
- Designing and improving financial products and services
- Determining outstanding balances
- Conducting market research or internal analysis
- Complying with legal, regulatory, and compliance obligations
- Other purposes directly related to the above

#### **4. Direct Marketing**

We, our group companies, and affiliates may only use your personal data for direct marketing if you have given voluntary consent (including an indication of no objection).

Types of products and services marketed include:

- Financial products and services
- Rewards, loyalty, or privilege programmes

You may opt out at any time, free of charge.

All personal data will be treated as confidential. We may disclose or transfer data to third-party service providers or government/regulatory bodies where required. Third parties with access must comply with confidentiality obligations.

- 持續監察信用狀況及賬戶狀態
- 更新資料以協助集團或關連公司進行信貸檢查或追收欠款
- 設計及改良金融產品及服務
- 計算應收或應付金額
- 進行市場調查或內部分析
- 遵守法律、監管及合規要求

- 與上述直接相關的其他用途
