**Summary Report**

Honorable Members and/or to whom it may concern:

In accordance with the Administrative Procedure Act (La. R.S. 49:950 *et seq*), the Louisiana Real Estate Appraisers Law (La. R.S. 37:3391 *et seq*), and the Louisiana Appraisal Management Company Licensing and Regulation Act (La. R.S. 37:3415.1 *et seq*), the Louisiana Real Estate Appraisers Board (“Board” / “LREAB”) respectfully submits this *Summary Report*, providing an update regarding its initial January 6, 2026, *Notice of Intent Report*.<sup>1</sup>

Since LREAB’s submission of the *Notice of Intent Report*, no changes have been made to the proposed rules. Accordingly, the summaries of the proposed rules, which were included in the *Notice of Intent Report*, remain accurate and effective (See Exhibit A). The Board published its

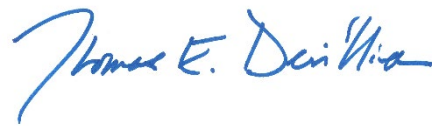

*Notice of Intent* on January 20, 2026.<sup>2</sup> No public comments were received either before or after the Board conducted an open meeting on March 16, 2026, in part, to consider any related public comments.

On March 26, 2026, the Board submitted its proposed rules to the Louisiana Department of Justice's Occupational Licensing Review Program ("OLRP"). Subsequently, on June 9, 2026, the Board received a written determination from the Louisiana Department of Justice, Occupational Licensing Review Program ("OLRP"), which, in part, approves the proposed rules and authorizes the Board to promulgate them.<sup>3</sup>

The Board intends to submit an insertion order to the Office of the State Register and proceed with final publication of the rules as soon as possible in accordance with the Louisiana Administrative Procedure Act. Please contact us at your convenience with any questions.
