FOR THE FINANCIAL YEAR ENDING 31ST MARCH 2023

On the 29 November 2021 the Board resolved as follows: -

- 1 That the proportion of its expenditure to be raised by drainage rates in respect of agricultural land and agricultural buildings and by special levies on local charging authorities is 3.0196% and 96.9804% respectively.
- 2 That the proportion between the local charging authorities of the amount to be raised by special levies is as set out against the special levy for each local charging authority.
- 3 To make the drainage rate and special levies set out below and that the seal of the Board be affixed to the drainage rate and special levies.
