Drainage Rates and Special Levies for 2026/27

As required by Section 48 (2) of the Land Drainage Act 1991, the Board gives notice as follows:

1. On 08 December 2025, the Board made:

A Drainage Rate of 7.763 (Seven Point Seven Six Three) in the pound (£) in respect of agricultural land and/or buildings in their district to raise £71,106.59 of their expenditure for the financial year ending on 31 March 2027, comprised of:

Note on amalgamation

This Section 48 notice is issued jointly by the Lower Medway Internal Drainage Board and the North Kent Marshes Internal Drainage Board.

By Order of the Secretary of State, with effect from 1 April 2026, the two Boards will be abolished and their functions, assets and liabilities transferred to a single successor authority, to be known as the North Kent Marshes Water Level Management Board.

The drainage rates and special levies set out in this notice have been lawfully made by the existing Boards prior to that date and will be administered by the successor Board following amalgamation.

Drainage Rates and Special Levies for 2026/2027: From 1 April 2026 to 31 March 2027

On the day of 8th December 2025, the Board resolved as follows:

1. That in respect of the financial year ending 31 March 2027 the proportions of expenditure to be raised by drainage rates with regards to agricultural land or buildings and by special levies on local authorities is 3.00% (£71,968.54) and 97.42% (£1,907,392.37) respectively.
2. That the proportions between the local billing authorities of the amount to be raised by special levies are as set out below, against the special levy for each local billing authority.
3. To make the drainage rates and special levels set out below.
