

Section 3 – External Auditor’s Report and Certificate 2024/25

In respect of **Lower Medway Internal Drainage Board – DB0045**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website – <https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/>

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2025; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2024/25

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 1 has been incorrectly completed, regarding arrangements for effective financial management during the year, and for the preparation of the accounting statements. This is consistent with the Internal Auditor’s response to Internal Control Objective A.

The AGAR was not accurately completed before submission for review. The bank reconciliation submitted in support of Section 2, Box 8, contains the balance of the CCLA Public Sector Savings Account as at 28 February 2025 not 31 March 2025. As a result, Section 2, Boxes 3 and 8 should read £831,927 and £3,491,922 respectively to recognise the interest received. This is due to the late receipt of the bank statement. Please ensure that amendments are corrected in the prior year comparatives when completing next year’s AGAR.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to weaknesses in relation to financial records, risk identification, budget monitoring, remuneration policies and procedures, members allowance and approval, and publication requirements. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.

The smaller authority has not provided year end bank statements to support the bank reconciliation to Section 2, Box 8 for 3 accounts where the total balances included in Section 2, Box 8 amounted to £18.25. This was also reported last year as the smaller authority has still not been able to gain access to the accounts.
