

2026 NERC and NPCC CMEP Focus Areas

Background

The table below shows the requirements identified by NERC (shaded blue) as Focus Areas in the 2026 ERO Compliance Monitoring and Enforcement Program (CMEP) Implementation Plan, along with additional requirements identified by NPCC (unshaded) as 2026 NPCC Regional Focus Areas. There are 67 total requirements: 56 from NERC (14 CIP, 42 O&P) and 11 from NPCC (4 CIP, 7 O&P).

This table is one of several NPCC considerations used in decision making as part of the development of annual risk-based compliance monitoring plans. Entities are still obligated to remain in compliance with all Reliability Standards that apply to their functional registration.
