Dinner:

- Kitchen closes 21:30 (Sunday to Wednesday). 22h30 (Thursday-Saturday)
- Reservations for 8-20 guests are required to pay a R2000 holding deposit and guests above 20 are required to pay a deposit of R300 per person, this amount is credited to your bill at the end of the evening.
- Our minimum spend per head is R500.

Payments:

- · Maximum of two split bills allowed per table, regardless of size or seating area
- Only 4 payments allowed per table.

Large Reservations:

- For reservations of more than 8 people, please email: reservations@kol-restaurant.co.za
- Set Menus, Deposits, Gratuity and Minimum Average Charge per Person is applicable for all bookings over 7 people.
- Booking deposits are refundable if cancelled within 48 normal hours' notice prior to the confirmed booking time.
- For bookings above 20 guests we do recommend having a set menu in place, however if guests want to use our
 a la carte menu, we require selecting starters to share for the table.
- We strongly recommend selecting 3 mains options guests can select from and 2 dessert options

In the case of the reservation not having been cancelled 48 hours in advance from the reservation date, KōL Izakhaya reserves the right not to refund the deposit. Instead, the reservation shall be postponed to a later date. An administration fee of R250 shall apply for all cancellations.

Cancellations Terms:

- Cancellations within 24 hours will result in a surcharge of 25% of total holding deposit
- Cancellations within 48 hours will result in a surcharge of 12% of the total holding deposit
- 100% of the holding deposit will be kept in event of no shows or cancellation on the day of the booking.
- An administration fee of R500 shall apply for all cancellations for The Private Dining room.

Private Dining Room:

- Maximum of 22 Guests.
- Minimum, Compulsory Service Charge of 15% applies due to additional resource allocation.
- All bookings in the private dining room are required to use a set menu.
- Maximum Time Allocation of 4hrs Applies.
- Minimum Surcharge of R8 000.00 per reservation (holding deposit).

Absolutely no photography is allowed in the restaurant, as this is not a private space and can negatively affect the experience of other guests. Only guests booked in the private room can take pictures inside the private room.

Reservation Terms

- On busy days guests are allowed 3hrs dining experience, with the option of moving to the bar.
- KōL Izakhaya tables will be held for a maximum of 20 minutes after your confirmed online reservation times, thereafter, tables will be released, or as in the case of no-shows.

Re-allocation:

Table Allocation:

Although we always strive to give our guests the table of their preference, we cannot always guarantee this. Online reservations may include seating allocated at our Sushi Bar or Robata Counter i.e. Seating at tables is not guaranteed.
