Electrical Supply Circuit Requirements

Plan the location of the appliance so that it will have adequate electric power. A 15 AMP, 60Hz circuit is required for 120V installation. Additional appliances on the same circuit may exceed the current rating of that circuit. A dedicated circuit is not required, but is preferred to prevent circuit breaker trips or fuse failure.

Do not cut the ground terminal off under any

circumstances. When connected with 120 volts, the appliance must be electrically grounded in accordance with local codes, current version of CSA C22.1 (in Canada) or in the absence of local codes, with the National Electrical Code ANSI/NFPA 70-1987.

DO NOT operate any appliance with a **damaged cord or plug** or after the **appliance malfunctions**, has been **dropped** or **damaged in any manner**. Discard appliance, or return to authorized service facility for examination and/or repair.

This appliance is **hot when in use**. To avoid burns, **DO NOT** let bare skin touch hot surfaces. Keep **combustible materials**, such as furniture, pillows, bedding, papers, clothes, and curtains at least **3.3 feet (1.0 m)** from the **front of the appliance**.

Extreme caution is necessary when any appliance is used by or near **children** or **invalids** and whenever the appliance is left **operating and unattended**.

ALWAYS disconnect this unit from the **power** supply **before** performing any assembly or cleaning, or before relocating the electric fireplace.

Always use properly grounded, **fused** and polarized outlets.

Always use ground fault protection where required by electrical code.

Avoid use of an **extension cord** because an extension cord may overheat and cause a fire. If you have to use an extension cord, the cord should be **N.14 AWG minimum size** and rated to not less than 1875 Watts.

NEVER plug this appliance into an outlet that is **old, cracked**, or has any loose wires or connections. Plugging this appliance into a faulty outlet could result in **electric arcing** within the outlet that could cause the **outlet** to **overheat or catch fire**.




OPERATING INSTRUCTIONS



WARNING! Do not operate the appliance if it is damaged or has malfunctioned. If you suspect the appliance is damaged or has malfunctioned call a qualified service engineer to inspect the appliance, and replace any part of the electrical system if necessary, before reuse.

Do not disconnect the power at the main supply <u>while</u> <u>the appliance is running</u>. Use the functions on the remote to turn the fire off and ensure the main switch has been moved to the off position before disconnecting.

MANUAL CONTROL PANEL

OPERATING THE APPLIANCE

Press 1 to turn the appliance on/off.

Press 2 to turn flames on/off.

REMOTE CONTROL

The remote control should be left on a flat surface in the room where the appliance is installed and away from any direct flow of hot air.

IMPORTANT: If operating the appliance using the remote control provided, do not touch the following buttons on the control panel. (1. Power On/Off 2. Flame On/Off button 3. Heater On/Off) These 3 buttons on the control panel are only to be used when operating the appliance in manual mode without use of the remote control.

OPERATING THE APPLIANCE - ADVANCED OPERATION

POWER

Initial Startup

Press the main power button \bigcup to turn on the fireplace. All settings will be in their initial status:

Flame: Option 1

Top Light: On, Brightness Level 5

Ember Light: On, Brightness Level 5, Orange

Heater: Off


Volume: On, Level 4

Subsequent Operations

After the initial startup, when the power is off, press the main power button once to turn on the fireplace. All settings will revert to the last operation status.

Power On

When the power remains on, the remote screen will continuously display icons representing the functions that are currently active.








Power Off

To power off the device, press the main power button \cup once. One short beep sound will indicate that the device is powering off. The remote control display will subsequently turn off most of the icons and display only the room temperature.

Standby Mode

If the remote is inactive for 10 seconds or longer, the remote screen will switch to standby mode.





HEATER

IMPORTANT

Heater Mode Operation

When the appliance heater is turned on, there will be two temperatures displayed. Both ROOM (top left hand corner of the remote screen) and SET (top right hand corner of the remote screen. Unlike typical thermostats/remote thermostats, the ROOM temperature on the remote will not change regardless of any temperature change that occurs in the room where the remote is located as the remote goes into a sleep mode. The only way to see if the ROOM temperature has changed would be to press any button on the remote to wake up the remote. Importantly, the unit's actual temperature control is managed by an internal sensor located beneath the ember bed. This sensor does not communicate with the remote, which is why the displayed ROOM temperature on the remote has no impact on how the appliance functions. Once the internal sensor detects that the set temperature (with a ±2° variance) has been reached, the heater will shut off. The blower fan will continue to run for an additional 30 seconds and then will also shut off.

Turn on the Heater

STEP 1 - Press the heater button to turn on the heater mode. The remote LCD will display the heater icon ...


STEP 2 - Use the + and - buttons to adjust and set the preferred temperature.

Turn off the Heater

When the heater is on, press the heater button again to turn it off.

The heater icon will disappear from the remote LCD. All other functions will remain unchanged.









The remote screen will automatically return to the operating status display after 10 seconds of inactivity.



BATTERY REPLACEMENT



Ensure that the handset batteries are new and inserted correctly.

The Remote requires two 1.5V alkaline AAA batteries.

Ensure the correct polarity.

Do not short circuit the terminals.

Do not attempt to recharge non-rechargeable batteries.

Remove rechargeable batteries before charging.

Do not mix old and new batteries.

Remove batteries if the appliance is not used for long periods.

Changing the batteries will not affect the Timer settings.

MAINTENANCE

ENSURE THE APPLIANCE IS TURNED OFF BEFORE CLEANING.

GLASS CLEANING

Wipe the glass viewing panel with a damp cloth and buff with a lint free duster.

Caution: Do not use abrasive cleaners on the glass panel. Do not spray liquids directly onto any surface of the unit.




CLEANING AIR INLETS

Clean the air inlet and outlet grilles regularly with a soft cloth or the nozzle of a vacuum cleaner.

Dust build-up can inhibit efficient performance of the fan and lead to the safety cut-out operating.

Keep the area around the appliance clean and free of fluff, dust or pet hair.

In particular, build-up of dust etc. can occur around the heater area. Take particular care to keep this area free from such particles on a regular basis to prevent build-up.





INSTALLATION

GENERAL

TOOLS REQUIRED

A Screwdriver, Level, and Drill will be needed.

UNPACKING THE FIREPLACE

WARNING! DO NOT use this appliance if any part has been exposed to water.

Immediately call a qualified service technician to inspect and to replace any part of the electrical system if necessary.

Open the packaging carefully and remove the polystyrene.

Remove and discard the plastic bag.

Keep plastic wrapping away from children.

Be responsible when handling the packing materials.

Check all parts and accessories are removed before disposing of any packaging.

If necessary keep the original packaging for future transport and/or storage.

Test the appliance before installation.

FITTING THE APPLIANCE

LOCATING THE E800 LCD

Your new E800LCD may be installed virtually anywhere in your home. However, when choosing a location ensure that the general instructions are followed.

For best results, install out of direct sunlight.

The heater should ideally be fitted into/onto an internal flat wall constructed from either wood framing and drywall/brick, etc. The fixings provided are for use on masonry fireplace ONLY. Please ensure that suitable fixings are used when securing to any hollow or purpose built cavity. This may also be installed into a masonry fireplace as long as it meets the requirements as per below.

NOTE: This appliance is not suitable for fitting to a Cavity Wall, backing on to an outside wall, an open chimney or any opening that may be subject to damp and draft, unless adequate precautions are taken to avoid the appliance coming into contact with moisture or excessive drafts.

Into Framed construction: For exterior/outside walls, insulate the enclosure to the same degree as the rest of the house, apply vapor barrier and drywall, as per local installation codes. Do not insulate the appliance itself.

Into masonry chimneys: The flue damper must be fully blocked if safe to do so for installation of the unit. Ensure the fireplace and chimney are clean and in good working order, and that all chimney clean-outs are tight-fitting and not permitting air into the chimney. Install a sealed vent cap and metal flashing at the top of the masonry chimney to prevent water leaks and air movement within the cavity. Do not insulate the appliance itself.

Make sure there are no pipes or cables behind the area to be drilled or cut.

Always ensure the appliance is adequately supported and sits on a firm structure when mounting above floor level.

IMPORTANT: It is highly recommended to complete finishing of the wall fully prior to sliding the appliance into final position.

Once the rough in framing & the finishings materials have been completed and power has been routed to the right hand side of the recess in the wall, the appliance may be slid into its final position.

This will allow ease of installation and for servicing if ever required in future.

WIRING KITS

This appliance is supplied with a 3 prong plug with a 93.3" (2.37m) lead.

Power for this appliance will be located on the right hand side if facing the appliance from the front.


Note: Must be plugged into a 3 prong receptacle which is exposed and accessible. Do not under any circumstances, cut the ground on the 3 prong plug.

This appliance is for use on 120 Volts only with the supplied power cord. The cord has a plug as show in (A). An adapter as shown in (C) is available for connecting three-blade grounding type plugs to two slot receptacles. The green grounding lug extending from the adapter must be connected to a permanent ground such as a properly grounded outlet box. The adapter should not be used if a three-slot grounded receptacle is available.

The appliance should ideally be located close to a suitable receptacle to enable connection. An extension could be run from an existing socket outlet but this must be carried out by a suitably qualified electrical engineer. The electrical socket must be easily accessible to allow disconnection when the appliance is fitted. If the power cord is damaged, it must be repaired by the authorised service centre or professional person.

Ensure that curtains and furniture are not positioned close to the chosen position, as this would create a potential fire hazard or block the heater outlet ducts.

WARNING! KEEP ALL COMBUSTIBLE MATERIALS AT LEAST 1M (3.3 FEET) FROM THE FRONT OF THE ELECTRIC FIREPLACE.





To disconnect the appliance, turn the controls to off, then remove plug from outlet.

This appliance must be connected and grounded in accordance with local codes, if hard wired. In the absence of local codes, the use the current CSA C22.1 CANADIAN ELECTRICAL CODE in CANADA or the current ANSI/NFPA 70 NATIONAL ELECTRICAL CODE in the UNITED STATES.

HARDWIRING

This appliance can also be hardwired. See HARDWIRED INSTALLATION within this manual for details.

SERVICING REQUIREMENTS

Wait for at least 10 minutes until the appliance has cooled down.

Remote Handset Battery Replacement

Replace with 2 AAA batteries. Make sure the batteries are installed correctly in the remote control.

Resetting the Thermal Cutout Switch

The appliance is fitted with an Electronic Safety Control (E.S.). This is a safety device which switches off the fire if the appliance overheats for any reason e.g. when covered.

If the heater stops operating while the flame effect continues normally, this indicates that the E.S. Control is in operation.

The E.S. Control can only be re-set after the appliance has cooled down.

To re-set the F.S:

Switch off the appliance (Manual On/Off switch) and leave for approximately 120 minutes.


Remove any obstruction to the fan heater outlet or other internal parts.

Switch on appliance and the E.S. Control will re-set. Ensure that the appliance is functioning correctly. If the E.S. Control operates again, the appliance should be checked by a competent Electrician.





IMPORTANT: It is highly recommended to complete finishing of the wall fully prior to sliding the appliance into its final position. Once the rough in framing & the finishings materials have been completed and power has been routed to the right hand side of the recess in the wall, the appliance may be slid into its final position. This will allow ease of installation and for servicing if ever required in future. Also see **FITTING THE APPLIANCE** in this instruction manual.

Electrical Receptacle in a Masonry Fireplace/Wood Framing

The electrical receptacle (if permitted) can be placed on the left or right side of the unit within the masonry/wood framing enclosure, respecting the following conditions:

- 1. Distance from the receptacle face to the insert minimum 3" (76 mm).
- 2. Height from the top of the receptacle to the floor of the fireplace: maximum 3.5" (89 mm).
- 3. The receptacle box and receptacle cover must be made of metal.
- 4. Where the 120-volt power cord exits toward the receptacle, it must not come into contact with the back or sides of the fireplace. When installed, this appliance must be grounded in accordance with local codes, or in their absence, the National Electrical Code ANSI/NFPA 70, or the Canadian Electrical code CSA C22.1.

IMPORTANT: Check with your local inspector before starting this installation, as some jurisdictions may not allow placement of this receptacle within a masonry chimney/Fireplace/wood framing.

Note: Ensure that the appliance is sitting on a solid continuous surface which is the full width and depth of appliance and is level.

Finishing Materials (Wood Framing)

Combustible or non-combustible finishing materials may be used to finish up to the fireplace.

DO NOT PACK THE VOID AROUND OR ABOVE THE APPLIANCE WITH INSULATION OR MINERAL WOOL.


NOTE: In order to avoid the possibility of exposed insulation or vapour barrier coming into contact with the appliance body, it is recommended that the walls of the appliance enclosure be "finished" off with drywall/sheetrock as you would finish any other outside wall of a home. This will ensure that clearance to combustibles is maintained within the cavity.

Once the opening has been prepared and the power has been routed to the right side (if hardwiring) of the appliance, follow steps below.

- A. Remove the glass front (See glass front removal)
- B. If leveling legs are required this should be installed with the bolts provided.
- C. If hardwiring, the electrical connections must also be made prior to placing the appliance into opening.
- D. Level the appliance and slide insert into its final position
- E. Install the log set
- F Reinstall the glass front.
- G. Plug 3 prong plug into a suitable receptacle or if hardwired, turn breaker on.



*Heater Mode Operation

When the appliance heater is turned on, there will be two temperatures displayed. Both ROOM (top left hand corner of the remote screen) and SET (top right hand corner of the remote screen. Unlike typical thermostats/remote thermostats, the ROOM temperature on the remote will not change regardless of any temperature change that occurs in the room where the remote is located as the remote goes into sleep mode. The only way to see if the ROOM temperature has changed would be to press any button on the remote to wake up the remote. Importantly, the appliance's actual temperature control is managed by an internal sensor located beneath the ember bed. This sensor does not communicate with the remote, which is why the displayed ROOM temperature on the remote has no impact on how the appliance functions. Once the internal sensor detects that the set temperature (with a $\pm 2^{\circ}$ variance) has been reached, the heater will shut off. The blower fan will continue to run for an additional 30 seconds and then will also shut off.







 Replace ember light strips. Once Logs and ember bed have been removed the ember light tray will be exposed as shown below.




2. To remove the ember bed light strips, remove the logs and ember bed, start by gently squeezing and pulling each strip upward to

detach it from the black securing post. Once all seven ember strips have been removed, disconnect each Molex connector linking the strips together. Note that one of the Molex connectors is secured with a zip tie, which will need to be carefully cut to free the ember light wire harness.

After the zip tie is removed and all connections are detached, proceed with replacing the ember bed light strip. Once replaced, secure the new strips firmly onto the black securing posts and ensure they are stable.

Finally, reconnect all the Molex connectors and verify the stability of the entire assembly.



LCD screen glass layer access

 Remove rear glass panel. Remove the unit from the cavity and remove the glass and media including the ember bed, logs and brick panels, remove the retainer bracket held in place with 4 x Philip head screws as shown below.





Once the retainer bracket has been removed the rear glass can be removed by tilting the glass forward and lifting outward.



NOTE: the LCD screen will also move with the rear glass care must be taken not to damage the LCD screen.



Steps for Removing the LCD Screen:


1.Open the top and back covers to expose the power board and multimedia video board.



2.Disconnect the screen's power cable from the power board (1) and the data cable from the video board (2).



- 3.Remove the protective strip from the top of the LCD screen's front glass. Caution: As you remove the front glass, the LCD screen must be supported with an appropriate object to prevent it from falling out of the fireplace chamber.
- 4. Carefully remove the LCD screen from the chamber.



Important: The LCD screen and its connections are fragile electrical components.

Handle with extra care and gentleness to avoid damage.



Electric Circuit Board Access:


Remove the Access Panel:

 Disconnect the power supply and carefully extract the unit from the cavity. Position the unit to facilitate access to the rear access panel, as illustrated below. Remove the six Phillips head screws, located as indicated, to access the main control board.



Detach the Control Board:

With the access panel removed, you may now proceed to detach the control board. To do so, press in on the four vertical black posts while simultaneously and carefully pulling each corner of the control board to disengage it. Once the board has been detached, observe, and document the positions of the Molex connectors for future reference. Proceed to disconnect each connector and then install the replacement control board.



Important:

Document Wire Connections:

Before disconnecting any wires, take note of the positions and configurations of all Molex connectors.

Ensure each connector is clearly labeled or documented for proper reinstallation.

Disconnect the Connectors:

Proceed to disconnect each Molex connector one at a time. Ensure all wires follow the proper connection codes and are securely fastened. Inspect for any loose or damaged wires and address any issues before proceeding.

Install the Replacement Electric Circuit Board:

Position the new control board, ensuring it is aligned with the mounting posts. Carefully reconnect each Molex connector according to the documented positions, ensuring each connection is secure and follows the correct wiring codes. Double-check that

all connections are tight and properly seated.

Final Checks:

Once installed, confirm that the board is properly secured in place and that no wires are pinched or misaligned. Verify all connections for stability and correctness before reassembling the unit.

Blower, heater, remote receiver, top LED lights Access:

 Remove the unit from the cavity and disconnect from power, remove top outer firebox by removing 15 Philip head screws.
 screws are located on the top of the appliance, 4 screws are located on the rear and 4 screws are located on each side.







Once all screws have been removed and the outer top shell has been removed, the top of the unit will be exposed as shown below. Access to the heater, blower, upper light and receiver are now accessible to swap out.



To remove and replace the operation button assembly:

- 1.Remove the two Phillips head screws from the top, as shown in Diagram 1, and another two Phillips head screws as shown in Diagram 2.
- 2. This will release the retainer holding the receiver in place (refer to Diagram 3).
- 3. Disconnect the Molex connector from the rear of the receiver.
- 4. Replace the component and follow the steps in reverse to reinstall.

Top LED light, Heater and blower replacement

1. With the top of the unit exposed remove the fan mounting bracket by removing 4 Philip head screws on top and 2 Philip head screws on the left and right side as shown below.





Once the mounting bracket has been removed, remove 3 screws on each side of the heater unit (6 Total) doing so will allow access to the top light and the Molex connector.





Once the Ember light strip has been removed remove the physical strip from the mounting plate by loosening 2 \times nylon Philip head screws as shown below.





To replace the blower or heater unit the above steps will need to be repeated, making sure to disconnect the wiring from the blower or heater unit.

Blower or Heater Unit Replacement:


To replace the blower or heater unit, follow the steps outlined above, ensuring that all wiring is properly disconnected before removal.


