



Determination of the physical existence of Wheat, Barley, Corn, Hazelnut products, which constitute the physical basis of Cropto Tokens (Cropto Wheat Token (CROW), Cropto Barley Token (CROB) , Cropto Corn Token (CROC), Cropto Hazelnut Token (CROF)) created by AgriFintech Financial Technologies Inc. and determining whether the equivalents of 16 additional different Cropto Tokens, created to represent 16 different agricultural products (olive, cotton, rice, soybean, etc.), are held in the company's assets in line with the purpose specified in the first article of the Independent Accountant Financial Consultancy and Certified Public Accountant Law No. 3568.



Our Proof of Reserve audit was referenced by the Independent Auditing Standards ("BDSs"), which are part of the Turkish Auditing Standards published by the Public Oversight, Accounting and Auditing Standards Authority ("KGK").





It has been determined that the company has fulfilled its tax and declaration obligations.



In cases where there is no necessary clarity on accounting records and documents, necessary information is obtained from the accounting officer.







The Whitepaper document on the website <https://www.cropto.io/>, under Section 6 – What are Cropto Agricultural Tokens?, contains the following statement:

<< Cropto Tokens listed 5-20 rows below are asset-backed Agricultural commodity Tokens, while AgriFintech reserves the right for the relevant Cropto Tokens listed 5-20 rows below to display the assets in its bank and crypto asset accounts as the underlying asset for the relevant Cropto Tokens in the amount equivalent to the monetary value of the relevant supply against the risk that the relevant agricultural product may not be supplied from the markets on favorable terms and in a timely manner. Max. supplies of those Cropto Tokens are unlimited as well. >>

The monetary value of the 16 Cropto Tokens, each containing 100 tokens, is approximately between 4500 – 5000 USDT as of the end of December 2025, and this amount has been identified as being held in the crypto accounts of AgriFintech Financial Technologies Inc.

# REASONS FOR THE OPINION ON THE REPORT

1-We completed our audits with on-site audits in four different locations where AgriFintech Financial Technologies Inc. products are stored and protected.

- d) SH Lojistik Depoları, Kerimbey, Mavi Su Sk. No:8, 55330Tekkeköy/Samsun

2-Our inspections have proven the existence of the products of AgriFintech Financial Technologies Inc. in four different locations where they are stored and protected.

3-It has been determined by the invoices that the relevant goods belong to AgriFintech Financial Technologies Inc. together with the authorities in the relevant locations regarding the products belonging to AgriFintech Financial Technologies Inc.

4 -As a result of the inventory count we conducted in four different locations where the products of AgriFintech Financial Technologies Inc. are stored and protected, the physical existence, quantitative accuracy and authenticity of the Wheat, Barley, Corn and Hazelnut products, which constitute the physical basis of the Crypto Tokens (Crypto Wheat Token (CROW), Crypto Barley Token (CROB), Crypto Corn Token (CROC), Crypto Hazelnut Token (CROF)) released by AgriFintech Financial Technologies Inc. have been determined and proven as a result of the measurement and counting made by us.



# **REASONS FOR THE OPINION ON THE REPORT**

- 5- It has been confirmed that the necessary measures have been taken to protect the quality of the products of AgriFintech Financial Technologies Inc.
- 6-The authenticity of the documentary arguments put forward regarding the audit report has been confirmed by the Warehouse Reserve Documents and Invoices.
- 7-The current audit has been completed by adhering to the principles of Honesty, Impartiality, Professional Competence and Care, and Conduct Appropriate to the Profession by complying with the Ethical Rules within the Scope of Independent Auditing Standards.
- 8-When the legal accounting records and legal declarations of AgriFintech Financial Technologies Inc. were examined, it was seen that the relevant documents reflected the truth and complied with the provisions of the legislation.
- 9- Cropto Tokens have been confirmed to be distributed and created on the Polygon blockchain network, which is the Ethereum Layer 2 network.
- 10- Cropto Token addresses have been confirmed with the contracts verified on the blockchain.
- 11- Article 402 of the Turkish Commercial Code (TCC) No. 6102 Pursuant to the fourth paragraph of the Article, it is understood that the bookkeeping order of the Company in the 2025 accounting period is in accordance with the provisions of the law and the company's articles of association regarding financial reporting.
- 12- Article 402 of the TCC. Pursuant to the fourth paragraph of the Article, the Board of Directors has made the requested explanations and provided the requested documents to us within the scope of the audit.



# REASONS FOR THE OPINION ON THE REPORT

When all the documents on which the report is based are examined and the necessary studies are carried out, we give a positive opinion to the Proof of Reserve Audit Report prepared for the determination of the physical existence of Wheat, Barley, Corn and Hazelnut products, which constitute the physical basis of Cropto Tokens (Cropto Wheat Token (CROW), Cropto Barley Token (CROB), Cropto Corn Token (CROC), Cropto Hazelnut Token (CROF)) created by AgriFintech Financial Technologies Inc.

We believe that the audit evidence obtained by us during the audit constitutes a sufficient and appropriate basis for the formation of our opinion.

As a result of the physical inspections, it has been determined that the products that make up the Cropto Tokens (Cropto Wheat Token (CROW), Cropto Barley Token (CROB), Cropto Corn Token (CROC), Cropto Hazelnut Token (CROF)) released by AgriFintech Financial Technologies Inc. are available in the specified amounts in the specific warehouses as a result of the physical inspections carried out by us. It was also determined that the monetary equivalent of 100 units of each Cropto Token Types created for each of the other 16 different agricultural products is held in the crypto asset accounts of AgriFintech Financial Technologies Inc.

1,001,000 Kg of physical products underlying relevant Cropto Tokens has been determined that it is one million one kilogram.

Based on the amounts of the relevant Cropto Tokens created on the blockchain network, the quantities of total physical products are greater than the relevant Cropto Token amounts. It has been confirmed that.

Since there is no physical change in quantity or quality in the products mentioned in this report for the Year 2025 compared to the previous 2024-4rd Quarter, the minutes and the documents for the previous period maintain their validity and authenticity.


