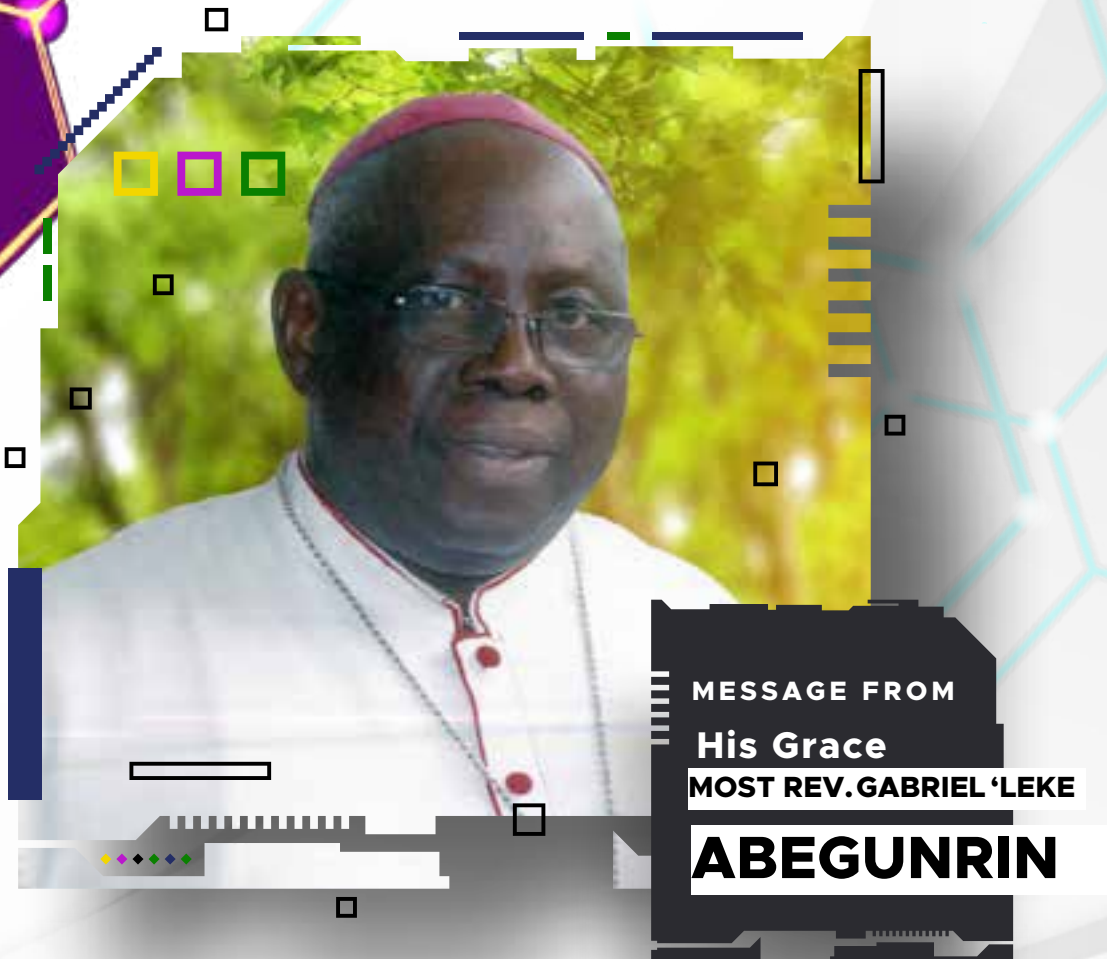
HIS HOLINESS POPE FRANCIS

Today the path of peace, which Saint Paul VI called by the new name of integral development, remains sadly distant from the real lives of many men and women and thus from our human family, which is now entirely interconnected. Despite numerous efforts aimed at constructive dialogue between nations, the deafening noise of war and conflict is intensifying. While diseases of pandemic proportions are spreading, the effects of climate change and environmental degradation are worsening, the tragedy of hunger and thirst is increasing, and an economic model based on individualism rather than on solidarity sharing continues to prevail. As in the days of the prophets of old, so in our own day the cry of the poor and the cry of the earth constantly make themselves heard, pleading for justice and peace.

In every age, peace is both a gift from on high and the fruit of a shared commitment... each one of us can work together to build a more peaceful world, starting from the hearts of individuals and relationships in the family, then within society and with the environment, and all the way up to relationships between peoples and nations.

I wish to propose three paths for building a lasting peace. First, dialogue between generations as the basis for the realization of shared projects. I continue to remember the victims and their families in my prayers.

To government leaders and to all those charged with political and social responsibilities, to priests and pastoral workers, and to all men and women of good will, I make this appeal: let us walk together with courage and creativity on the path of intergenerational dialogue, education, and work. May more and more men and women strive daily, with quiet humility and courage, to be artisans of peace. And may they be ever inspired and accompanied by the blessings of the God of peace!



The starting point, the core and end point of the Catholic Church's social teaching is the dignity of the human person. This teaching emphasizes that we all are created in the image of God and therefore have inherent dignity and worth. This dignity is not based on a person's race, gender, social status, or any other external factor.

For this reason, every person has fundamental rights that must be respected, defended and protected. Beyond this, the human person, especially the poor and underprivileged among us, must be supported and assisted. To this effect, the Church emphasizes the importance of the common good, redistributive justice and the well-being of all.

Notably, this is Christ's mandate; the care of all, especially the least among us. The actions of Christ in the Gospels showed his concern to raise poor humanity from its lowly state to its proper dignity. It is with great joy and delight that I present the annual report of the Justice, Development and Peace Commission (JDPC) Ibadan for the year 2022. The year happened to be a unique one, as the ground work for the General Election for 2023 is ongoing. Both the political parties and the citizens were in high spirit in anticipation for the contest towards a new Government. JDPC, Ibadan played very prominent role in awakening the consciousness of the people of Oyo State towards their civic responsibility with particular reference to active participation in the forth coming electioneering process.

The impact of JDPC was greatly felt in the State and its environs through her many programmes and interventions. The Democracy and Human Rights programme (DHRP) among other achievements continue to train paralegals to be able to administer a first aid 'justice' in their local communities. These efforts of the paralegals have helped in restoring peace in situations that ordinarily could have led to long hours in police custody or an expensive and long court case.

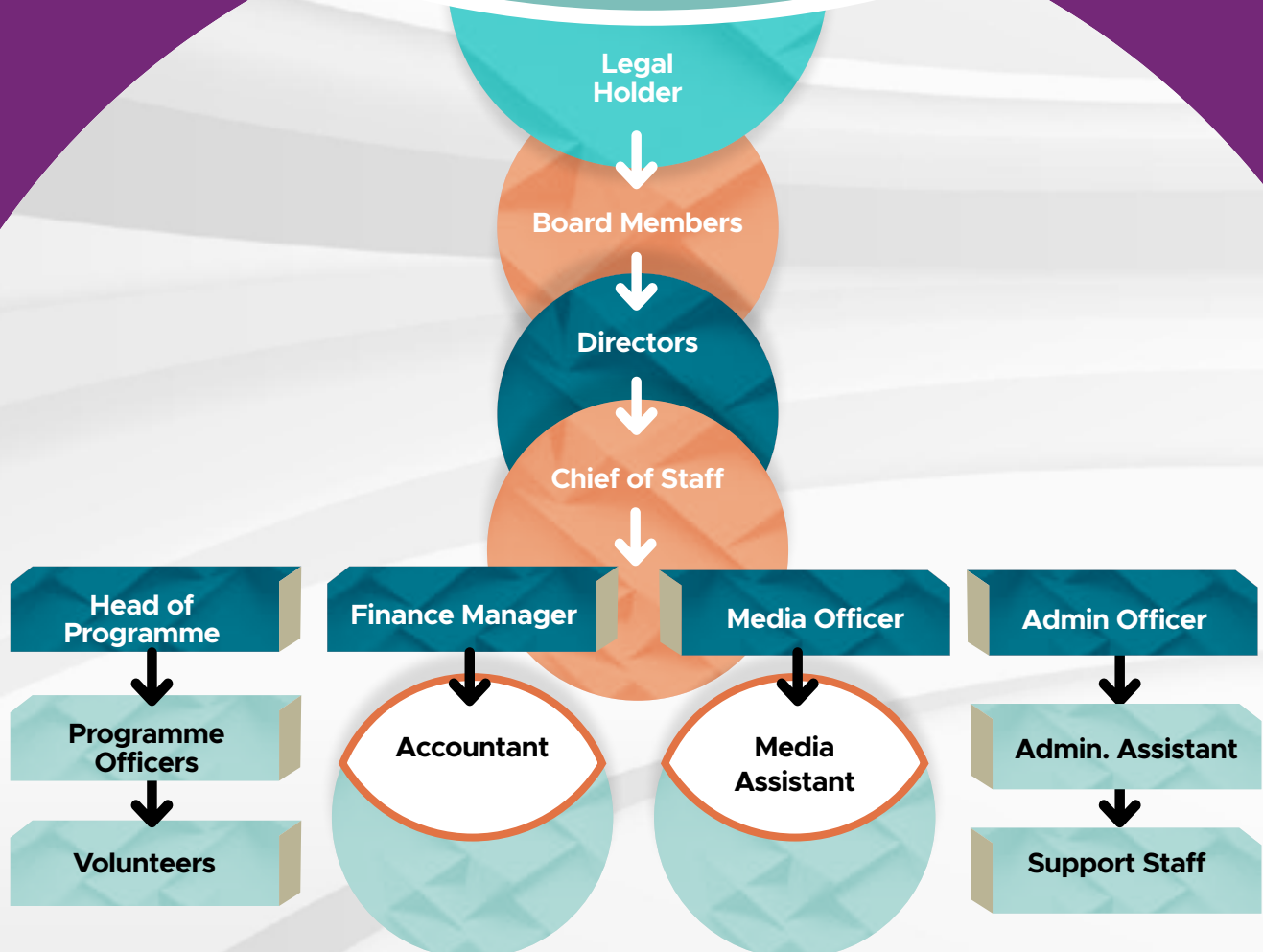
The Commission also made great strides during the year through the various civil coalition groups in holding duty bearers accountable with regards to better primary health care service delivery in communities. As a result of capacity building offered, People living with disabilities are more conscious than ever about their rights as members of the community. The growing population of our correctional centers have been stemmed by our success with the Community Service as Alternative to Imprisonment Programme. Over 900 minor offenders who could have been added to the numbers in Abolongo and Agodi Custodial Centers have been granted community service. We have continued to provide free legal services to indigent inmates awaiting trials and these efforts have been greatly rewarded with the reintegration of several inmates with their families. Our Caritas programme embarked on sensitization and awareness creation on the dangers and ills of Human Trafficking in Oyo State. In the course of the year, they also embarked on awareness creation on the need to protect the environment. These efforts would not have been possible without the support of Miseen Cara and Conrad Hilton Sisters through the Religious Sisters of Charity.

In our world today, the effect of climate change and global warming cannot be overemphasized. These effects can be felt in food production by the farmers as the climate continues to be unpredictable, thus disrupting the normal planting circle that farmers have been accustomed to. However the Integrated Development Programme (IDP) of JDPC, Ibadan have continued to build the capacity of farmers on best agricultural practices to mitigate these problems and produce fresh and organic food healthy for human consumption. The IDP has also made deliberate and conscious efforts to facilitate peaceful coexistence between the Fulani cattle herders and the local farmers in our ecclesiastical jurisdiction.

I am greatly humbled by the impact of JDPC, Ibadan is making in Oyo State and beyond through the various programmes. The successes recorded this year as highlighted in this report would be impossible without the contribution of our partners, active participation of our stakeholders and my ever diligent Members of Staff who sacrifice their time, energy and even their lives in the cause of discharging their duties.

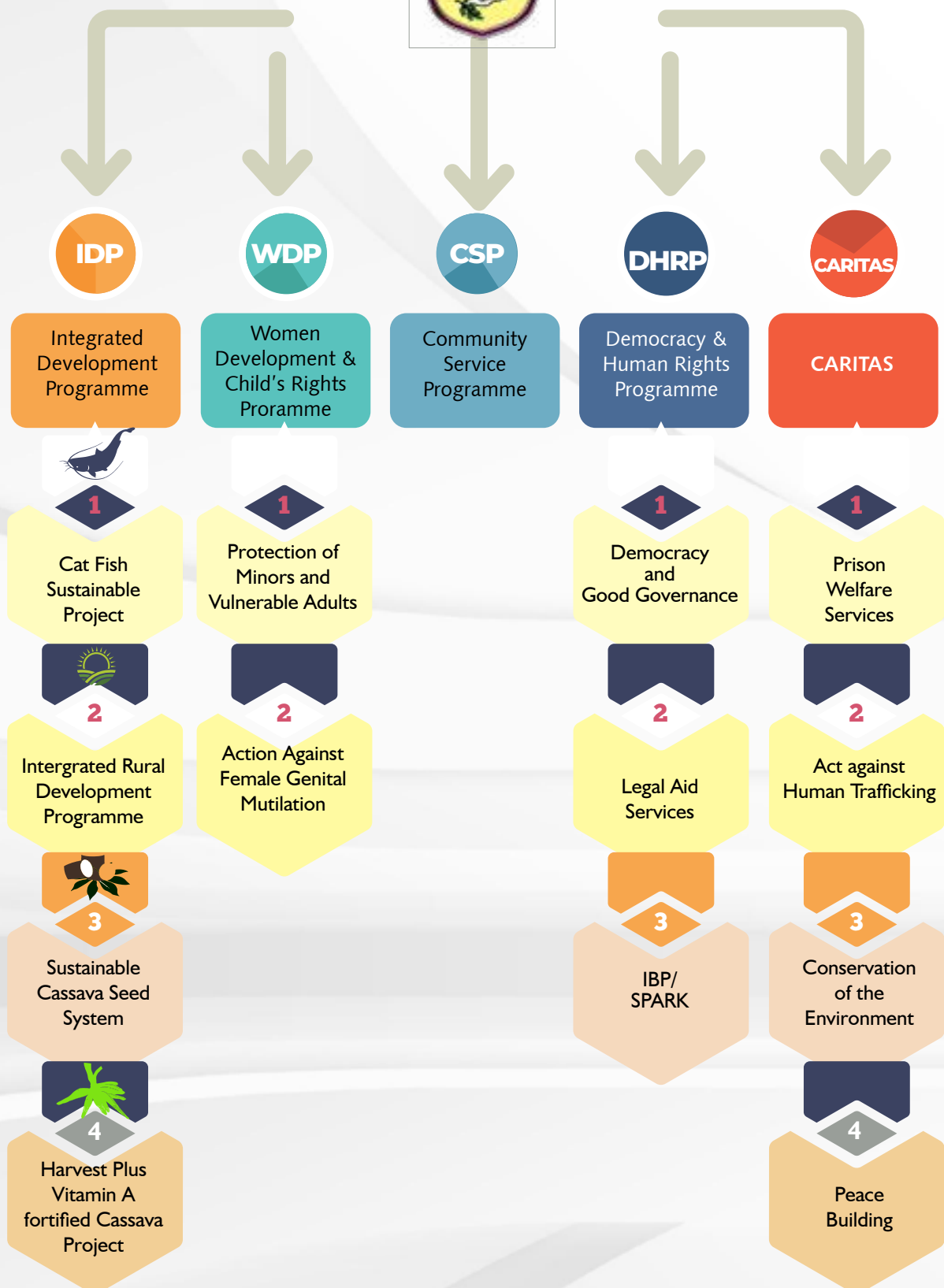

IDP Engages Youths in Agricultural Value chain



Twenty –three (23) youths have been successfully engaged into the Youth in Agriculture Initiative. The initiative of the JDPC is targeted at unemployed youths with the aim of creating employment, sustaining food security and promotion of agribusiness in the catholic archdiocese of Ibadan. The engaged youths were taken through series of capacity development in the chosen area of agribusiness, supported with technical backstopping by the programme and identified mentors and resource support.



In 2014, Mrs. Seun Ogundele, a young woman whose business background was in fashion designing, returned from Abuja. Against her expectation, her fashion design business was badly affected as it could not be sustained because of her relocation.



In 2019, through her landlady who is a catfish farmer, she became interested in aquaculture business after several visits to her landlady's farm. Oluwaseun was fascinated with the swimming rhythm of the fingerlings in the pond. This aroused her interest in aquaculture. However, with limited resources, she started the aquaculture business. Though, it was tough for her to start because of the limited resources at her disposal.



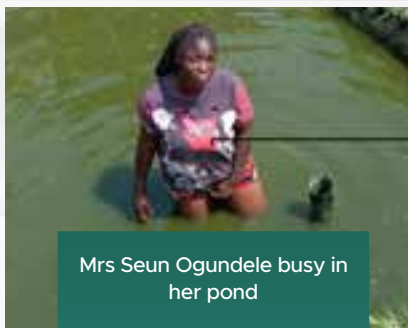
Oluwaseun joined the YIA (Youth in Agriculture Initiative) in 2019, and went through the necessary training and mentorship programme. Immediately after the training and mentorship program, Oluwaseun rented an earthen pond and stocked one thousand (1000) fingerlings. At the early stage of the first cycle, her inexperience in aquaculture made her to experience high mortality rate. But, her doggedness and passion enabled her reinvested in the business with adequate mentorship and supervision.

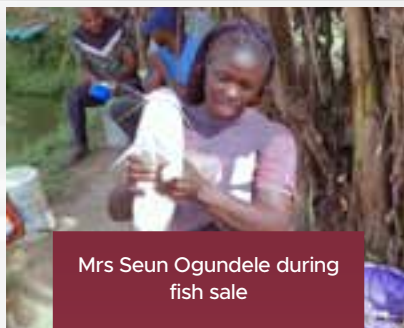

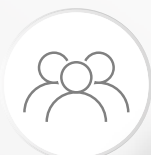

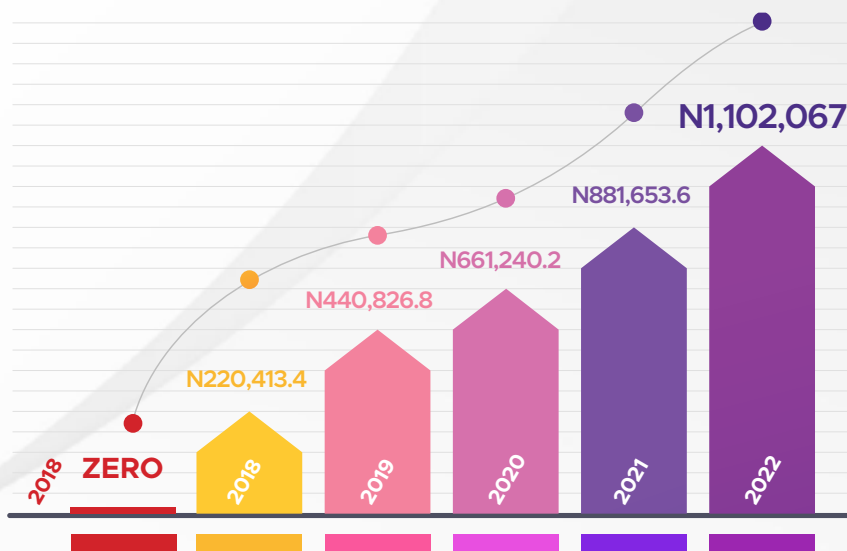


Raising Capital Base

Sustainable farmers' Association Raises CAPITAL BASE



The Apex farmers group of the Sustainable farmers Association of Nigeria (SUFAN), facilitated by Justice Development and Peace, commission, Ibadan has raised its capital base from zero level in 2018 to One million, one hundred and two thousand, sixty-seven Naira (N1,102,067) in 2022.



This development has empowered the association to commence credit advancement to her zonal members for agricultural activities.

AGRO SERVICE

This is an initiative which was birth as a result of the series of capacity building and planning initiatives facilitated by the Integrated Development Programme to ensure agro service delivery by the farmers to members and non members.



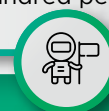
CREDIT INSTITUTIONS

Farmers in the past have complained about the inaccessibility of credit from credit institutions, because of the unending bureaucracy and the inability to provide the necessary collateral securities.



AGRO SERVICE

The organized farmers group started building its capital base from zero level so as to commence agro service delivery in 2018 through zonal investment. The capital received over the years was invested in agricultural produce marketing, provision of agricultural inputs such as seeds, simple farm tools, agrochemicals and sprayers to members and non members. The group has been able to reach more than three hundred people.

The Apex SUFAN group commenced credit facilities in 2021 with the Sum of hundred thousand Naira (N100, 000) and has increased the facility to two hundred thousand per zone in 2022.

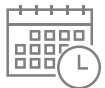

INCREASE SCOPE OF PRODUCTION

Catfish Farmers Increases Scope Of Production From 1,000 Fishes To 4,000 Fishes



One thousand, two hundred (1200) small scale catfish farmers in Oyo, Osun and Ogun states of Nigeria under the Catfish Sustainability Project funded by Skretting Nigeria Limited have had their productivity improved. The farmers who are formed into different groups were supported with capacity development, technical and advisory services and input supply (catfish revolving feed input) to boost production.

Two farmers, Messers Akintayo Solomon Oluremi and M.O. Adewunmi belonging to the Obalagbe fish farmers group, Ayegun - Olomi Ibadan increased their scope of production from one thousand (1000) fishes to four thousand fishes (4000)



FARMERS EXPERIENCE

Messers Akintayo Solomon Oluremi and M. O. Adewunmi of Obalagbe fish farmers group have been in catfish farming business for more than a decade and practicing the conventional fish farming, with little or no regard for the environment, quality of fish produced and record keeping.



2021 MOBILIZATION

In 2016, they were sensitized about the catfish sustainability project. Though, they were of the opinion that adopting best management practices is unrealistic and not profitable. Following the success recorded by other farmers' groups in the project, they were encouraged and mobilized into the project in 2021.



STOCKING THE POND

In the second half of 2021, the duo stocked their earthen pond with one thousand fish (1000) each, adopting the best management practices (proper planning, feed and feeding techniques, sorting, water management etc) championed by the catfish sustainability project.



They were adopted into the mainstream of the project where they received the necessary capacity development, advisory services, monitoring and feed revolving input for better productivity.

Integrated Pest Management

Ninety-three (93) Farmers adopts “IPM” for environmental sustainability



Ninety-three farmers out of the two hundred and ten (210) trained farmers under the sustainable farmers association (SUFAN) have adopted the use of local herbs and botanicals rather than the synthetic agrochemicals to promote environmental sustainability.

Following the capacity building programme on Integrated Pest Management (IPM) organized by the Integrated Development Programme, there was a demonstration of the use of the local herbs and botanicals carried out at different farmers group meetings. Farmers who showed interest in the adoption of IPM were closely monitored for proper application and usage.

This innovation aims at producing neat and safe food for public consumption and to guard against food insecurity that often results in loss incurred by the farmers caused by pest and diseases. Recently, farmers have been experiencing the infestation of pests and diseases on their cocoa and cowpea farms which has resulted into yield and income reduction.

After the demonstration of the “IPM” to farmers, Mr. Ojediran Abiodun resolved to the use of local herbs and botanicals as recommended by the integrated Development programme. After the application on his farm, he testified to the potency of the organic pesticide on black pod disease of cocoa and aphids in cowpea.

Mr. Ojediran Abiodun, a 52 year old farmer of Elere Adeogun community has been practicing Agriculture alongside his Father since he was a boy. He is a farmer that cultivate crops such as; cocoa , citrus , cassava, yam, maize and cowpea.



BOTANICAL USAGE



Using the botanical did not only reduce his cost of production by forty percent (40%), it also promotes safe environment, biodiversity and reduced toxicity caused by the use of synthetic pesticide to ensure safe food.



Mr. Ojediran Abiodun through his testimony and results, has also influenced member of his group Agbelere farmers' group at Elere Adeogun to make use of “IPM” on their farms.



The National Association of Organic Agriculture (NOAN) is looking to collaborate with the farmers' group for Organic Cocoa production.

Advocacy And Disability Law

Advocacy Propels The Passage Of The People With Disability Law 2022, In Oyo State



The people with disability bill has been passed to law by the Oyo state House of Assembly on the 21st day of August, 2022. This was partly due to the advocacy championed by the representatives of the people with disabilities engineered by Justice Development and Peace Commission, Ibadan.

To speed up the passage of the bill into law, several advocacy visits were made to the Chairman, House Committee on Women Affairs and Social Inclusion, Hon. Wunmi Oladeji, The Speaker, Oyo State House of Assembly, Rt. Hon. Adebo Ogundoyin, the Attorney General and Commissioner for Justice, Professor Oyelowo Oyewo SAN and the Executive Assistant to the Governor on Disability matters, Ayodele Adekanmbi Esq.

To strengthen the advocacy, we facilitated four (4) media advocacy using the Radio. Representatives of the people with disability spoke on the following radio stations, Naija 102.7 FM, Splash 105.5FM, 32 FM (94.9FM) and Impact Business Radio (IBR) 92.5FM to sustain the advocacy effort for a speedy passage of the bill into law.



AWARDS

JDPC, Ibadan Bags Two Awards From The Dissability Community



Justice Development and Peace Commission, Ibadan received a Humanitarian Service Award and a merit award from the Oyo State Government/Community of People living with Disabilities in Oyo state and the National Association of the Blind, Oyo state Chapter respectively.

The Humanitarian Service Award was presented on behalf of the Oyo state government and the Community of people living with disabilities by the Executive Assistant to the Oyo State Governor on Disability, Ayodele Adekanmbi Esq on the 3rd of December, 2022 during the commemoration of the International day of People with Disabilities.

On the 15th of October, 2022, the organization received the Merit Award from the National Association of the Blind, Oyo State Chapter in Ogbomosho during the annual celebration of the International day of White Cane.

Community Paralegals

Community Paralegals Resolve 132 Cases In 12 Months



In Twelve (12) months, One hundred and thirty-two (132) cases have been resolved by the community paralegals trained by Justice Development and Peace Commission, Ibadan. This is in the bid of making Justice closer and more accessible in communities in Oyo State.

In 2022

JDPC, Ibadan trained thirty-two (32) new Community Paralegals. The paralegals are to give simple first aid legal advice to indigents in the community either before their matter gets to court or in places where the courts are far from the people.

They also make referrals to relevant agency of government of lawyers and organizations. These community paralegals comprises of 24 persons in Ibadan and 8 persons in Oyo Town. These 32 paralegals have joined the existing 35 earlier trained in 2019.

This program is aimed at increasing access to justice in communities; the paralegals are able to intervene and resolve simple conflicts as individuals and as a team. Complex cases or disputes and those with criminal incidents are referred to the law enforcement agents, other organizations and lawyers as the case may be.



The course module for training the paralegals include; Debt Recovery, Land lord and Tenancy, Land transactions, Alternative Dispute Resolution, Consumers Right, Electricity Law, Disability Law, criminal Law, Civil Law, Powers of the Police, e.t.c.



The paralegals are also filling the information gap that exists among the people by carrying out regular public enlightenment in their various communities to reduce ignorance among the people and prevent abuse of rights.

To further enhance their work and knowledge, the paralegals went on a learning and exchange visit to Justice Empowerment initiative (JEI), Lagos to learn from other paralegals on subjects like Land and Eviction, Security, Sexual and Gender Based Violence, Police cases, Land grabbers, work in rural communities and attacks on informal livelihood.

Human Rights

One Hundred And Ten Inmates Of Agodi Custodial Centre Gets Their Cases Fast Tracked



One hundred and Ten cases of awaiting trial inmates at the Agodi Custodial Centre have been fast tracked by Justice, Development and Peace Commission, Ibadan. This is carried in partnership with other legal aid providers like; Legal Aid Council of Nigeria, Citizens Gavel, Nigerian Bar Association. This is in the bid to contribute to the decongestion at the correctional facility.

Using the list of inmates pending at the Agodi Custodial centre Ibadan the Coalition visited the inmates and had one on one conversation with the inmates so as to know the situation of their cases and there were visits to the courts where these cases are pending; the required legal intervention was then taken. From this exercise defendants who had no legal representation had their cases taken up by JDPC, Citizens Gavel, and Legal Aid Council of Nigeria. Applications for striking out have been filled in courts, while three people have been released from custody after many years awaiting trial.

LAP Legal Aid Providers

JDPC, Forms Coaliton Of Legal Aid Providers



As part of her efforts in making the Administration of criminal Justice Law of Oyo state 2016 more effective and to decongest the Agodi correctional Centre, JDPC forms the Coalition of Legal providers in the state.

The Coalition of legal Aid Providers is the umbrella body of all organizations working on legal Aid in the state. The member organizations are Legal Aid Council of Nigeria, Human Right Committee of the Nigerian Bar Association, Citizens Gavel and JDPC Ibadan.

The essence of the coalition is to discuss issues strictly pertaining to Legal Aid of inmates in the prisons, coordination of legal Aid for inmates and recommendation of inmates for pardon by the Chief Judge.

The Coalition has made several visits to the Agodi correctional centre and has taken up the cases of inmates to represents them in court.

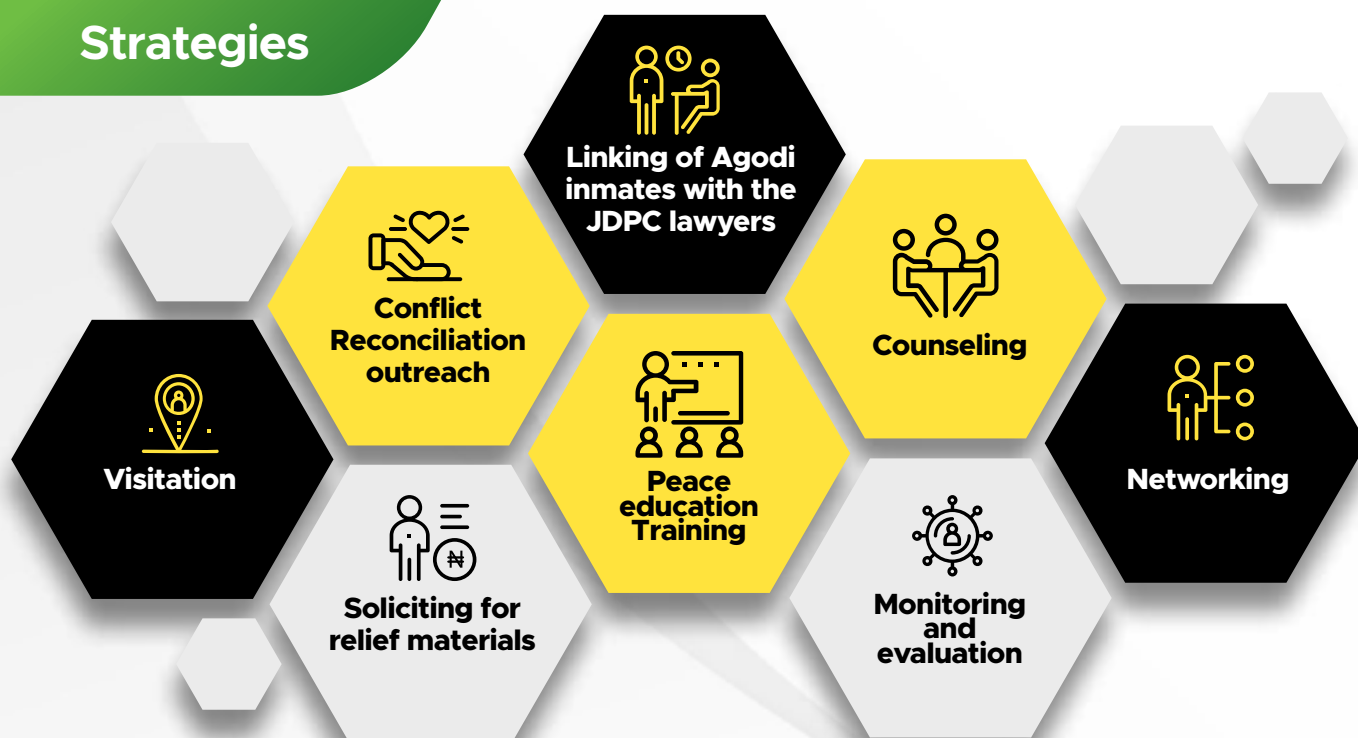

Agodi Inmates' Welfare

The CARITAS service delivery to the inmates of the Agodi Custodial Centre during the year 2022 was with no sense of complacency, unrelenting and impactful. The impacts include the following:

+ **Spiritual Renewal**

The inmates had the opportunity of some spiritual renewal through our encounter with them during the year as seen below;

// The celebration of the Mass on Ash Wednesday marked the

beginning of lent. It was an enriching experience for the inmates who attended the Holy Mass. It equally marked the official reopening of the Agodi Custodial Centre for spiritual services; after it had been on hold since the 2020 COVID 19 lockdown.

// Subsequently, the inmates had Stations of the Cross; it was a moment of deep reflection on the passions of the Lord and a call to repentance.

// Spiritual upliftment during Eucharistic Celebration took place on 17th April, and every Sunday

General Welfare of the inmates

We provided some of the basic needs of 345 inmates, through the financial and material support of some generous individuals and groups.

+ Inmates' Linkages

We were able to keep some inmates connected with their families, friends and lawyers. The linkages were as follows:

// We kept 194 inmates connected with their family, friends, and lawyers.

// 122 inmates' families and friends visited them in Agodi Custodial Centre. Given the challenges of communication between the inmates and their families and friends, the linkage meant a lot for the inmates, so they do not take it for granted.

// The Christmas party for 1076 inmates and 200 staff of Agodi

// The initiation of the formation of the JDPC friends and partners was a key event that coloured the fund raising for the inmates Christmas party. The number of those who indicated to become friends and partner of JDPC was amazing.

+ Collaboration: Inmate's Welfare

We appreciate the efforts of individuals and groups who collaborated with us to meet the welfare needs of the inmates. They include; (a) Fr. Wilfred Kouijzer SMA and his brothers and Fr. Ifeanyi CSsR, Fr. Kingsley Okereke, Schoenstart Priest who were always available and officiated the Eucharistic celebrations for the inmates. (b) The Prison Fellowship of Nigeria PFN whose intervention has aided the release of some inmates.

Assistance of Indigent Persons

- We appreciate the support of some individuals and groups who assisted us financially and materially to reach out to 170 indigent persons during the year 2022. They include: The Society of African Mission(SMA) Priests Bodija, Parishioners of St. Patrick Catholic Church, Basorun, SS Peter & Paul Major Seminary Bodija, The Religious Sisters of Charity (RSC), the Catholic Women Organization from Our Lady Seat of Wisdom Catholic Church, University of Ibadan and Church of Ascension Bodija, St. Anthony's Guild, Dr. Mrs. Baiser, Mrs. Ani, Youths of the North Deanery, Mother Mary's Youth (Odiiche) Pro Labore Dei, Fr. Eugene Egbe, JDPC Staff and some anonymous donors

- It is pertinent to note that one of the indigents, now has her own shop, and is doing very well in the business we assisted her to set up.

JUSTICE DEVELOPMENT AND PEACE COMMITTEE IN PARISH (JDPC-P)

The inauguration of 181 JDPC-P promoters from 27 parishes on 2nd October, 2022 was the culmination of the JDPC-P awareness campaign in parishes and formation training of the promoters. The promoters through the training were equipped with all the skills needed for taking up issues of Justice, development and peace in Catholic Archdiocese of Ibadan and beyond. The cases below were successfully handled by the promoters.

- Case work intervention of an abducted child from Togo who was exposed to forced labour without

pay. The JDPC promoters from St. Leos Catholic church Orita Challenge handled the case. They made all the necessary requirements, including some paper work, tracing of her family and subsequently sent her back to her family who thought she was dead.

- Case work intervention in the case of a 10 years old child who was abused by a 46 years old man. The child was taken for medical checkup. The case was reported to the police and other necessary actions have been taken.

- Family Conflict Intervention: Among the family conflict reconciliations conducted during the year 2022, one family has moved beyond their unhealthy rancor because they are better equipped to handle conflicts positively. In her words, "things are much better now than before."

The election and voter education saw a new dimension as the JDPC-P St. Anthony Igboora, took the awareness campaign to the radio, by producing and airing election jingles. The airing of radio jingles was a useful means of getting the message closer to the people.

AWARENESS CAMPAIGN AGAINST HUMAN TRAFFICKING IN OYO STATE

The message of the evil of human trafficking reached the wider population in Oyo State, specifically targeted at eleven Local Government Areas (LGA). They are: Ona Ara, Oluyole, Ibadan North, Ibadan South East, Akinyele, Ogbomoso North, Ibarapa Central, Ibarapa North, Lagelu, Saki West and Atisbo.

+ Consultative visits and meeting

We consulted and had meetings with 288 key stakeholders, the gate keepers in the 11 LGAs, (including people living with disability) which made the awareness creation in the LGAs achievable. Gaining access into the community was much easier through their support.

+ Networking and collaboration

This strategy was adopted as a sure way of breaking the strong chain of human traffickers' network. Hence, we keenly visited and collaborated with the following agencies of the project: Ministry of Women Affairs and Social Inclusion (MWA), National Agency for prohibition of trafficking in persons (NAPTIP), the Nigerian Police Force, Ministry of Education, Nigeria Immigration Services (NIS), the National Human Rights Commission (NHRC), the Nigeria Security and Civil Defence Corps (NSCDC). We appreciate their support thus far.

+ Training of Trainers

202 participants from the 11 LGAs were trained on the issues of human trafficking. The training took place in

four batches, one at Ibarapa central and North. Two batches in JDPC Ibadan and one in Atisbo. Out of the 202 participants, 179 of them stepped down the training in their communities. We are hopeful that with the knowledge gained from the training, the awareness on the issues of human trafficking will widely spread among the Oyo populace and yield a positive result

+ **Market and street rallies**

The participants of the training of trainers together with JDPC staff took the awareness campaign to the following markets; Saki West market, Ojo market, Igboora main market, Bodija market and Oja Oba Market. Thus, reaching the people at the grassroots.

+ **Other Networking / Collaboration**

// It was a good experience to be part of those that drafted the action plan for the Oyo State Taskforce on human trafficking in April, 2022. Hopefully, the plan when fully utilized will help reduce the incidences of human trafficking in Oyo State.

// We participated at a training on Smuggling of Migrants organized by Nigeria Immigration Service on 10th November, 2022. It was a crucial learning experience for our Human trafficking project.

// Working very closely with Mr. Augustine Akanya, the Coordinator of the National Agency for the Prohibition of Trafficking in Person (NAPTIP) Oyo State, Pastor Marcus Williams, the Chairman of Oyo State Rapid response Team on gender base violence, the Nigeria Immigration Services, the Nigeria Security and Civil Defence Corp and the Nigeria police and Oluwakemi Ademola-Aremu (Comrade Kaytee) in the implementation of the Human Trafficking awareness campaign was a worthwhile experience.

WOMEN ENVIRONMENTAL AND CLIMATE CHANGE PROJECT

The promotion and care of the environment was of paramount importance to us. Hence, we took the Women Environmental and Climate Change Project to Ibarapa North. The goal of the project was to ensure an enhanced and sustainable environment for social, economic and holistic well-being of the inhabitants of Ibarapa North.

We adopted two strategies,

The Participants were enlightened on the need to adopt proper waste management strategies, smart farming, how to deal with Health and environmental issues and the use of alternative energy devices. We trust that the participants will make good use of the lessons learnt and that they will train others. We therefore, look forward to a healthier and cleaner environment in the area.

OTHER OUTSTANDING HIGHLIGHTS OF CARITAS PROGRAMME INCLUDE THE FOLLOWING:

- We made our presence felt at the Ibadan Archdiocesan Synod of Synodality Meeting, attended by participants from across the 53 parishes in the archdiocese on 3rd March 2022. The Synod on Synodality is a crucial event in the life of the church that encourages listening, dialoguing, and participation in a way that promotes God's Kingdom. The expected result is that concrete actions are taken following the harvest from listening and dialoguing together. We seized the opportunity to emphasize the need for parishes to have the Justice, Development and Peace Committee (JDPC-P) functioning in their parishes because JDPC is a sure concrete action part of the fruits of the synod of synodality.

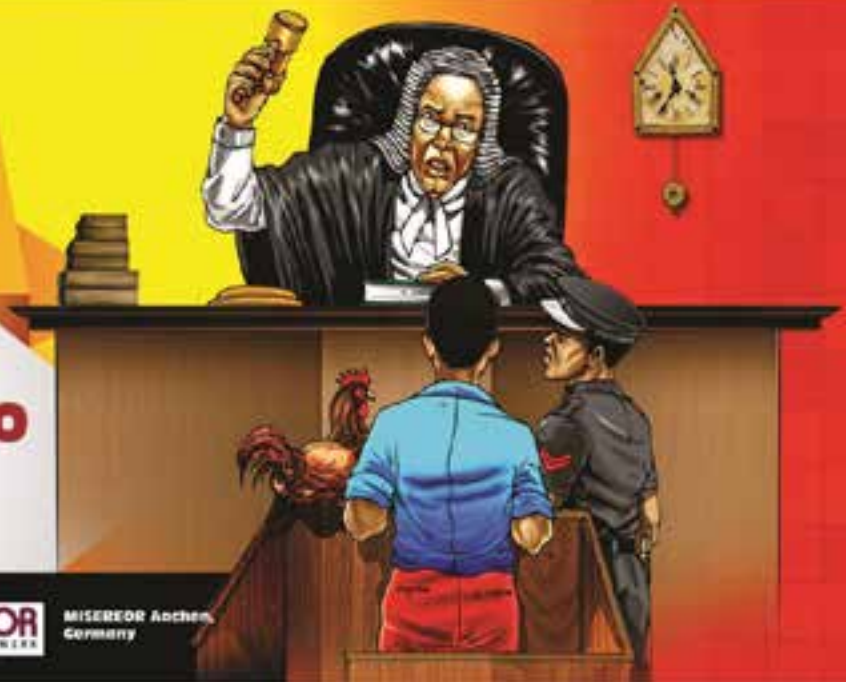

The Community Service as an Alternative to imprisonment programme of The Justice, Development and Peace Commission (JDPC) Ibadan is focused on improving the efficiency, effectiveness and humaneness of Nigeria's criminal justice system by promoting community service as an alternative form of punishment for minor offences as opposed to incarceration.

The programme which commenced in 2012 was created as a result of the need to contribute to the decongestion of Prisons (Now known as correctional centers) in Oyo State. This is achieved with the help of MISEREOR as its major funding donor.

952 Offenders Undergo Non-Custodial Sentencing



Nine hundred and fifty-two (952) offenders of minor offences have been sentenced to community service across all the magisterial districts in the state in the last four years. This has considerably stemmed the influx of offenders sentenced to prison custody upon conviction; thus, resulting in reduction of prison congestion. In other words, the aforementioned 952 offenders would have contributed to the congestion of Agodi and Abolongo Correctional Centres if there was no option of community service punishment.

Inauguration Of Psychosocial Support Group (Psg) For Community Service in Oyo State



The community service team of JDPC Ibadan inaugurated a psycho social support group (PSG) that provides counseling to the offenders who undergo the community service punishment.

The group which was inaugurated at the JDPC, Ibadan office consists of Counseling Association of Nigeria (CASSON) Oyo State Chapter, Nigerian Correctional Service (Oyo State Command), The Oyo State Judiciary, Department of Social Welfare (Ministry of Women Affairs), ASIDO Foundation (A mental health organization) and JDPC Ibadan.

This group meets bi-annually to deliberate on the impact of the counseling on offenders, the challenges faced by the counselors and how to improve the counseling services rendered to offenders.

311 Offenders Receive Counselling



Three hundred and eleven (311) offenders out of the five hundred and twelve (512) offenders sentenced to community service in Oyo State have been counselled.

This was achieved through the collaboration between JDPC Ibadan, Counselling Association of Nigeria (CASSON) Oyo State Chapter and the Oyo State Judiciary.

The offenders who undergo community service punishment are counselled to aid their reformation, rehabilitation and re-integration back into the society and to also, reduce recidivism.

Members of CASSON do regularly visit the counselling centres which have been set up in the various community service units across the State to counsel offenders who undergo community service.

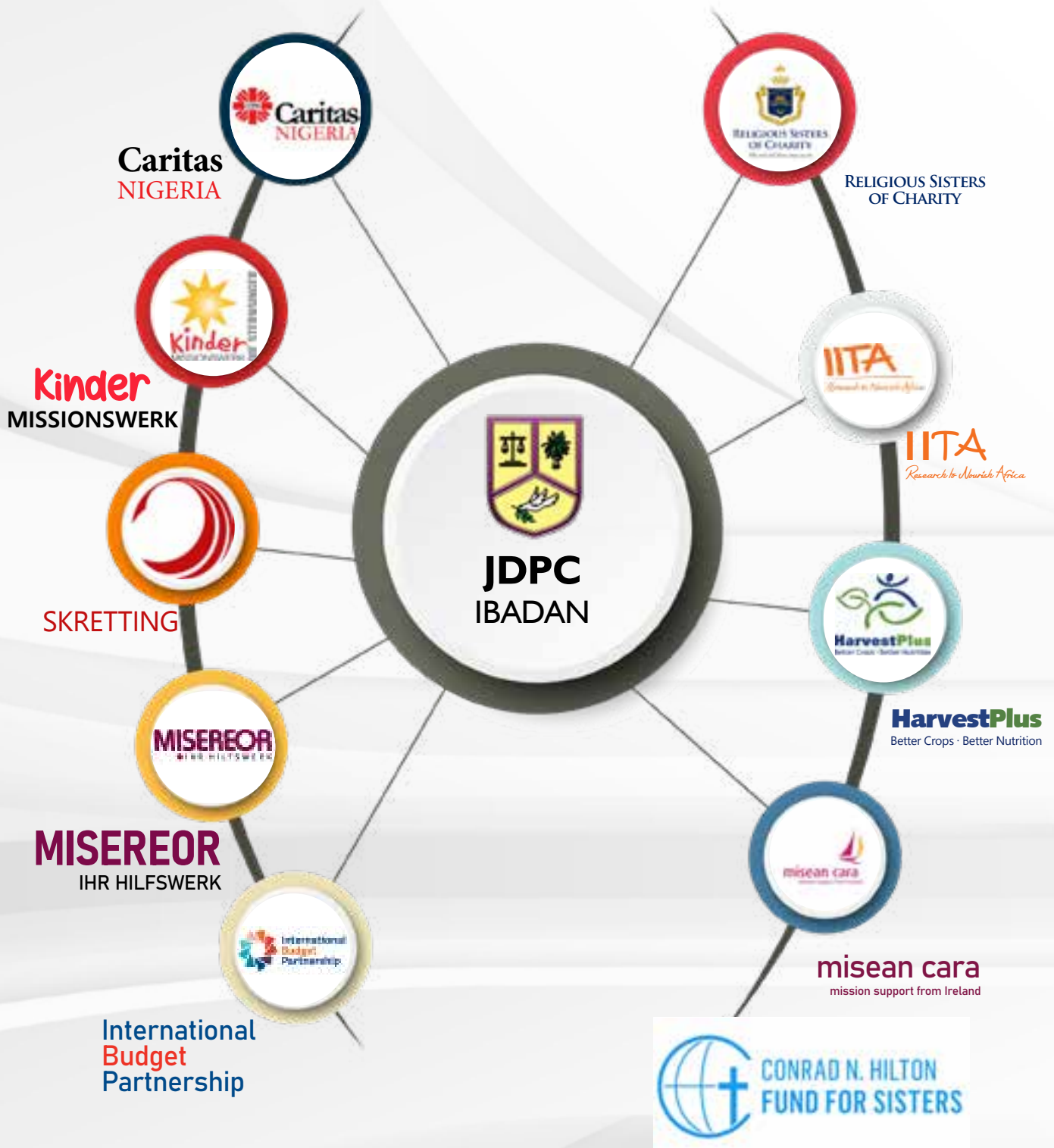

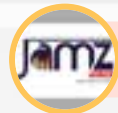

AUDITORS' REPORT TO THE MEMBERS OF JUSTICE, DEVELOPMENT AND PEACE CENTRE

Report on the Audit of the Financial Statements

We have audited the financial statements of Justice, Development and Peace Centre, which comprise the statement of financial position as at 31 December 2022, and the statement of Comprehensive Income and profit or loss, statement of changes in equity and statement of cash flows for the year then ended, and notes, comprising significant accounting policies and other explanatory information, as set out on pages 54 to 61

Opinion

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Centre as at 31 December 2022, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs) and in the manner required by the Companies and Allied Matters Act, 2020 and the Financial Reporting Council of Nigeria Act, 2011.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 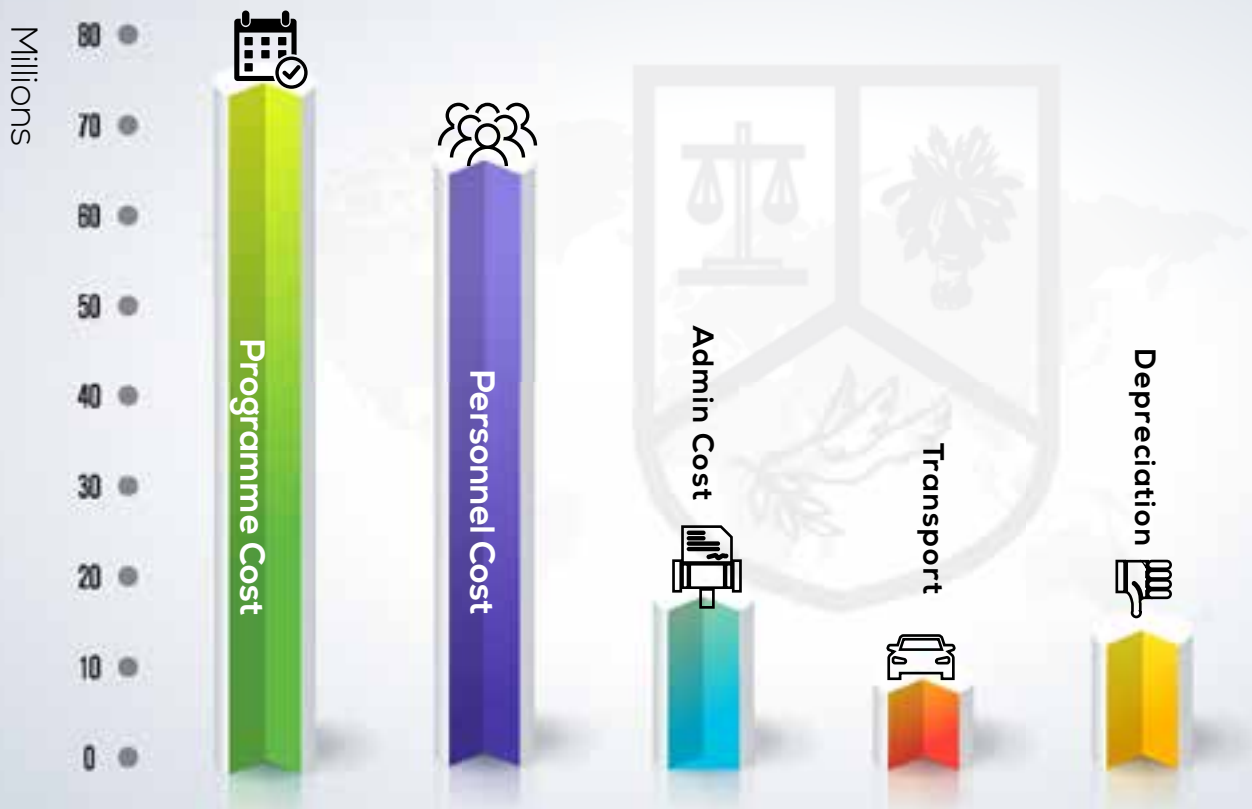

CHART SHOWING 5 YEARS EXPENDITURE TREND

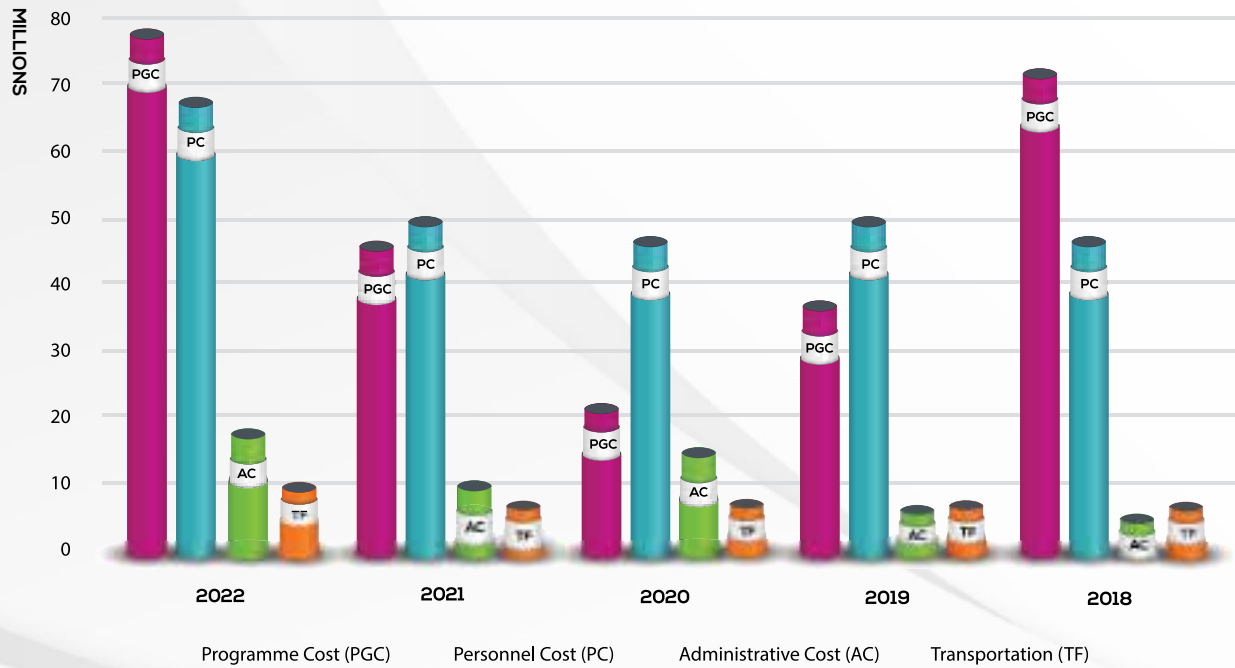
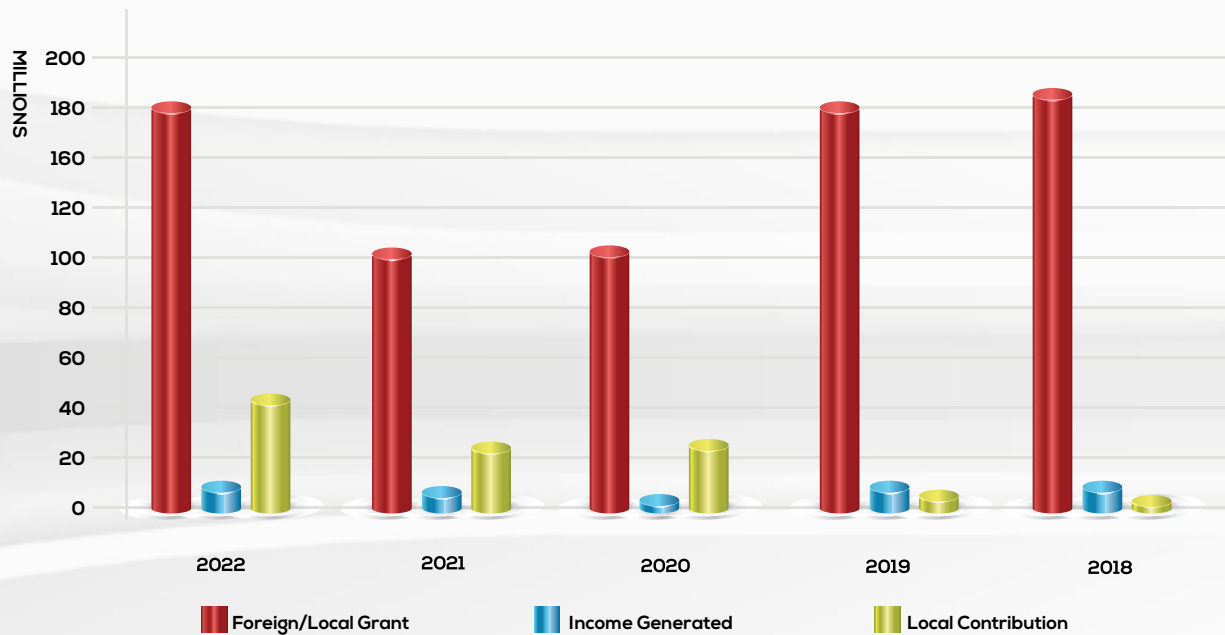


CHART SHOWING 5 YEARS INCOME CONTRIBUTION STATEMENT
