The Role

We are seeking a **Research and Business Development Associate** to join the Trade Policy Hub team. This is a dynamic role that combines business development, project management, and policy research. The successful candidate will play a key role in delivering high-quality consulting and research projects in international trade and sustainable development, supporting the Hub's mission to make trade policy more transparent, inclusive, and effective.

Key Responsibilities

Policy and strategy:

 Scans and feeds insights to support strategy, monitor developments in the external policy and funding landscape (UK, EU, and international) to identify relevant opportunities.

- Contribute intelligence to TPH's business development strategy by scanning for new public and private opportunities.
- Support the development of strategies to grow academic engagement in consultancy.
- Undertake market scoping and research activities to inform business development.
- Monitor relevant public procurement opportunities and contribute to the strategic growth of the Trade Policy Hub's portfolio.
- Contribute to the dissemination of research findings through reports, presentations, and policy briefs.
- Develop collaborations across the School and externally to deliver interdisciplinary opportunities

Business Development:

- Lead and support the development of competitive proposals and bids for traderelated consulting and research projects.
- Identify and develop new business opportunities with public, private, and thirdsector clients.
- Build strong relationships with academics across departments and centres to encourage consulting activity.
- Support the preparation and submission of bids, drafting sections as required and coordinating contributions.
- Contribute to the design of methodologies, budgets, and compliance requirements in proposals.
- Contribute to income targets by generating new consulting opportunities through partnerships, preparing proposals and winning contracts.
- Draft and contribute to sections of technical and methodological proposals.

Project Management:

- Provide project management support for selected projects, including reporting, team coordination, risk monitoring, and budget distribution.
- Act as liaison between project team and clients for assigned projects, ensuring clarity of deliverables and timelines.
- Monitor project progress and escalate challenges where necessary.

- Conduct policy research and analysis on trade-related topics, including core trade policy, trade and sustainable development, digital trade, trade and industrial policy as part of proposal writing.

- A minimum of 3-years demonstrated experience in policy research, consulting, or project management, ideally in the field of international trade, investment, sustainable development or economic policy.
- Ability to develop and tailor offers or initiatives to meet the needs of clients, stakeholders, or target audiences
- Experience supporting the development of new offers and project proposals
- Experience collaborating with interdisciplinary or cross-sector teams
- Qualitative, quantitative or mixed- method research skills (e.g. interviews, documentary analysis, surveys)
- Experience with working in an international environment
- Knowledge of social sciences and experience in policy development or consulting, ideally involving both public and private sector stakeholders.
- Familiarity with procurement processes, contracting, or commissioning of services—whether in public sector, consulting, or other relevant contexts.
- Ability to self-motivate and an ability to work with minimal supervision to prioritise work and meet deadlines.
- Ability to work collaboratively in a fast-paced, interdisciplinary environment.
- Strong understanding of global trade institutions, UK,EU or other national trade policies, industrial policy or development policy.
