## 1 GENERAL

All tariffs are stated in Norwegian kroner (NOK) and exclusive VAT. For information and the terms and conditions, please refer to the document “Commercial Terms and Conditions – Port of Alta - 2026”. In the event of changes to the arrival or departure time less than 24 hours before reported arrival, the vessel must cover any additional costs resulting from such changes. The captain of the vessel or a representative of the vessel must provide notification of arrival to the Port Control before the vessel calls at the port district, preferably no later than 24 hours prior to arrival.

### 3 PAYMENT FOR USE OF INFRASTRUCTURE

#### 3.1 QUAY CHARGES

Different rates apply per vessel category. The minimum amount for quay charges is NOK 300.

### 3.5 CHARGE FOR LAND-BASED TRANSPORT

#### TERMINAL CHARGES

The same rates and rules as stipulated for cargo handling charges apply (See table in Section 3.4 above).

#### CRANE CHARGES

Use of vehicle-mounted crane to load/unload its own vehicle is charged at the same rate per 24-hour period as vehicles over 7.5 t and can only load/unload its own vehicle. Cranes for launching boats, etc. are charged NOK 500 and in such cases the crane company is invoiced along with the vehicle charge (see above).

#### FISHING VESSELS

Fishing vessels that are registered with their home port in Alta, and where the owner's main occupation is registered as a commercial fisherman, pay the same quay charge whether they are moored at one of our marinas or at another quay. They are not required to pay a deposit.

All rates are stated on an annual basis. The width specifications state the minimum width to the maximum width in each category. The deposit amounts apply to agreements entered into after 1 January 2018. Short-term rental at Urnes Bukta Marina costs NOK 200 per 24-hour period when paying by Vipps: #77470. A surcharge applies for invoices.

The rate for electricity at the Post of Alta's marinas is:

- NOK 2,20 + VAT per kWh

## 4 FEES TO COVER COSTS

### 4.1 WASTE DISPOSAL FEE – SHIP WASTE DISPOSAL SERVICES

All vessels must pay a waste disposal fee for each call. Costs related to waste and cargo residues delivered to Finnmark Gjenvinning or Vefas Retur AS or others will be invoiced directly from the recipient. The Port of Alta can administer invoicing for a fee.

Minimum waste disposal fee: NOK 170 per call

Vessels over 100 GT pay NOK 200 per call.

### 4.2 ISPS FEE/SECURITY CHARGE

### 5 SALE OF GOODS AND SERVICES

#### 5.1 WATER SUPPLY TO SHIPS

The minimum rate, which is for 10 m<sup>3</sup>, is NOK 237. Supplies above 10 m<sup>3</sup> cost an additional NOK 33 per m<sup>3</sup>.

A charge equivalent to one hour of labour (NOK 1,025) applies for supplying fresh water during regular working hours. Outside regular working hours, actual costs are incurred.

#### 5.2 SUPPLY OF ELECTRICITY

Supply of electricity: NOK 2 per kWh

Connection of electricity during regular working hours costs NOK 1,025. Outside regular working hours, actual costs are incurred.

#### 5.3 HIRING OF LABOUR

The standard hourly rate is NOK 1,025. Overtime rates apply for inconvenient working hours.

## 6 BOAT SERVICES/EQUIPMENT RENTAL

Work boat rental. The minimum rental period outside regular working hours is two hours. The work boat is not rented out without a skipper. The rental per time up to three hours is NOK 7,175.

When hiring a skipper outside ordinary working hours, the time usage is calculated in accordance with Section 5.3.

Rental of tugboat services must be booked at least two days in advance directly through the tugboat company. Tugboat services are always invoiced directly from the tugboat company to the vessel.

## 7 RENTAL OF LOGISTICS AREAS AND OUTDOOR STORAGE AREAS

The rental rates are stipulated in separate agreements depending on duration, requirements concerning surface and fencing, etc. Refer to Section 3.6.

## 8 ISPS - SECURITY

Security guards for ISPS vessels during port calls are charged to the shipping company at a rate of NOK 1,025 per security guard per hour unless otherwise agreed in advance.

## 9 ENVIRONMENTAL PRICING FOR SHIPS

Environmental Port Index (EPI) has been introduced as an economic incentive to support sustainable and environmentally friendly cruise operations and to make it less profitable for polluting ships to call at ports. EPI is used for all cruise calls and has an impact on the quay charges.

No later than 72 hours after departure, the ship/agent must report data from their call via the EPI portal. The ship will be assigned an EPI score from 0 (worst) to 100 (best) based on the reported data. An EPI score of 0 will lead to an additional 70% being added to the quay charges, while an EPI score of 100 will lead to a discount of 20%.

The quay charge will be subject to a percentage change as follows:

- Ships scoring below 20 will incur an additional charge based on the following formula:  $2 \times (20 - \text{EPI})$
- Ships scoring between 20 – 70 will pay quay charges based on the current tariff.
- Ships scoring above 70 will receive a discount based on the following formula:  $0.5 \times (\text{EPI} - 70)$

If a ship fails to report data within the stipulated deadline, it will be allocated an EPI score of 0 (zero). Ships equipped for shore power will receive a minimum score of 30 points.
