# **Nurse Assistant Certification Program**

#### The Course:

MCC's Nurse Assistant Certification AM Course is a 5-week program, Monday - Friday. On Mon, Tues & Fri is Theory Instruction from 7:00 AM to 3:30 PM. This will consist of lectures in the classroom.

On Wed & Thurs. students report to Clinicals at various times and sites. Students will learn and experience hands-on training skills.

MCC's Nurse Assistant Certification PM Course is a 7-week program, Tue-Thurs

is Theory Instruction from 6PM to 10PM. This will consist of lectures in the classroom.

On Sat & Sun. students report to Clinicals at various times and sites. Students will learn and experience hands-on training skills.

This 160-hour program will train you to provide quality care to residents in long-term care facilities and professional organizations requiring the staffing needs of a Nurse Assistant Certification. It consists of 60-hour Theory and 100 hours of Clinical Practical Training focused on all aspects of residential care on the **Six Principals of Care**.

Upon successfully completing the course of 100 supervised clinical hours and 60 theory /lab hours along with passing the Nurse Assistant Certification course exam you will qualify to take the State Competency Test (CEP to be a Nursing Assistant (NA.

The course is led and oversighted by Licensed Vocational Nurses as secondary instructors. The instructors are approved by the Bureau for Private Postsecondary and Vocational Education, accepted by the California Department of Public Health and certified by the American Red Cross, and meet the State requirements.

# NA 101-Long-Term Care 160 Hours

On completion of this course, the student will meet the California requirements to take the State Certification Exam for Nurse Assistant's. Basic Nursing Theory and skills are taught in the classroom and laboratory setting. Students are supervised in giving care to residents in the long-term care facility (Nursing Home . The focus is on the care of elderly residents. Course content follows the California State approved Nurse Assistant curriculum.

# Nurse Assistant 102 Home Health Aide 40 Hours

Prerequisite - Nurse Assistant 101

This course prepares the Nurse Assistant for certification as a Home Health Aide by DPH. It allows the Home Health Aide to function as an entry-level worker on a health care team in a home health agency. The course is structured to provide knowledge and skills to function as a Home Health Aide.

## Nurse Assistant 103-AcuteCare

116 Hours

Prerequisite - Nurse Assistant 101

After completing Nurse Assistant 101, the student may take Nurse Assistant 103, which builds on the skills learned in longterm care. The focus is on the care of the patient in the acute care hospital setting. This course consists of Theory and supervised Clinical experience at a hospital.

#### **Nurse Assistant Certification:**

A federal law (OBRA enacted on April 1, 1987, requires all students completing an accredited nursing program to be tested in theory and clinical skills. As mentioned above, after taking Nurse Assistant 101 the student qualifies to take the Nurse Assistant Certification State Exam. The student has 3 opportunities to pass the exam, which consists of a multiple choice and a skills performance component. After successfully passing both parts, the student is certified as a Nurse Assistant for 2 years. To remain active, this certification must be renewed every 2 years. Successful completion of 48 units of continuing education and at least 8 hours of paid employment must be completed for certification renewal. If the certificate is not renewed, the student must take the class and State Exam again in order to be able to work as a Nurse Assistant. The student is responsible for following up with certificate renewal, and knowing

his/her renewal date. Renewal dates will be indicated on the NA certificate.

### **Dress Code:**

Students must wear medical scrubs and white shoes. Hair should be pulled back neatly, and acrylic nails are not allowed.

## Attendance:

Students are expected to attend daily, all day and on time. There is an opportunity to make-up missed classes, as deemed absolutely necessary.

## **Applicants:**

Must be in good health and required to have passed a health examination. If a student's health, either before or after acceptance, poses a risk to a patient's well-being, they won't be admitted to or will be removed from the program.

To be enrolled into the Nurse AssistantCertification PROGRAM students are required to submit the following:

- ·A MCC application in the admission office prior to beginning classes.
- ·Complete a Physical Exam with up-to-date immunizations.
- ·A CPR certification card for the health care provider or professional rescuer, if needed will be provided.
- ·A copy of your Social Security card and ID
- ·A complete Live Scan form.
- Option to purchase personal liability/health insurance (MCC does not provide insurance coverage).

## CERTIFICATION INFORMATION

Nurse Assistants and Home Health Aides will NOT be certified by the State of California if convicted of certain Penal Code Violations. Additional information will be given at the scheduled information meetings.

LIVE SCAN FINGERPRINTING & SUBMISSION REQUREMENTS All initial and renewing CNA/HHA certification applicants who have not been cleared through Aide and Technician Certification Section (ATCS) and employees of Intermediate Care Facilities (ICF) for Developmentally Disabled (DD), Developmentally Disabled-Habilitative (DDH), and Developmental Disabled-Nursing (DDN), must submit their fingerprints for clearance using the live scan method.
