# SOCIAL SECURITY MATTERS

Ask Rusty - Should my Spouse be getting half of my Social Security amount?

Dear Rusty: I was referred to you to ask a question about Social Security benefits. I receive about \$1,700 a month from Social Security while my husband receives only approximately \$750 monthly. Is he entitled to file for half of my Social Security as a monthly benefit without touching my amount? Signed: Curious Wife

Dear Curious Wife: For information, spousal benefits are one of the most misunderstood areas of Social Security. A spouse does not always get half of their partner's Social Security benefit – how much the spouse gets is determined by their age when the spouse benefit is claimed, and it is always based upon both partner's full retirement age (FRA) benefit, regardless of when they actually claimed Social Security. The partner with the lower SS benefit can only get half of the other spouse's FRA amount if that partner takes the spouse benefit at (or after) their personal SS full retirement age (FRA). And each spouse's FRA may be different depending on the year they were born (FRA today is somewhere between age 66 and 67, depending on the person's year of birth).

Here are two basic rules for a lower earning marital partner to get spouse benefits:

- The lower earning spouse's FRA entitlement must be less than 50% of the higher earning spouse's FRA entitlement. FRA amounts are used, even if SS benefits were claimed earlier than, or later than, full retirement age, and FRA amounts are frequently different than the monthly amounts actually being received.
- If one spouse's FRA amount is less than 50% of the other spouse's FRA amount, the difference between

those two amounts can be added to the lower earning spouse's SS retirement amount, to become their spousal benefit. That may, or may not, equal half of the higher earning spouse's FRA

So, if you claimed your Social Security exactly at your own full retirement age, and your husband also claimed his Social Security exactly at his own full retirement age, then - based on the numbers you provided - your husband is likely entitled to about \$850 per month, instead of his current \$750. And that would not affect your own SS benefit in any way.

Your FRA entitlement would need to be more than twice your husband's FRA entitlement for him to receive a spousal boost from you. But if either of you claimed Social Security before (or after) your respective full retirement ages, your husband would not get 50% of your benefit.

# Harvest Quality Bucks Before the General Season

White-tailed deer hunters heading to blinds for the archery-only season should experience another great opener this year. Bucks during this time of year gather in bachelor groups and provide plenty of hunting opportunities before the rut kicks off.

Texas began the growing season under drought conditions in March, but much of the state received abundant rainfall later in the spring. The vegetation growth from these rains boosted antler development and allowed does to pack on reserves for fawning and lactation, and those regions should expect an excellent season.

"Historically good fawn recruitment over the last several years will provide archery hunters plenty of opportunities to bag a quality buck," said Blaise White-tailed Deer Archery Hunters Should Have Plenty of Opportunities to Korzekwa, White-tailed Deer Program Leader.

Forbs (weeds and flowering plants), which are a critical component of a deer's diet, became abundant during late spring and offered essential nutrients to boost antler development in much of the state. However, hunters in portions of the Edwards Plateau and South Texas ecoregions may see average to below-average antlers on bucks this season, as rainfall wasn't received in these regions until the summer months.

While the archery-only and Managed Lands Deer Program seasons

begin Sept. 27, the general season opens more than a month later, on Nov. 1. The general season runs through Jan. 4, 2026, in the North Zone and Jan. 18, 2026, in the South Zone. A youth-only deer season is set in both zones for Oct. 24-26 and Jan. 5-18. For additional late season deer hunting opportunities, county specific regulations and information on how to properly tag and report a harvest, consult the 2025-26 Outdoor Annual.

Texas Parks and Wildlife Department (TPWD) is asking hunters to continue surveillance for New World screwworm. If hunters or landowners observe a live animal infested with maggots, they should quickly report the observation to a local TPWD biologist. Through active surveillance hunters can help protect the state from a pest that could have devastating impacts. For more information, please visit TPWD's New World Screwworm webpage.

Landowners and hunters also play a critical role in managing Chronic Wasting Disease (CWD). The most effective way to help manage CWD is by reporting sick deer, properly disposing of unused carcass parts and voluntarily testing harvests. More information about carcass disposal requirements and voluntary CWD check station dates and hours of operations can be found on TPWD's CWD website.

Public land hunters should also consult the Public Hunting Lands Map Booklet to review regulations that may apply to specific areas. The Texas Hunt & Fish app can be used to complete on-site registration electronically at a public hunting area.


