Blow Your Own Ornament

Glassblowing Experiences at Fredericksburg Glassblowing Start Oct. 9

Fredericksburg, TX – Fredericksburg Glassblowing at Enchanted Fredericksburg Ranch (EFR) will begin “Blow Your Own Ornament” glassblowing experiences this fall and winter on Oct. 9 through Jan. 10, 2026.

Experiences are offered on Thursdays, Fridays, Saturdays and during holiday weeks through Jan. 10, 2026 at various times.

Reservations can be made now for “Blow Your Own Ornament” experiences at www.EnchantedFredericksburgRanch.com/book-online. Minimum age is 8 years old, and youth 17 and younger must be accompanied by a parent, grandparent or guardian.

All experiences are private to your group and reservations are recommended. Glass pieces must cool slowly overnight and are ready to pick up the next day or shipping can be arranged.

In addition to glassblowing experiences, Fredericksburg Glassblowing will offer free demonstrations on Satur-

days from 1 p.m. to 4 p.m. starting Oct. 11, and at other times during visiting glassblower artist residencies in Oct. and Nov.

“Our ‘Blow Your Own Ornament’ glassblowing experiences were extremely popular last year and sold out fast,” said Holly Simonette, co-owner of Fredericksburg Glassblowing at EFR. “This year, we’re expanding the ‘Blow Your Own Ornament’ experiences to after-school hours on Thursdays and Fridays, and every day during Thanksgiving, Christmas and New Year’s school holiday weeks. Blowing glass ornaments is a wonderful way to make lasting memories with kids and grandkids and take home a tangible reminder that will last forever.”

During the “Blow Your Own Ornament” glassblowing experiences, participants pick colors and (with the help of resident glassblower, Paul Simonette) dip the molten glass into colored frit, re-heat the glass in the “glory hole,” blow air

into the pipe to shape the ornament, and knock the ornament off the pipe.

Fredericksburg Glassblowing and the Purple Shack Makers Gallery at EFR are conveniently located about 10 minutes north of Main Street at 7991 Ranch Road 965 (the road to Enchanted Rock State Natural Area or N. Miliam at Main St.).

Parking is limited. EFR is a family- and leashed dog-friendly venue. There is also a small picnic area in the recognized pollinator garden open to the public during glassblowing studio hours.
