But I don't feel that way.

I love the look, the night before Christmas, when everything is sparkly and stuffed full of surprises—even if those surprises are nothing more than new hot pads and cat toys.

I've been fortunate that Christmas has never felt overwrought with expectations. (Unless you count getting my grandmother's recipe for rice pudding correct on Christmas Eve. That recipe is not easy and has caused more than its share of stress.)

But when I think of presents, I don't think of stress. I have given my young nephew inappropriately dangerous gifts (what young man does not need a pickax?) And I've given joke presents (my friend, Andrew, at one time had an impressive collection of shower caps). I remember the fun I've had giving them over the years, and the giant mess of

paper and ribbons that is left after the present opening is over. I love giving presents to pets. I love hearing my mother exclaim, "What on earth...?" as she opens a box.

And many decades later, I still remember one of the few years I spent Christmas away from my family. I was performing in a show that ran over the holidays, and coming back home wasn't feasible. Working as an actor, I didn't have a lot of money. But I remem-

HOLIDAY RECIPES

SANTA COOKIES

Yield: 14 cookies

1 cup (2 sticks) Maple Hill Salted Butter, at room temperature

1/2 cup brown sugar

1 tablespoon vanilla extract

1 large egg, at room temperature

2 1/4 cups all-purpose flour

1/4 teaspoon salt

1 teaspoon red food coloring

mini chocolate chips

mini red chocolate-coated candies

Frosting:

1/2 cup (1 stick) Maple Hill Salted Butter, at room temperature

4 ounces cream cheese, at room temperature

1 teaspoon vanilla extract

2 1/2 cups powdered sugar

Preheat oven to 350 F and line two baking sheets with parchment paper.

In large mixing bowl, beat butter, sugar and vanilla until light and fluffy. Add egg and beat until combined. Add flour and salt; mix until dough begins to form ball.

Remove 1 cup dough and set aside. Add red food coloring to remaining dough.

From red cookie dough, make one 1-inch ball and five 1/2-inch balls. From plain cookie dough, make one 3/4-inch ball and five 1/4-inch balls.

On prepared baking sheet, place red 1-inch ball and gently flatten until 1/2-inch thick. Attach four red 1/2-inch balls for arms and legs. Attach plain 3/4-inch ball for head and gently flatten until 1/2-inch thick. Attach plain 1/4-inch balls for hands and feet. Shape remaining red 1/2-inch ball into triangle for hat and attach. Repeat with remaining dough, arranging cookies 2 inches apart on baking sheet. Add chocolate candies for eyes and buttons.

Bake 12-15 minutes, or until lightly golden.

To make frosting: In medium bowl, beat butter and cream cheese until light and fluffy, about 3 minutes. Add vanilla and powdered sugar; mix until combined.

To decorate: Place half of frosting in piping bag with small tip to line Santa's arms and legs. Place other half in second piping bag with small star tip to add Santa's beard, hat and hands. Put small dot of icing between eyes and beard and place red mini chocolate-coated candy on face for nose.

4 ounces cream cheese, at room temperature
1/4 cup brown sugar

1/4 cup powdered sugar

3 tablespoons molasses

1 container (16 ounces) Maple Hill Vanilla Greek Yogurt

1 teaspoon ground ginger

1 teaspoon ground cinnamon

1 teaspoon ground nutmeg

2 cups whipped cream
graham crackers
fruit

In medium bowl using electric mixer on medium speed, beat cream cheese and sugars about 1 minute. Add molasses and mix until combined.

Add Greek yogurt, ginger, cinnamon and nutmeg; beat until combined. Fold in whipped cream and mix until fully incorporated. Refrigerate 1 hour before serving or overnight.

Serve with graham crackers and fruit.

Oil or butter, for sauteeing
1/4 cup onions, small diced
3 garlic cloves, minced
1/2 cup mushrooms (such as baby portobello, button or shiitake), minced
1 tablespoon picked thyme
2 cups heavy cream
2 tablespoons cornstarch
4 tablespoons water
2 tablespoons truffle oil
salt, to taste
pepper, to taste

Pizza:

1 pizza dough
grated or fresh mozzarella cheese
mushrooms
spinach (optional)
cooked sausage (optional)

To make cream sauce: In saucepan over medium heat, add oil or butter. Sauté onions until translucent then add garlic and mushrooms. Cook until mushrooms release moisture and begin to caramelize.

Stir in picked thyme and cook 1 minute to release oils.

Add heavy cream and bring to gentle simmer. Let it reduce slightly, 5-7 minutes.

In small bowl, mix cornstarch and water to make slurry. Slowly whisk into simmering cream sauce until it reaches desired consistency.

Remove from heat and stir in truffle oil. Taste and adjust seasoning with salt and pepper.

Scallops with Florida Grapefruit Butter

Prep time: 30 minutes
Cook time: 3 minutes
Servings: 4

2 Florida Grapefruit
1 fennel bulb
3 tablespoons olive oil, plus additional for searing, divided
1 tablespoon sherry vinegar
1/8 teaspoon, plus 1 pinch, salt, divided, to taste
1/8 teaspoon, plus 1 pinch, pepper, divided, to taste
1 small bunch fresh cilantro
12 scallops with empty shells
1 tablespoon butter

Peel and cut one Florida Grapefruit into segments. Squeeze remaining grapefruit and reserve juice.

Wash and finely chop fennel. In bowl, mix fennel with olive oil, sherry vinegar and 1 pinch salt and pepper.

Mix and add fresh cilantro. Keep a few leaves for garnish.

In hot frying pan, drizzle with olive oil then sear scallops 1 minute on each side.

Remove scallops from pan then deglaze with reserved Florida Grapefruit juice. Let it simmer slightly and add butter to make sauce. Add 1/8 teaspoon salt and pepper.

Place 1 tablespoon fennel salad in washed shell, top with three scallops and coat with grapefruit butter.

Finish with reserved cilantro leaves and fresh grapefruit segments.

Florida Grapefruit Brandy Sour

Prep time: 5 minutes
Servings: 1

1 3/4 ounces brandy
2 1/2 ounces freshly squeezed Florida Grapefruit Juice
1/3 ounce simple syrup, or to taste
2 dashes bitters
1 egg white
ice cubes
1 ounce sparkling water
Florida Grapefruit twist, for garnish

In cocktail shaker, add brandy, Florida Grapefruit juice, simple syrup, bitters and egg white. Shake vigorously 15-20 seconds to create frothy texture.

Add ice cubes to shaker and shake 15 seconds to chill drink. Strain into chilled coupe or rocks glass filled with fresh ice. Pour light splash of sparkling water over top to enhance effervescence.

Garnish with grapefruit twist.

Florida Citrus Vinaigrette:
1/3 cup Florida Grapefruit Juice
1/3 cup Florida Orange Juice
2 teaspoons orange zest
2 tablespoons cider vinegar
2 teaspoons honey
1 tablespoon Dijon mustard
1/3 cup olive oil
2 tablespoons shallots
sea salt, to taste
fresh pepper, to taste

Pickled Onion:

1 red onion, thinly sliced
1/2 cup white vinegar or cider vinegar
1/2 cup water
1 tablespoon sugar
1 teaspoon salt

Burrata Salad:

4 Florida Grapefruit, peeled and cut into segments
3 oranges, peeled and cut into segments
1 bunch radishes, sliced thin and cut into sticks
1/3 cup pistachios, grilled and coarsely chopped
1 cup arugula
2 tablespoons dill, chopped
sea salt, to taste
pepper, to taste
8 ounces burrata

To make vinaigrette: In small bowl, mix Florida Grapefruit Juice, Florida Orange Juice, orange zest, cider vinegar, honey, Dijon, olive oil and shallots until dressing is emulsified. Season with salt and pepper, to taste. Set aside. Vinaigrette will keep 7 days in refrigerator.


To make pickled onion: Place sliced onion in airtight canning jar.

In small saucepan, combine vinegar, water, sugar and salt. Bring to boil and pour over sliced onion in jar. Add small amount of water to completely cover onion.

Refrigerate at least 2 hours before serving. Pickled onions will keep 15 days in refrigerator.

To make burrata salad: In bowl, combine Florida Grapefruit and Orange segments; add radish sticks, toasted pistachios, arugula and dill. Season with salt and pepper, to taste.

Place salad on large plate, top with coarsely chopped burrata and drizzle generously with citrus vinaigrette and pickled onion.
