

## Overview of TISFD Regional Councils

### Introduction

TISFD's Regional Councils are critical to ensuring that TISFD's recommendations are globally relevant and tailored to different regions' unique social, economic, and cultural contexts. The purpose of the Regional Councils is two-fold:

- To ensure regional stakeholders, including businesses, financial institutions, and civil society and labour organisations, are meaningfully engaged in TISFD and contributing to the development of TISFD's recommendations and guidance.
- To enhance the impact and acceptance of TISFD's framework by ensuring it addresses local challenges and opportunities.

### Composition

The Taskforce launched four Councils in early 2025 in the Americas, Asia-Pacific, Europe & UK, and Middle East & Africa. The Councils are managed by TISFD's Secretariat and consist of 20-25 members each, with the potential to expand as the initiative progresses. Membership includes representatives from:

- *Financial Institutions*: Participants from financial institutions, including asset owners and asset managers across the region.
- *Companies*: Participants from leading corporations, bringing perspectives on corporate reporting and sustainable business practices.
- *Civil Society Groups and Labour Organisations*: Members from NGOs, community organisations, and labour unions representing grassroots concerns, ensuring diverse voices and perspectives are included and amplified.

### Roles and Responsibilities

Regional Council members will actively advance TISFD's mission, providing essential regional insights to address inequality through financial and social disclosures. The primary roles include:

- *Co-creation of Deliverables*: Collaborate in developing TISFD's recommendations, contributing regional insights and strategic feedback to ensure relevant and actionable deliverables.
- *Thought Leadership*: Share lessons learned and insights on region-specific issues relevant to TISFD's work within and across Regional Councils, and across the broader TISFD Alliance, to inform global discussions on inequality and social-related financial disclosures and to contribute to building a global community of practice.
- *Capacity Building*: Participate in capacity-building activities, such as learning modules and workshops, to strengthen knowledge of the relationship between financial markets and social and inequality-related issues.
