## Challenges You Faced With PCI Compliance

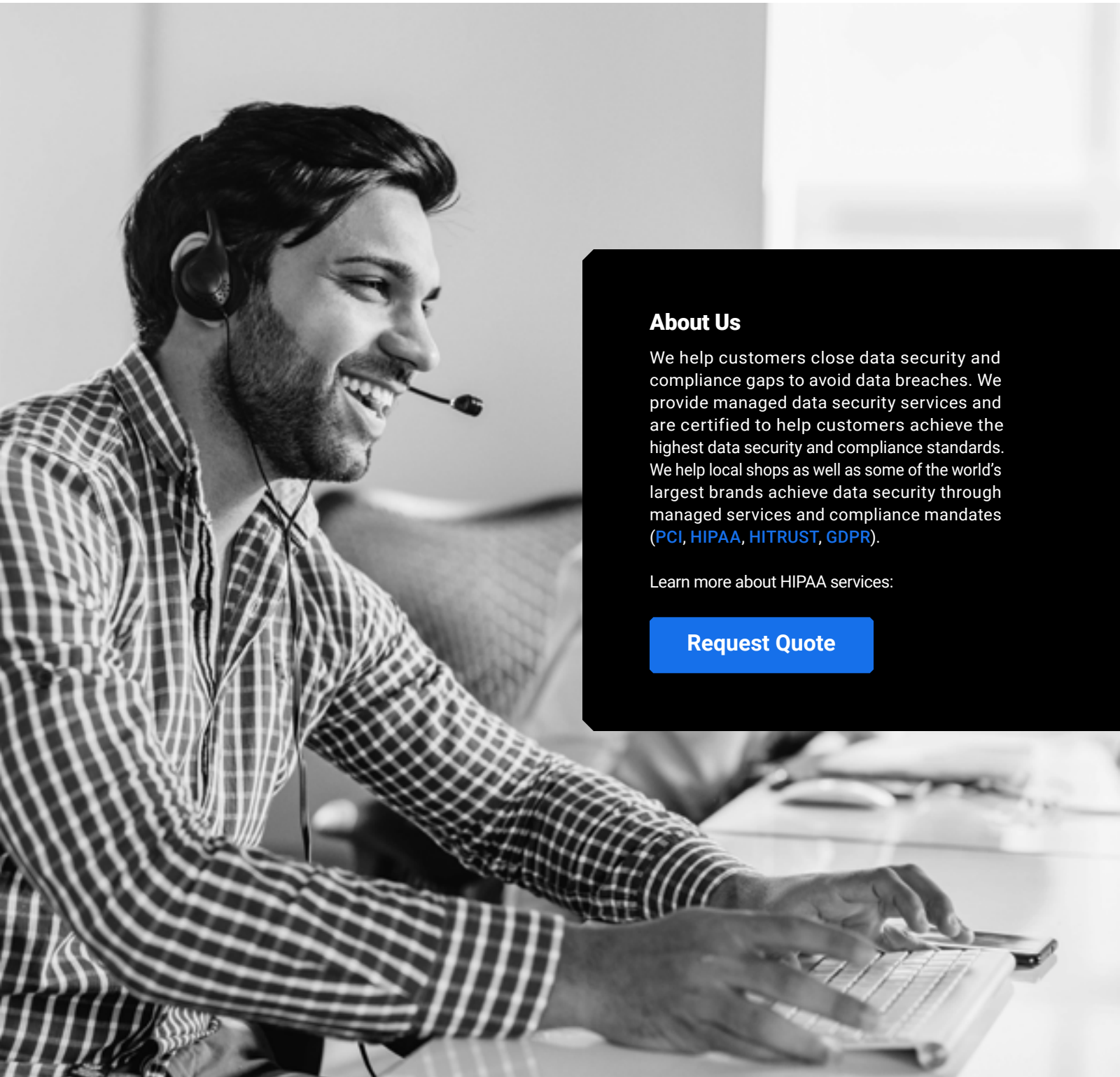
- I purchased my practice with current computer system and continued utilizing the managed service that was already in place.
