1 Pre-Onsite Gap Analysis

During this phase, knowledgeable SecurityMetrics QSAs complete an initial gap analysis of your organization's compliance status. After the gap analysis is completed, feedback and remediation checklist items will be shared with you in our online project management tool.

2 Onsite Assessment

PCI DSS onsite assessments determine the data security posture of your organization. Your QSA will make an in-person visit to your location to assess and collect evidence of compliance to the PCI DSS.

3 Remediation and Retesting

SecurityMetrics QSAs work with you to fix areas of non-compliance, expediting the retesting process to ensure a timely assessment. If you use SecurityMetrics to run your [ASV scan](#), you will also benefit from unlimited rescans during the assessment and remediation phase until you can pass.

4 ROC Submission and Certification

Once your PCI audit is complete and compliance requirements have been met, SecurityMetrics QSAs act as your advocate by writing and submitting your ROC directly to the PCI Council.

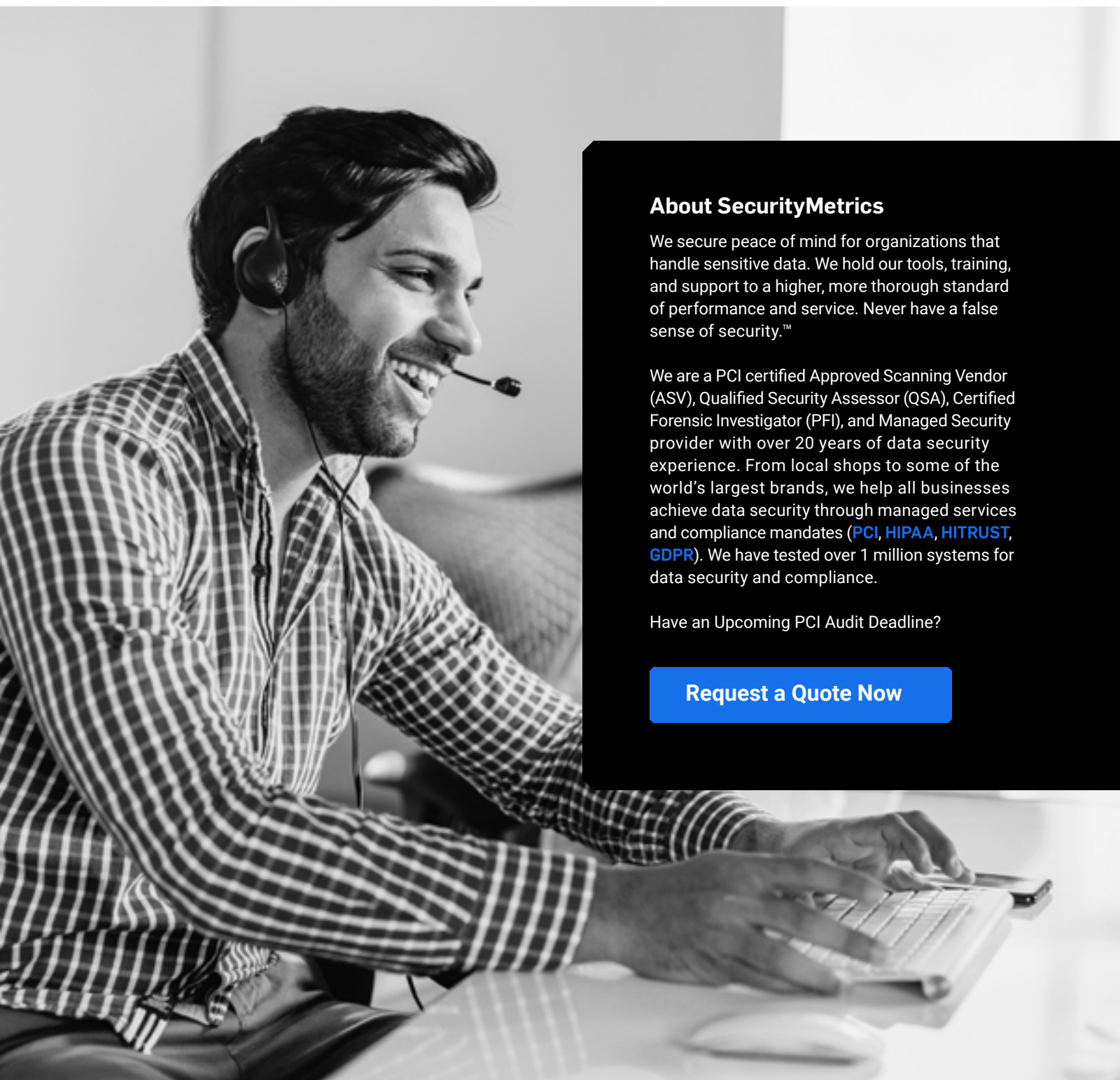
