Our water therapy program, "SPLASH" (Supporting Posture, Longevity, Agility, Strength & Health), is so popular that we are working

Recent work includes improvements to our siding, parking lots, hallways and several apartments. The team has had training on a variety of emergency responses and is ready for whatever the future brings.

On other key developments, I'm proud to say that we are making excellent progress on our inpatient Hospice Center (see article on page 3). It is also a pleasure to report that we are operating within our financial targets and have adopted a good and realistic budget for the coming year.

#### **Inpatient Hospice Center Update**

OUR GOAL is to hold an official opening in Spring 2020 and we are making great progress! Renovations on six of the twelve suites have been completed; three have been fully outfitted and are spacious, warm, and comfortable; furniture, fixtures, and amenities have been ordered for the remainder. The common and support areas that will truly make this a "center" will not be done until sometime early next year; however, demand is so high that we have already served eight residents with a hospice diagnosis.



Responses to the Center's newlycompleted serenity garden have been so positive that we are entertaining proposals to do something similar on the Health Care Center's other side. An architect has provided preliminary drawings for the revitalization of the Hospice Center common areas and thoughts are coming together for the adjacent bistro and porches. We are now fully into fundraising mode for the remainder of the support needed to complete the Hospice Center. Persons interested in donating to the area's first
