# GROWTH & INCOME ETF

As of March 31, 2026

The SWP Growth & Income ETF seeks to provide long-term capital appreciation with a secondary emphasis on generating current income. The Fund will invest at least 80% of its net assets in income-producing equity securities that are judged to have strong growth characteristics.

Our Portfolio Managers characterize “growth” companies as those that are expected to achieve higher than average profitability ratios such as operating profit margin or return on equity, and have characteristics to generate above-average sustainable earnings and free cash-flow growth, while showing a history of paying a stable dividend.

- **Hybrid Investment Approach:** Our Portfolio Managers utilize Macroeconomic, Fundamental, and Technical Analysis to arrive at the underlying holdings within the Fund.
- **Managed Risk:** Designed for investors seeking lower volatility with higher income than the broad U.S. stock market.
- **Dividend Focus:** Driven by our belief that dividend-paying companies tend to be more established higher-quality businesses with high cash flow, stable revenue streams, self-funded growth and disciplined capital reinvestment.
- **Investor Friendly Vehicle:** Active stock-picking within a transparent and tax efficient ETF structure that distributes income quarterly.

Dividends have contributed a significant portion of historical U.S. equity Total Returns. Dividend payouts could be viewed by investors as a sign of corporate health and may provide a natural hedge against equity drawdowns. The fund may use covered calls to generate additional income on top of dividends and help manage downside risk (covered calls are considered a lower-risk option strategy that involves selling call options on a stock that an investor already owns. If the market price of the stock increases, then the investor may have to buy back the call option at a loss or have the underlying stock called away, thus depriving the investor of any further upside potential).

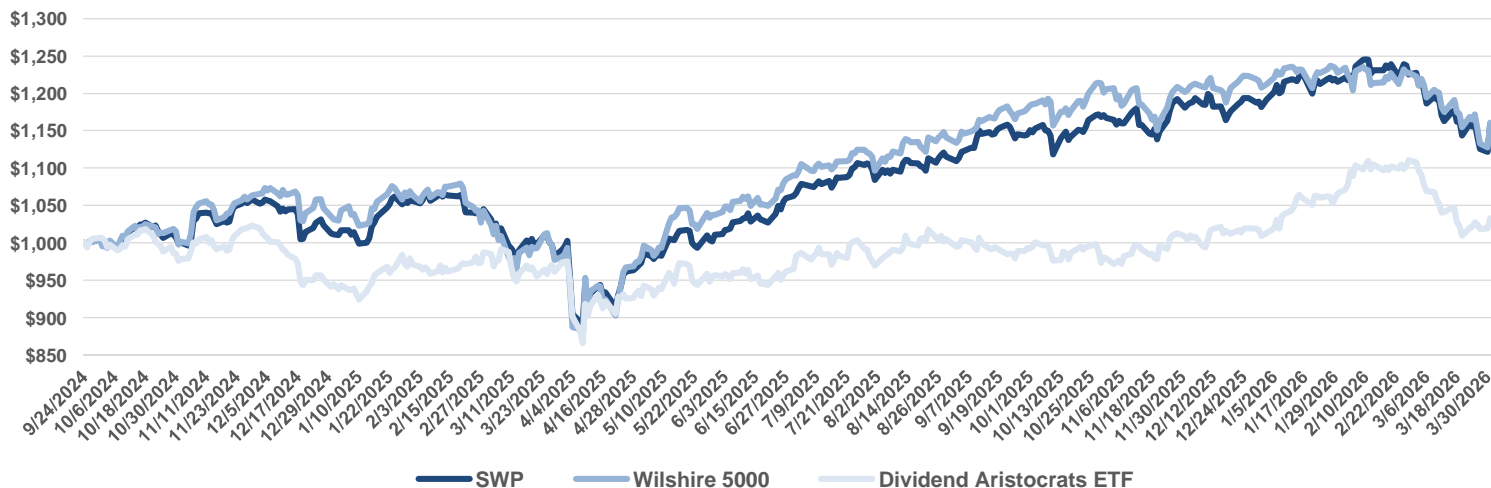
