NEW BUSINESS

AFG Grant – Kieler and Eastman submitted an application for diesel mitigation and extractors for all stations. They are optimistic about our chances. We would hear if we are awarded the grant anywhere between May 1st and September. Station Paging is a go and will go live May 1st. As with anything new, there are bound to be some kinks, but we just need to be patient and work through them as they arise. Station paging will occur from 2100 hrs to 0700 hrs. It is either 1 station, 2 stations, or all. Things like fires, 10-50s involving 3 stations (306, 301, 300, 334) or any other call type using more than 2 stations will be paged at all stations regardless of time. BCs will carry a pager to help reduce "missed" pages and hiccups.

Saunas – Kieler also stumbled into a conversation with the company that provided the sauna to the SportsPlex. In that conversation, this rep mentioned giving us/the City a deal on 2 saunas. The saunas would cost about \$5,000 shipped. Chief Beck is meeting with finance to hopefully get approval for \$5,000 to pay for one. The Union would pay for the other. There was some discussion about whether or not the City should buy both for warranty issues or invoicing simplicity. If that were the case, the Union would then pay our "half" in the form of updating equipment for the Tech Rescue team or other department need. Chief would like one on each side of the river and placement has yet to be finalized. Motion from B. Weber, 2nd by Demry for NTE \$5000 to match money from the City for the purchase of equipment to be determined later. Motion passes, all ayes.

501c3 – We are moving forward with the formation of our 501c3 that has been discussed at previous meetings. Donohue will be the president and McNally the treasurer. They are looking for other volunteers to be board members. They would like a mix of active members and non-union members. If anyone's significant other, parent, etc would like to be involved, please reach out.
