COMMITTEES & BILLS

Golf – August 23rd at Gates. 12 teams signed up so far. Sign up before August 1st to guarantee a shirt.

IPFF Convention – Lobbyist contract for the IPFF was renewed. They do a great job of getting our issues out there and seen by the legislature and were instrumental in getting the 411 bill passed this session. The bill includes a 3-year lookback on presumptives including cancer, heart and lung, and other cumulative injuries. PTSD disability needs to be tied to a readily identifiable work event and unexpected or unusual compared to other police and fire across the state. May also be cumulative. It is important that we are checking the "traumatic event" box in ESO and also reporting injuries that may be cumulative over time (tweaked your knee at a fire, but didn't require immediate care). Employee pension contribution will go from 9.4% to 9.55%. IPFF to endorse Ed Kelly, Frank Lima and Mark Woolbright at IAFF Convention. IPFF is looking into obtaining state funding for routine cardiac and cancer screenings for members. Our light duty grievance has been filed in district court at the State level. Could be awhile before a court date/hearing/resolution.

Waterloo was selected to host the IPFF Convention in 2026. We will be putting together a planning committee in the near future to start working on this. If you are interested, let Hubka know. If you were part of the process in 2014 when we last hosted, reach out with any suggestions, ideas, etc.

DEPARTMENTAL MATTERS

Staff Meeting – ISO is coming in August for evaluation. Working on an officer development manual. FTO program is ready to go and should be launched soon. \$4.73 mil in EMS revenue. Stewart started his new position 7/1 and will be working on supply management initially. Working on how the bariatric rig deployment will work now that it is at HQ. OT budget for this fiscal year is \$275k and will be hiring 3 to keep 333 in service. Chief Beck is requesting money from the City for the G2 paging system. Unsure when that meeting will take place.

Labor Management - Lots of discussion on the mandatory overtime policy. It will be the low person on the off-going shift. People on vacation are not considered "on-shift" for mandatory call back. You get 2 "no questions asked" passes on MOT, if you don't work the 3rd day, progressive discipline will kick in. Some discussion on eliminating the 72 hour cap on consecutive shifts worked. Discussion also included ways to prevent medics from getting forced and stuck on an ambulance for 48 (try and put them on 6s?). Looking at a soft rollout of the new CAD software, Central Square, in August. Hernandez is working on updated maps.
