Floatpays (Pty) Ltd will strive to comply with and contribute to the TCF fairness outcomes, viewed from the perspective of the customer:

The six fairness outcomes:

- Outcome 1: Customers are confident that they are dealing with providers where the fair treatment of customers is central to the provider's culture.

- We will pay attention to the outcomes of complaints which can serve as an important source of intelligence about the health of our business and systems. - We will measure the length of time taken to deal with a compliant, the
