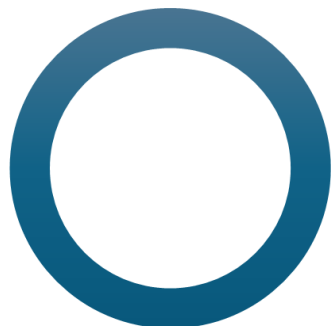
Index Information
