

TERMS OF USE OF THE WEBSITE

1. General Provisions

- 1.1. These Terms of Use set out the rules for using the website www.drszczyt.pl (hereinafter: the "Website").
- 1.2. The owner and administrator of the Website is Dr Szczyt Chirurgia Plastyczna sp. z o.o. sp.k. (a limited liability company limited partnership) with its registered office at ul. Królewicza Jakuba 37, 02-956 Warsaw, NIP: 951 247 42 72 (hereinafter: the "Administrator").
- 1.3. Using the Website constitutes acceptance of these Terms of Use.
- 1.4. The content available on the Website is for information purposes only and does not constitute medical advice, diagnosis, or therapeutic recommendations. All health-related decisions should be made only after consultation with a medical specialist.

2. Scope of Services

- 2.1. The Website is of an informational nature and allows Users to learn about the services and activities of the medical facilities operated by the Administrator.
- 2.2. The Website may enable appointment booking, contacting the facility, and obtaining general medical information.
- 2.3. The information provided on the Website does not constitute medical advice and does not replace a medical consultation.
- 2.4. The User may, through the "book an appointment/consultation" functionality, provide their contact details to request to be contacted. By accepting these Terms of Use, the User consents to being contacted by the Website.

3. Use of the Website

- 3.1. A User of the Website (hereinafter: the "User") is any person using the Website.
- 3.2. The User undertakes to use the Website in accordance with applicable law, these Terms of Use, and generally accepted principles of social conduct.
- 3.3. It is prohibited for the User to provide unlawful content, including content that infringes the rights of others.

4. Liability of the Administrator

4.1. The Administrator makes every effort to ensure that the information published on the Website is up-to-date and reliable; however, the Administrator shall not be liable for any decisions made by the User based solely on the information contained on the Website.



4.2. The Administrator shall not be liable for any temporary unavailability of the Website due to technical reasons or reasons beyond its control.

5. Personal Data Protection and Security

- 5.1. The Administrator processes Users' personal data in accordance with applicable law, including the GDPR.
- 5.2. Detailed information on the processing of personal data is provided in the Privacy Policy available on the Website.
- 5.3. The Administrator applies appropriate technical and organisational measures to protect Users' personal data against unauthorised access, loss, destruction, or unlawful processing.

6. Rules of Electronic Communication

- 6.1. The Administrator may contact Users by email, SMS, or telephone, provided that the User has given consent while using the Website.
- 6.2. The User may withdraw their consent to electronic communication at any time by contacting the Administrator.

7. Copyright

- 7.1. The content published on the Website, including graphic materials, texts, and logos, is protected by copyright and belongs to the Administrator or its partners.
- 7.2. Copying, distributing, or using the Website's content without the Administrator's consent is prohibited.

8. Final Provisions

- 8.1. The Administrator reserves the right to amend these Terms of Use.
- 8.2. Any amendments shall take effect upon their publication on the Website.
- 8.3. In matters not regulated by these Terms of Use, the provisions of Polish law shall apply, in particular the provisions of the Polish Civil Code.

These Terms of Use shall enter into force on the date of their publication on the Website.
