15-YEAR COMMERCIAL LIMITED WARRANTY (RESILIENT)

The following is the 15 Year Commercial Limited Warranty issued by Advanced Flooring Concepts for our resilient when used in commercial applications.

This 15 Year Commercial Limited Warranty begins on the original date of purchase. The product must be installed in accordance with the installation guidelines. The product must be maintained in accordance with the resilient maintenance recommendations and such maintenance continues throughout the duration of the original installation.

The 15 Year Commercial Limited Warranty is further limited to the period of time the resilient is owned and maintained only by the original end-user purchaser. The basis of a warranty related claim is the original Advanced Flooring Concepts invoice or authorized Advanced Flooring Concepts dealer invoice.

Specifications and installation guidelines along with resilient care recommendations can be obtained from your dealer.

WHAT THE WARRANTY COVERS

Manufacturing Defects – Advanced Flooring Concepts ensures that the resilient product will be free from any manufacturing defects during the period of this warranty.

Wear – Advanced Flooring Concepts ensure that during the period of the warranty, wear due to normal foot traffic will not change the visual aspects of the product.

WHAT IF YOU NEED WARRANTY SERVICE

You (the original purchaser) should notify the authorized Advanced Flooring Concepts Dealer or your sales representative and submit in writing, the following:

1. Valid proof of purchase in the form of a sales receipt or invoice.
2. Detailed description of the problem along with a photograph and physical sample clearly showing the warranty problem.
3. Contact information for you (the original purchaser) including name, phone number, email address, mailing address and address of the project location.

WHAT WILL WE DO

Should a defect covered under this warranty be found, the affected area will be repaired to meet the warranty standards. If repair is not able to be made, Advanced Flooring Concepts may, at its sole option, replace the affected product or refund the purchase price for the affected area. SAR Floors will pay the standard costs for labor and freight. Any costs incurred for the moving of equipment including partitions, furnishings, or similar objects, that were installed over the SAR Floors product, will be at the purchaser's expense.

WHAT CONDITIONS APPLY

For jobsite and floor preparation conditions, see product specific installation guidelines.

This warranty does not extend to or cover failure or damage resulting from the following:

Damage caused by improper installation or maintenance; differences in color between products and samples or photographs; problems arising from excessive moisture, alkali or water pressure from the sub floor; indentation from improper loading including heavy static loads, high heels, spiked shoes, rolling loads, chairs or other furniture not using floor protectors; discoloration, including but not limited to U.V. light and heat sources; surface scratches, changes in shading, texture and/or gloss during use; damage caused by chemically reactive material, dye, mold, stains, spillage; burns, gouges, scratches, indentations, floods, accidents, abuse or any harsh scouring pads while buffing.

Any moisture related testing (i.e. calcium chloride, relative humidity and pH) is not the responsibility of SAR Floors and all issues related to moisture, including any resilient related issues, are excluded from this warranty.

NOTE: Chair floor protectors are recommended to inhibit premature wear of the surface of the resilient. Replacement resilient will come only from current running-line products comparable to the warranted product.

NOTE: The warranty is not transferable. It extends only to the original end use purchaser. SAR Floors does not grant to any person or entity the authority to create for it any obligation or liability in connection with this product. SAR Floors shall not be liable to the consumer or any other person or entity for any incidental, special or consequential damages, arising out of breach of this limited warranty or any implied limited warranty (excluding merchantability).

All implied warranties, including an implied warranty of merchantability or fitness for a particular purpose, are hereby limited to the duration of this limited warranty. Some states do not allow the exclusion or limitation of implied warranties or the limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to the purchaser. This warranty gives the purchaser specific legal rights, such rights may vary from State to State.
